



HB3669: FACT SHEET

A Proven Program for Training Oregon's Workforce

Prosperity 10,000 (P10K), part of Senate Bill 1545 / Future Ready Oregon, is a \$35 million investment empowering Local Workforce Development Boards (LWBs) to expand critical workforce services to Oregonians facing unique challenges. This funding maximizes existing local programs and partners by supporting proven strategies to connect people to training and career-track employment, including career coaching, scholarships, work-based learning, stipends, and essential support services. In addition, unprecedented federal infrastructure, climate change, and caregiver investments create huge opportunities to boost our economy and enhance the prosperity and well-being of all Oregonians. We must prepare Oregonians for the high-quality jobs in construction, semi-conductors, clean energy and behavioral health these investments promise to produce.

A unique “fast-tracked” workforce fund

Fast track funding required in 2023 by the Legislature was directly distributed within 60 days to LWBs. By leveraging established regional networks, LWBs quickly distributed these funds across the State to a range of proven workforce development organizations, including nonprofits, educational institutions, labor organizations, and workforce service providers.

Often, the Legislature passes programs, but the results aren't clear, even years down the road. The opposite is true with P10K. **Data shows IT WORKS!**

The bottom line - P10K increased tax revenues and reduced social service costs.



By the end of this biennium, after a **\$35 million** investment Oregon will see:

\$23.1 Million in tax revenue from new earnings

\$195.4 Million in reduced social services costs*

= A Total Annual Financial Benefit to the State and Tax Payers of **\$219 million!!!!**

This empowers individuals, leads to stable families, long-term housing, and reduced health and human services spending in other areas of the state budget. It builds local talent and ensures businesses have the skilled workforce they need to grow and thrive.

HB 3669: PROSPERITY PROGRAMS

Investing in Oregonians, strengthening Oregon's future

A SMART INVESTMENT WITH PROVEN RETURNS

AN INVESTMENT IN OREGONIANS IS AN INVESTMENT IN OREGON'S FUTURE.

For every \$1 invested, Oregon gets \$2.98 back.

Funding request: \$50 million

- Oregonians in poverty: 533,358
- Individuals served over two years: 10,000
- Investment per person served: \$5,000

Projected return on investment (ROI) over two years

- Total investment: \$50 million
- Total return over two years: \$149.1 million
- Annual ROI: \$74.6 million per year

Breakdown per year:

- New Oregon tax revenue: \$10.1 million annually (\$20.2 million over two years)
- Reduced social service costs: \$64.5 million annually (\$128.9 million over two years)
- Total ROI: \$74.6 million annually (\$149.1 million over two years)

RETURN ON INVESTMENT

→ HOW DOES THIS WORK?

Generating new tax revenue

- 10,000 Oregonians served
- 7,500 gain employment (75 percent employment rate)
- Average wage: \$20.50 per hour
- Annual hours worked: 1,500
- Total new wages: \$231 million
- Oregon state income tax (8.75 percent): \$20.2 million in new tax revenue

Reducing social service costs

- Reduction in social service costs per employed person: \$17,195
- Total reduction in costs: \$128.9 million

→ WHY DOES THIS MATTER?

- **Reduces dependency:** Moves Oregonians from state assistance to self-sufficiency
- **Boosts workforce and economy:** Increases wages and tax revenue while lowering social service expenses
- **Maximizes impact:** Every \$1 invested returns \$2.98 to Oregon

WE URGE THE OREGON LEGISLATURE TO ALLOCATE **\$50 MILLION** TO EXPAND PROSPERITY PROGRAMS, EMPOWERING OREGONIANS, STRENGTHENING COMMUNITIES, AND CREATING LASTING ECONOMIC GROWTH.


