SUMMARY

Digest: The Act says a person might be allowed to do certain jobs with animals, like checking if cows are pregnant, even if they are not veterinarians. Allows the ODA to adopt rules to explain when this is okay. (Flesch Readability Score: 65.1).

Allows an individual to verify whether cattle are pregnant without holding a valid license issued by the Oregon State Veterinary Medical Examining Board under certain circumstances. Permits the State Department of Agriculture to adopt rules.

1 A BILL FOR AN ACT

2 Relating to providing animal health care; amending ORS 686.040.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 686.040 is amended to read:

5 686.040. (1) ORS 686.020 (1)(a) does not apply to **the following:**

6 (a) Commissioned veterinary officers of the United States Army, or those
7 in the employ of other United States Government agencies while engaged in
8 their official capacity, unless they enter into a private practice.

9 (b) **An individual who has received training to verify whether cattle**
10 **are pregnant and is performing pregnancy verification services on**
11 **cattle within the scope of the individual's training.**

12 (2) Nothing in ORS 167.322 or 686.020 (1)(a) shall be so construed as to
13 prevent any person or the agent or employee of the person from practicing
14 veterinary medicine and surgery or dentistry in a humane manner on any
15 animal belonging to the person, agent or employee or for gratuitous services
16 or from dehorning and vaccinating cattle for the person, agent or employee.

17 (3) Nothing in ORS 686.020 (1)(a) shall be so construed as to prevent the

1 selling of veterinary remedies and instruments by a licensed pharmacist at
2 the regular place of business of the licensed pharmacist.

3 (4) A practitioner of allied health methods may practice that method on
4 animals without violating ORS 686.020 (1)(a), as long as the practice is in
5 conformance with laws and rules governing the practitioner's practice and
6 the practice is upon referral from a licensed veterinarian for treatment or
7 therapy specified by the veterinarian.

8 (5) ORS 686.020 (1)(a) does not apply to the lay testing of poultry by the
9 whole blood agglutination test.

10 (6) A certified euthanasia technician holding an active, current certificate
11 may inject sodium pentobarbital, sedative and analgesic medications and any
12 other euthanasia substance approved by the Oregon State Veterinary Med-
13 ical Examining Board without violating ORS 686.020 (1)(a).

14 (7) The board by rule may specify circumstances under which unlicensed
15 persons may give vaccinations, administer an anesthetic or otherwise assist
16 in the practice of veterinary medicine.

17 (8) Any individual licensed as a veterinarian in another state may be used
18 in consultation in this state with a person licensed to practice veterinary
19 medicine in this state provided the consultation does not exceed 30 days in
20 any 365 consecutive days.

21 (9) ORS 686.020 (1)(a) does not apply to authorized representatives of the
22 State Department of Agriculture in the discharge of any duty authorized by
23 the department.

24 (10) ORS 686.020 (1)(a) does not apply to an unlicensed representative of
25 a livestock association, cow-testing association, or poultry association who,
26 for the benefit of the association, takes blood samples for laboratory tests
27 for the diagnosis of livestock or poultry diseases, but only if this person has
28 received authorization from the State Department of Agriculture following
29 a written request to the department.

30 (11) ORS 686.020 (1)(a) does not apply to persons permitted by the State
31 Department of Fish and Wildlife to rehabilitate orphaned, sick or injured

1 wildlife, as defined in ORS 496.004, for the purpose of restoring the animals
2 to the wild.

3 (12) ORS 686.020 (1)(a) does not apply to students, agents or employees
4 of public or private educational or medical research institutions involved in
5 educational or research activities under the auspices of those institutions.

6 (13) ORS 686.020 (1)(a) does not apply to:

7 (a) Veterinarians employed by Oregon State University;

8 (b) Instructors of veterinary courses; or

9 (c) Students of veterinary science who participate in the diagnosis and
10 treatment of animals if the students:

11 (A) Are participating in the diagnosis and treatment of animals while
12 engaged in an educational program approved by the board or a college of
13 veterinary medicine accredited by the American Veterinary Medical Associ-
14 ation; and

15 (B) Are under the direct supervision of an Oregon licensed veterinarian
16 or a veterinarian approved by the board or Oregon State University to su-
17 pervise students in the educational program.

18 **(14) The State Department of Agriculture may by rule specify cir-**
19 **cumstances under which unlicensed persons may engage in activities**
20 **described in subsection (1)(b) of this section.**
