And income tax going up?!?! How?!?!? We can barely afford it NOW! We have to pay bills and eat! And drive to work to pay said bills!!! Do you realize how much my power bill is?! On equal pay my bill is \$542.02. On EQUAL pay!!! It is so high I have to call Pacific Power and pay TWO SEPARATE PAYMENTS ON THEIR PHONE TREE, because their system cannot accept that high of a payment, and cuts off payment amounts at \$500. Call it and try. I am not making this up. We cannot afford another tax hike, let alone 4 or 5. You guys are living in some fantasy land where you think if you need money for this green project or that, you can just arbitrarily hike taxes sky high and move on with your day. My family lives in an older home. We aren't millionaires. After we pay bills, buy gas, and put food on the table, there isn't much left, and what IS left, goes to the things that

My husband has worked himself nearly to death to get where he is and make decent money, and we are barely scraping by. Most people I know are in much more precarious financial positions. Many, maybe even most I know, are a mere paycheck away from being homeless. HOMELESS!!! This is shameful...Unacceptable. We at MINIMUM deserve a vote on all this!!! For ONCE in your LIFE, LISTEN TO YOUR VOTERS!!! And STOP THE SPENDING!!! In my house, if we don't have the funds for the extra thing, WE DON'T GET IT!
