SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes a task force to stop gun violence and suicide. The Act provides money for research on gun violence and suicide. (Flesch Readability Score: 77.4).

Directs Oregon Government Standards and Practices Commission to charge public bodies [amount based on number of public officials serving public body], **special government bodies, local governments and local service districts specified amounts** for purposes of funding activities of commission.

[Requires] **Increases amount of reportable lobbying expenditures. Requires, on January 1, 2010**, quarterly online filing of expenditure statements by lobbyists and persons on whose behalf lobbyist was registered. Directs commission to allow public access to statements using Internet.

Increases amount of civil penalties that may be imposed for violation of lobbying or government ethics law from \$1,000 to \$5,000. Prohibits candidate from using political contributions to pay criminal or civil penalties. Exempts civil penalties [imposed under election laws] **related to or arising from course and scope of duties of public official.**

Prohibits former member of Legislative Assembly from being compensated lobbyist during period beginning on date person ceases being member and ending on date of adjournment sine die of next regular legislative session.

Prohibits public official from receiving in calendar year gifts with value exceeding \$50 from source with legislative or administrative interest.

Allows public official to receive items exempted from definition of gift from person with legislative or administrative interest. Allows public official to receive gift from source that does not have legislative or administrative interest in governmental agency in which official has official position.

Exempts judges or public officials serving judicial department from gift limits.

Modifies required contents of statement of economic interest.

Requires public officials and candidates to file quarterly statements with commission listing gifts with value exceeding \$15 received from person with legislative or administrative interest, expenses received when participating in an official meeting, honoraria exceeding \$15 and each source of income exceeding aggregate amount of \$1,000 from source that does business with or has legislative or administrative interest in governmental agency served by public official or candidate.

Requires person with legislative or administrative interest who gives gift with value exceeding \$15 to public official, pays expenses of official meeting or provides honoraria to report to commission and to notify recipient of value. Sets schedule for filing reports. Prescribes content of reports.

Prohibits public officials and candidates for public office from receiving honoraria in connection with official duties. Exempts honoraria or other items with value of \$50 or less.

Authorizes public official to establish legal expense trust fund to defray legal expenses incurred by public official in defending public official in legal proceeding relating to or arising from status of person as public official. Requires approval by Oregon Government Standards and Practices Commission.

Prohibits personal use of legal expense trust fund proceeds. Prohibits public official from soliciting contributions to trust fund. Directs trustee of trust fund to file with commission quarterly reports of contributions received and expenditures made.

Declares emergency, effective on passage.

5 **SECTION 1.** Section 2 of this 2007 Act is added to and made a part of ORS chapter 244.

6 **SECTION 2.** (1) The Oregon Government Standards and Practices Commission shall es-
7 timate in advance the expenses that it will incur during the biennium in carrying out the
8 provisions of ORS 171.725 to 171.785 and 171.992 and this chapter.

9 (2)(a) The commission shall charge each public body as defined in ORS 174.109 for the
10 public body's share of the expenses described in subsection (1) of this section for the
11 biennium.

12 (b) For public bodies in state government as defined in ORS 174.111, and special govern-
13 ment bodies as defined in ORS 174.117 that are not subject to the Municipal Audit Law, the
14 commission shall set the charges at a rate that is not less than \$_____ and not more than
15 \$_____ per public official serving the public body or special government body against which
16 the fee is charged. The commission shall charge each public body in state government and
17 special government body the same rate.

18 (c) For local governments and local service districts as defined in ORS 174.116, and spe-
19 cial government bodies as defined in ORS 174.117 that are subject to the Municipal Audit
20 Law, the commission shall set the charges at a rate equal to _____ percent of the annual
21 municipal audit filing fee paid by the local government, local service district or special gov-
22 ernment body under ORS 297.485. If a local government, local service district or special
23 government body is not required to file an audit report, the commission shall set the charge
24 for that local government, local service district or special government body at a rate equal
25 to _____ percent of the annual municipal audit filing fee that would apply under ORS
26 297.485 if the local government, local service district or special government body were re-
27 quired to file an audit report.

28 (3) Each public body shall pay to the credit of the commission the charge described in
29 this section as an administrative expense from funds or appropriations available to it in the
30 same manner as other claims against the public body are paid.

31 (4) All moneys received by the commission under this section shall be credited to the
32 Oregon Government Standards and Practices Commission Account established under ORS
33 244.345.

34 (5) The commission shall adopt rules specifying the methods for calculating and collecting
35 the charges described in this section.

36 (6) Beginning on July 1, 2011, the commission shall adjust the dollar range specified in
37 subsection (2) of this section annually based upon the change in the Portland-Salem, OR-WA,
38 Consumer Price Index for All Urban Consumers for All Items, as published by the Bureau
39 of Labor Statistics of the United States Department of Labor or its successor during the
40 preceding 12-month period. The commission shall round the amount determined under this
41 subsection to the nearest dollar.

1 an estimate of the expenditure shall be submitted in the statement and designated as an estimate.
2 The exact amount expended for which a previous estimate was made shall be submitted in a subse-
3 quent report when the information is available.

5 lobbyist, who engages in lobbying activities without compensation on behalf of an organization is
6 not required to register as a lobbyist for the organization as long as the lobbying activity does not

26 **date, name of payee, purpose and amount of that expenditure. This paragraph applies if the**
27 **total amount expended on the occasion by one or more persons exceeds \$50. This paragraph**
28 **does not apply to information reported in compliance with ORS 171.745.**

29 (2) Using July 1, [1979] **2009**, as the base, the dollar amount specified in subsection (1)(b) of this
30 section shall be adjusted annually by the commission based upon the change in the Portland Con-
31 sumer Price Index for All Urban Consumers for All Items as prepared by the Bureau of Labor Sta-
32 tistics of the United States Department of Labor, or its successor, during the preceding 12-month
33 period. The amount determined under this subsection shall be rounded to the nearest dollar.

34 (3) A statement required under subsection (1) of this section shall include a copy of any notice

9 **SECTION 10.** ORS 171.992 is amended to read:

10 171.992. (1) Any person who violates any provision of ORS 171.740 to 171.762, or any rule
11 adopted [*pursuant thereto*] **under ORS 171.725 to 171.785**, shall forfeit and pay to the General Fund
12 **for each violation** a civil penalty [*for each violation*] of not more than [*\$1,000*] **\$5,000**, to be deter-
13 mined by the Oregon Government Standards and Practices Commission.

14 **(2)(a) The commission may impose civil penalties upon a person who fails to file the**
15 **statement required under ORS 171.745 or 171.750. In enforcing this subsection, the commis-**
16 **sion is not required to follow the procedures in ORS 171.778 before finding that a violation**
17 **of ORS 171.745 or 171.750 has occurred.**

18 **(b) Failure to file the required statement in timely fashion is prima facie evidence of a**
19 **violation of ORS 171.745 or 171.750.**

1 son acting in a capacity as a public official, the effect of which would be to the private pecuniary
2 benefit or detriment of the person or the person's relative or any business with which the person
3 or a relative of the person is associated unless the pecuniary benefit or detriment arises out of cir-
4 cumstances described in subsection [(14)] (11) of this section.

5 (2) "Business" means any corporation, partnership, proprietorship, firm, enterprise, franchise,
6 association, organization, self-employed individual and any other legal entity operated for economic
7 gain but excluding any income-producing not-for-profit corporation that is tax exempt under section
8 501(c) of the Internal Revenue Code with which a public official or a relative of the public official
9 is associated only as a member or board director or in a nonremunerative capacity.

10 (3) "Business with which the person is associated" means:

11 (a) Any private business or closely held corporation of which the person or the person's relative
12 is a director, officer, owner or employee, or agent or any private business or closely held corpo-
13 ration in which the person or the person's relative owns or has owned stock, another form of equity
14 interest, stock options or debt instruments worth \$1,000 or more at any point in the preceding cal-

42 (C) **Gifts from personal friends of the public official on a special occasion.**

43 (D) **An unsolicited token or award of appreciation in the form of a plaque, trophy, desk**
44 **item, wall memento or similar item.**

45 (E) **Unsolicited informational material, publications or subscriptions related to the**

1 recipient's performance of official duties.

2 (F) Admission provided to or the cost of food or beverage consumed by a public official,
3 or a member of the household or staff of the public official when accompanying the public
4 official, at a reception, meal or meeting held by an organization before whom the public of-
5 ficial appears to speak or to answer questions as part of a scheduled program.

6 (G) Reasonable expenses paid by any unit of the federal government, a state or local
7 government, a Native American Tribe that is recognized by federal law or formally ac-
8 knowledged by a state, a membership organization to which a public body as defined in ORS
9 174.109 pays membership dues or a not-for-profit corporation that is tax exempt under sec-
10 tion 501(c)(3) of the Internal Revenue Code and that receives less than five percent of its
11 funding from for-profit organizations or entities, for attendance at a convention, fact-finding
12 mission or trip, or other meeting if the public official is scheduled to deliver a speech, make

37 of the entertainment does not exceed \$100 per person on a single occasion and is not greater than \$250

39 [(8)] (6) [*"Honoraria"*] "**Honorarium**" means a payment or something of economic value given
40 to a public official in exchange for services upon which custom or propriety prevents the setting of

9 **otherwise be available but for the public official's holding of the official position or office.**

13 **(b) The receipt by a public official or a relative of the public official of an honorarium**

16 **(d) An unsolicited award for professional achievement.**

17 **(e) Gifts that do not exceed the limits specified in section 18 of this 2007 Act received by**

20 **official holds any official position or over which the official exercises any authority.**

33
34 **SECTION 28.** Sections 29 to 37 of this 2007 Act are added to and made a part of ORS
35 chapter 244.

36 **SECTION 29.** (1) Subject to the authorization of the Oregon Government Standards and
37 Practices Commission as described in section 31 of this 2007 Act, a public official may es-
38 tablish a legal expense trust fund if the public official incurs or reasonably expects to incur
39 legal expenses described in subsection (2) of this section.

40 (2) Proceeds from the trust fund may be used by the public official to defray legal ex-
41 penses incurred by the public official in any civil, criminal or other legal proceeding or in-
42 vestigation that relates to or arises from the course and scope of duties of the person as a
43 public official.

44 (3) Except as provided in subsection (2) of this section, a public official may not use
45 proceeds from the trust fund for any personal use.

1 (4) A public official may not establish or maintain more than one legal expense trust fund
2 at any one time.

3 (5) A public official who establishes a legal expense trust fund may not solicit, receive
4 or handle any contributions to the fund.

5 (6) The provisions of ORS chapter 130 do not apply to a trust fund established under
6 sections 29 to 37 of this 2007 Act.

7 **SECTION 30.** (1) The proceeds of a legal expense trust fund may be used to:

8 (a) Defray legal expenses described in section 29 of this 2007 Act;

9 (b) Defray costs reasonably incurred in administering the trust fund, including but not
10 limited to costs incident to the solicitation of funds; and

11 (c) Discharge any tax liabilities incurred as a result of the creation, operation or admin-
12 istration of the trust fund.

13 (2) The proceeds of a trust fund may also be used to defray or discharge expenses, costs
14 or liabilities incurred before the fund was established if the expenses, costs or liabilities are
15 related to the legal proceeding for which the fund was established.

16 **SECTION 31.** (1) A public official may apply to establish a legal expense trust fund by
17 filing an application with the Oregon Government Standards and Practices Commission. The
18 application must contain:

19 (a) A copy of an executed trust agreement described in subsection (2) of this section;

20 (b) A sworn affidavit described in subsection (3) of this section signed by the public offi-
21 cial; and

22 (c) A sworn affidavit described in subsection (4) of this section signed by the trustee.

23 (2) The trust agreement must contain the following:

24 (a) A provision incorporating by reference the provisions of sections 29 to 37 of this 2007
25 Act; and

26 (b) A designation of a trustee who meets the requirements of section 32 of this 2007 Act.

27 (3) The affidavit of the public official must state:

28 (a) The nature of the legal proceeding that requires establishment of the trust fund;

29 (b) That the public official will comply with the provisions of sections 29 to 37 of this 2007
30 Act; and

31 (c) That the public official is responsible for the proper administration of the trust fund,
32 even though a trustee of the fund has been designated.

33 (4) The affidavit of the trustee must state that the trustee:

34 (a) Has read and understands sections 29 to 37 of this 2007 Act; and

35 (b) Consents to administer the trust fund in compliance with sections 29 to 37 of this 2007
36 Act.

37 (5) Upon receiving an application under this section, the commission shall review the
38 trust agreement, the affidavits and any supporting documents or instruments filed to deter-
39 mine whether the application meets the requirements of sections 29 to 37 of this 2007 Act.
40 If the commission determines that the application meets the requirements of sections 29 to
41 37 of this 2007 Act, the commission shall grant written authorization to the public official to
42 establish the trust fund.

43 (6) The commission shall review the quarterly statements required under section 35 of
44 this 2007 Act and shall monitor the activities of each trust fund to ensure continued com-

1 (7) Unless subject to the attorney-client privilege, all documents required to be filed re-
2 lating to the creation and administration of a trust fund are public records subject to dis-
3 closure as provided in ORS 192.410 to 192.505.

4 (8) A public official may not establish a legal expense trust fund without receiving prior
5 written authorization of the commission as described in this section.

6 (9) A public official may file an amendment to a trust agreement approved as part of a
7 trust fund under this section. The commission shall approve the amendment if the commis-
8 sion determines the amendment meets the requirements of sections 29 to 37 of this 2007 Act.

9 **SECTION 32.** (1) The trustee of a legal expense trust fund is responsible for:

- 10 (a) The receipt and deposit of contributions to the trust fund;
11 (b) The authorization of expenditures and disbursements from the trust fund;
12 (c) The filing of quarterly statements required under section 35 of this 2007 Act; and
13 (d) The performance of other tasks incident to the administration of the trust fund.

14 (2) The trustee may not:

- 15 (a) Be a public official who serves the same public body as the public official who estab-
16 lishes the trust fund;
17 (b) Be a relative of the public official who establishes the trust fund;
18 (c) Be an attorney for the public official in the legal proceeding for which the trust fund
19 is established, or a member, partner, associate or employee of the firm employing the at-
20 torney; or
21 (d) Have a business or employment relationship with the public official who establishes
22 the trust fund.

23 **SECTION 33.** (1) Except as provided in subsection (3) of this section, any person may
24 contribute to a legal expense trust fund established under sections 29 to 37 of this 2007 Act.

25 (2) A person may make contributions of moneys to a legal expense trust fund in unlim-
26 ited amounts. Pro bono legal assistance and other in-kind assistance may also be provided
27 without limit and is considered a contribution subject to the reporting requirements of sec-
28 tion 35 of this 2007 Act.

29 (3) A political committee as defined in ORS 260.005 that is a principal campaign commit-
30 tee may not contribute to a legal expense trust fund.

31 **SECTION 34.** (1) A trustee of a legal expense trust fund shall establish a single exclusive
32 account in a financial institution, as defined in ORS 706.008. The financial institution must
33 be located in this state and must ordinarily conduct business with the general public in this
34 state.

35 (2) The trustee shall maintain the account in the name of the trust fund.

36 (3) All expenditures made by the trustee shall be drawn from the account and:

- 37 (a) Issued on a check signed by the trustee; or
38 (b) Paid using a debit card or other form of electronic transaction.

39 (4) A contribution received by a trustee shall be deposited into the account not later than
40 seven calendar days after the date the contribution is received. This subsection does not
41 apply to in-kind contributions received.

42 (5) This section does not prohibit the transfer of any amount deposited in the account
43 into a certificate of deposit, stock fund or other investment instrument.

44 (6) The account may not include any public or private moneys or any moneys of any
45 other person, other than contributions received by the trustee.

1 (7) A trustee shall retain a copy of each financial institution account statement from the
2 account described in this section for not less than two years after the date the statement is
3 issued by the financial institution.

4 **SECTION 35.** (1) The trustee of a legal expense trust fund shall, according to the schedule
5 described in subsection (3) of this section, file with the Oregon Government Standards and
6 Practices Commission a statement for the applicable reporting period showing contributions
7 received by the trustee and expenditures made from the trust fund account established under
8 section 34 of this 2007 Act.

9 (2) Each statement shall list:

10 (a) The name and address of each person who contributed an aggregate amount of more
11 than \$75, and the total amount contributed by that person;

12 (b) The total amount of contributions not listed under paragraph (a) of this subsection
13 as a single item, but shall specify how those contributions were obtained;

23 (5) The trustee may amend a statement filed under this section without penalty if the
24 amendment is filed with the commission not later than 30 days after the deadline for filing
25 the statement.

26 **SECTION 36.** (1) A legal expense trust fund established under sections 29 to 37 of this
27 2007 Act may be terminated by:

28 (a) The public official who established the trust fund;

29 (b) Subject to subsection (2) of this section, the terms of the trust agreement; or

30 (c) The Oregon Government Standards and Practices Commission following a determi-
31 nation by the commission that a violation of any provision of ORS chapter 244 has occurred
32 in connection with the trust fund.

33 (2) A trust agreement may provide that a legal expense trust fund is terminated not later
34 than six months following the completion of the legal proceeding for which the fund was es-
35 tablished. Upon application of the public official who established the trust fund, the com-
36 mission may extend the existence of the trust fund to a specified date if the commission
37 determines that the public official has incurred legal expenses that exceed the balance re-
38 maining in the fund. If the commission extends the existence of the trust fund, the trust
39 fund terminates on the date the extension expires.

40 (3) Following termination of a legal expense trust fund, the trustee may not accept con-
41 tributions to or make expenditures from the fund.

42 (4) Not later than 30 days after a trust fund is terminated, the trustee of the fund shall
43 file with the commission a final report listing the totals of all contributions made to the fund
44 and all expenditures made from the fund.

45 **SECTION 37.** (1) Not later than 30 days after a legal expense trust fund is terminated,

1 the trustee of the fund shall return any moneys remaining in the fund to contributors to the
2 fund on a pro rata basis.

3 (2) If the legal proceeding for which the trust fund was established results in an award
4 of attorney fees, costs or any other money judgment award to or in favor of the public offi-
5 cial, amounts awarded shall be distributed in the following order:

6 (a) To pay outstanding legal expenses;

7 (b) To contributors to the trust fund on a pro rata basis; and

8 (c) To the public official or, if required by the trust agreement, to an organization exempt
9 from taxation under section 501(c)(3) of the Internal Revenue Code.
