Work Session

- HB 2950 ** **Subsequent Referral(s) to Ways and Means
Requires the Land Conservation and Development Commission to update the statewide land use planning goal relating to "citizen involvement" by rule by June 30, 2027.
- HB 3103 ** **Subsequent Referral(s) to Ways and Means
Directs the State Forester to establish sustainable harvest levels for harvesting timber on state forestland and develop a timber inventory model to inform sustainable harvest levels.
- HB 3106 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from the General Fund to the Department of Environmental Quality for the Oregon Water Data Portal project.
- HB 3116 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from the General Fund to the Water Resources Department for place-based water planning.
- HB 3364
Makes changes related to a water supply grant program.
- HB 3806
Authorizes the Water Resources Commission to approve a Deschutes River water bank pilot program.

Public Hearing

- HB 2808
Increases certain fees related to wells.
- HB 2165 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from the General Fund to the Water Resources Department for costs related to well construction and compliance.
- HB 2803 ** **Subsequent Referral(s) to Revenue
Increases certain fees related to water.
