#### Work Session

HB 2557

Prohibits a person from raising octopus for the purpose of human consumption or participating in the sale or offer for sale of octopus that was raised for human consumption.

***HB 2785 is scheduled solely for the committee to consider recommending that the bill be moved to a different committee.***

HB 2785

Modifies certain fees charged by the State Department of Geology and Mineral Industries.

HB 3135 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Oregon Department of Administrative Services to award grants to soil and water conservation districts that operate in certain counties.

HB 3910

Expands the justifications for a domestic water supply district to exercise the powers of a sanitary district.

#### Public Hearing

HB 3544

Directs the Water Resources Department to study rules related to water.

HB 3343

Requires the State Department of Fish and Wildlife to study natural resources.

HB 3484

Directs the Water Resources Department to study rules related to water.
