HB 3342

CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the Water Resources Department to study rules related to water.

HB 3544

CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the Water Resources Department to study rules related to water.

HB 2773 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the State Department of Fish and Wildlife to establish a program to award grants for recreational fishing facilities within an urban growth boundary.

HB 2801

Allows the Water Resources Department to approve leases or temporary transfers of certain water rights in the Upper Klamath Basin until a court issues a final water rights decree.

HB 3910

Expands the justifications for a domestic water supply district to exercise the powers of a sanitary district.

HB 3596 **

**Subsequent Referral(s) to Ways and Means

Directs the State Department of Fish and Wildlife to study mule deer in the Steens Mountain herd range area.

HB 3372

Directs the Water Resources Department to study exempt uses of water.

HB 3525

CARRIED OVER FROM THE 4/7/2025 MEETING: Requires, for each dwelling unit rented by a landlord for which the source of drinking water is a well that is subject to regulation, that the landlord collect and test samples of drinking water from the dwelling unit for arsenic, E.

HB 3526

CARRIED OVER FROM THE 4/7/2025 MEETING: Establishes a cause of action for a buyer in a real estate transaction if the seller fails to provide the results of required well tests.

HB 2403

Authorizes landowners who meet certain criteria to petition for formation of a predator damage control district as a funding mechanism to pay the actual costs to the county of preventing, reducing and mitigating damage to property from predatory animals.

HB 3858

Makes remainder lands created by the lawful carve-out of lands by a recorded instrument into lawful units of land.

HB 2803 **

**Subsequent Referral(s) to Revenue

CARRIED OVER FROM THE 4/7/2025 MEETING: Increases certain fees related to water.

HB 3484

CARRIED OVER FROM THE 4/7/2025 MEETING: Directs the Water Resources Department to study rules related to water.

HB 2808

CARRIED OVER FROM THE 4/7/2025 MEETING: Increases certain fees related to wells.

HB 2165 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 4/7/2025 MEETING: Appropriates moneys from the General Fund to the Water Resources Department for costs related to well construction and compliance.

The following bill is scheduled solely for the purpose of moving it to the House Committee on Rules.

HB 3862

Requires the Department of Land Conservation and Development to study land use and submit findings to the interim committees of the Legislative Assembly related to land use no later than September 15, 2026.

Note change: HB 3901, 2557 removed; HB 3862 Public Hearing removed
