Public Hearing

HB 3834 **

**Subsequent Referral(s) to Ways and Means

Directs the Oregon Department of Administrative Services to establish a program to provide reinsurance against the risk of economic loss for insurers that issue policies of insurance against damage or loss caused by wildlife.

HB 3875

Provides that a motor vehicle manufacturer and an affiliate of a motor vehicle manufacturer must comply with the requirements of the state's privacy laws in controlling and processing personal data the motor vehicle manufacturer or affiliate obtains from a consumer's use of a motor vehicle, regardless of the number of consumers from which the motor vehicle manufacturer or affiliate obtains personal data.

HB 3899

Lowers the thresholds above which, in applicable circumstances, controllers are subject to regulation in processing consumers' personal data.
