Work Session

HB 3178

Requires in a transaction for a motor vehicle that is contingent upon a lender purchasing the retail installment contract or lease agreement negotiated between the seller and a buyer that the lender purchase the retail installment contract or lease agreement within two days after the transaction concludes or, if the sale of the retail installment contract or lease agreement does not occur, that the seller either void the transaction or agree to finance the transaction.

HB 2127

Makes various changes to the laws that govern franchise agreements between motor vehicle dealers and manufacturers, distributors and importers.

HB 3605

Punishes a violation of the laws that regulate home solicitation sales as an unlawful practice under the Unlawful Trade Practices Act.

HB 2373 **

**Subsequent Referral(s) to Ways and Means

Prohibits selling or offering for sale a timeshare without a license.

HB 2338 **

**Subsequent Referral(s) to Ways and Means

Creates a new tax professional certification known as a certified tax aide.

Public Hearing

HB 2680

Requires a contractor, as a condition of receiving public funds to install, repair or remodel a fenestration product or system in a public building, to have a national certification as a glazing contractor and at least one employee that has a national certification as an architectural glass and metal technician.

HB 2141

Creates a volunteer registry with the State Board of Architect Examiners for commercial interior designers.
