Work Session

HB 3178

CARRIED OVER FROM THE 3/27/2025 MEETING: Requires in a transaction for a motor vehicle that is contingent upon a lender purchasing the retail installment contract or lease agreement negotiated between the seller and a buyer that the lender purchase the retail installment contract or lease agreement within two days after the transaction concludes or, if the sale of the retail installment contract or lease agreement does not occur, that the seller either void the transaction or agree to finance the transaction.

HB 2127

CARRIED OVER FROM THE 3/27/2025 MEETING: Makes various changes to the laws that govern franchise agreements between motor vehicle dealers and manufacturers, distributors and importers.

HB 3179

CARRIED OVER FROM THE 3/27/2025 MEETING: Directs the Public Utility Commission to consider the cumulative economic impact of a proposed rate or schedule of rates on a public utility's ratepayers if the proposed rate or schedule of rates will result in an increase of the public utility's revenue in this state by 2.

HB 3865

Requires a person that makes a solicitation by telephone or text message to self identify, identify the purpose of the solicitation and identify the person on behalf of which the person is making the solicitation within the first 10 seconds of the call or within the body of the initial text message.

HB 3875

Provides that a motor vehicle manufacturer and an affiliate of a motor vehicle manufacturer must comply with the requirements of the state's privacy laws in controlling and processing personal data the motor vehicle manufacturer or affiliate obtains from a consumer's use of a motor vehicle, regardless of the number of consumers from which the motor vehicle manufacturer or affiliate obtains personal data.

Expands the application of certain statutes requiring publication in a newspaper to allow publication in online news publications.

Directs the Department of Consumer and Business Services to study certain impacts of damages from wildfire.

HB 3779

Requires a person that provides debt resolution services to consumers in this state to register with the Department of Consumer and Business Services and regulates the activities of debt resolution service providers.
