#### **Work Session**

HB 3336

CARRIED OVER FROM THE 3/25/2025 MEETING: Declares a state policy regarding the electric transmission system.

HB 2961

CARRIED OVER FROM THE 3/25/2025 MEETING: Increases the percentage of electrical service capacity for charging electric vehicles or electric vehicle charging stations that must be installed at vehicle parking spaces in the garages or parking areas of newly constructed commercial buildings, multifamily buildings with five or more units and mixed-use buildings consisting of privately owned commercial space and five or more residential dwelling units.

HB 2370

Increases the annual fee amount that the Public Utility Commission may impose on public utilities for the purpose of defraying costs of the commission.

HB 3546

Directs the Public Utility Commission to provide for a classification of service for large energy use facilities.

HB 3081 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the State Department of Energy to coordinate with other organizations, conduct outreach, establish a statewide navigation and support system and provide information in multiple languages, as part of the department's single resource for providing information and assistance related to available energy efficiency incentives and programs.

HB 2063 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Creates the Agrivoltaics Task Force staffed by the Department of Land Conservation and Development.

# AGENDA (cont.) March 27, 2025

HB 2375

Requires a person who is developing or repowering a wind energy facility to apply to the Federal Aviation Administration for installation of a light-mitigating technology system and, if approved, install the system within 24 months.

HB 3814

Prohibits the Environmental Quality Commission and Department of Environmental Quality from requiring seafood processors to meet water quality or purity standards for bacteria in effluent discharges associated with fecal sources.

HB 3655

Directs the Department of Environmental Quality to develop a program for examination and certification of operators of lagoon wastewater treatment systems.

## **Public Hearing**

HB 3868 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the State Department of Energy to study avoided costs paid to qualifying facilities under the federal Public Utility Regulatory Policies Act compared with the costs incurred by investorowned utilities to acquire or maintain renewable energy generation facilities.

HB 3874

Increases from 50 megawatts to 100 megawatts the minimum size that a wind energy facility needs to be before a wind energy facility is required to obtain a site certificate from the Energy Facility Siting Council.

HB 3927 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the State Department of Energy to study the need to expand electric transmission infrastructure in this state.

### **Public Hearing and Possible Work Session**

HB 3863

Requires the Public Utility Commission to establish an eligibility cap at no less than 10 megawatts for the use of standard avoided costs rates and contracts for the purchase of energy or energy and capacity from qualifying facilities under the Public Utility Regulatory Policies Act of 1978.
