Requires specified agencies to consider the effects of a proposed action on older adult populations.

HB 3356 ** **Subsequent Referral(s) to Ways and Means
Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to South Coast Business Employment Corporation to provide meal services to elderly individuals.
