CARRIED OVER FROM THE 4-7-2025 MEETING: Requires the Department of Education to study the adequacy of public education in this state.
- HB 2060
Directs the Department of Education to establish and maintain a registry for nonlicensed tutors.
- HB 2453
Requires the Department of Education to study the adequacy of public education in this state.
- HB 2530
Modifies school bus stop arm camera law.
- HB 3004 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4-7-2025 MEETING: Directs the Youth Development Division to establish a statewide community violence prevention program.
- HB 3040
CARRIED OVER FROM THE 4-7-2025 MEETING: Requires the Department of Education to study methods for improving early literacy outcomes.
- HB 3059 ** **Subsequent Referral(s) to Ways and Means
Requires the Department of Human Services and the Department of Education to jointly study the needs of youth who are in a residential facility and who attend a public school in this state.
- HB 3169 ** **Subsequent Referral(s) to Ways and Means
Directs the Oregon Health Authority to modify the amounts of grants for school-based health centers for inflation.
- HB 3199
CARRIED OVER FROM THE 4-7-2025 MEETING: Requires the Legislative Policy and Research Director to conduct a study regarding policies, grant programs, support programs and other initiatives implemented in this state with the intent of improving school attendance.

- HB 3200 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4-7-2025 MEETING: Requires the Department of Education to allocate a specified amount from the Fund for Student Success to the scholarship program for diverse teacher candidates in the biennium beginning July 1, 2025.
- HB 3360 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4-7-2025 MEETING: Requires that moneys from the corporate income and excise tax kicker be used for the funding of school construction and maintenance projects and infrastructure improvements.
- HB 3365 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4-7-2025 MEETING: Directs the State Board of Education to include an interdisciplinary approach to sustainability and climate change across all subjects for which academic content standards are established.
- HB 3568 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 4-7-2025 MEETING: Appropriates moneys to the Department of Education for distribution to the Oregon Coast Visitors Association for the purpose of promoting seafood in the public schools of this state.
- HB 3624 ** **Subsequent Referral(s) to Ways and Means
Directs education service districts to reimburse parents and legal guardians for fees incurred by parents and legal guardians related to examinations administered to homeschooled children.
- HB 3652
CARRIED OVER FROM THE 4-7-2025 MEETING: Expands the requirement to discuss class size and caseload as mandatory subjects of bargaining for purposes of school district collective bargaining.
