Public Hearing

- HB 2964 ** **Subsequent Referral(s) to Ways and Means
Requires the Housing and Community Services Department to award grants for the predevelopment costs of affordable housing and a grant to assist nonprofits receiving grants or loans under this Act.
- HB 3848
Prohibits the use of assessed historic property as a vacation occupancy unless the property is the owner's primary residence.
- HB 3136
Removes a requirement that a maximum of two real estate professionals may serve on a city or county planning commission.

Work Session

- HB 3031
Requires the Housing and Community Services Department to study housing.
- HB 3235 ** **Subsequent Referral(s) to Ways and Means
Directs the Housing and Community Services Department to give a grant to an organization to support first-time home buyers that purchase residential property to build equity ownership in the residential property through reduced interest rate loans and accelerated loan terms.
