# Work Session

SB 430

CARRIED OVER FROM THE 04-01-2025 AGENDA: Specifies disclosures that a retail seller must make to a retail buyer for a transaction in goods or services that concludes online by means of a website or other electronic method.

SB 433

Permits the owner of a self-service storage facility to advertise or publish a notice of sale of personal property that is subject to a lien once on a publicly accessible website that regularly advertises or offers personal property for auction or sale.

SB 605 \*\* \*\*Subsequent Referral(s) to Health Care CARRIED OVER FROM THE 04-01-2025 AGENDA: Prohibits medical service providers from reporting the amount or existence of medical debt to a consumer reporting agency.

SB 751 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Public Employees Retirement Board to establish definitions of "police officer" and "firefighter" for the sole purpose of determining which police officer and firefighter members of the Public Employees Retirement System are entitled to increased benefits.

SB 757

Requires the Public Employees Retirement Board to study the treatment of the salary of chaplains under the Public Employees Retirement System.

SB 906

CARRIED OVER FROM THE 04-01-2025 AGENDA: Requires that itemized statements provided to employees show, in plain language, the amount and purpose of each deduction. 907

SB 9

CARRIED OVER FROM THE 04-01-2025 AGENDA: Requires an applicant for a license to manufacture psilocybin to submit to the Oregon Health Authority information regarding the ownership and location of the premises to be licensed.

# AGENDA (cont.) April 3, 2025

#### SB 968

CARRIED OVER FROM THE 04-01-2025 AGENDA: Provides requirements for employer deductions for erroneous overpayments of wages for employees who are not subject to a collective bargaining agreement.

SB 1032

Prohibits the retail sale of an aerosol duster that contains 1,1-Difluoroethane to an individual under 21 years of age.

SB 1108

Requires employers to allow employees to take up to four hours of blood donation leave per calendar year without the loss of time, pay or benefits.

#### **Possible Work Session**

#### SB 460

Exempts workers on public works who are participants in a pre-apprenticeship program from the application of laws that determine and require payment of a prevailing rate of wage.

SB 727

Modifies the definition of "health care provider" for purposes of laws concerning job-protected leave.

## Public Hearing and Work Session

SB 66 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Authorizes the Oregon Business Development Department to survey state loan and grant programs for economic development.

#### SB 67

Requires the Employment Department to study issues related to the family and medical leave insurance program.

SB 68

Requires the Bureau of Labor and Industries to study matters relating to laws concerning unpaid, job-protected leave.

SB 71

Requires the Employment Department to study issues related to employment.

SB 1119

CARRIED OVER FROM THE 04-01-2025 AGENDA: Prohibits employers from engaging in unfair immigration-related practices.

SB 1148

CARRIED OVER FROM THE 04-01-2025 AGENDA: Prohibits disability income insurers from requiring a person to use other available benefits for which the person is eligible prior to being eligible for disability benefits offered by the insurer.

### Public Hearing and Possible Work Session

SB 1061

CARRIED OVER FROM THE 04-01-2025 AGENDA: Requires the Director of the Oregon State University Extension Service to establish a lumber grading training program.

### **Public Hearing**

#### SB 999

Modifies the definition of "farmworker camp" so that the relevant statutes apply to farmworker camps specifically in connection with workers who work on a seasonal or temporary basis.
