Work Session

- SB 680 ** **Subsequent Referral(s) to Judiciary
Prohibits a person from publishing or causing to be published an environmental marketing claim, net zero claim or reputational advertising that is materially false, misleading, deceptive or fraudulent.
- SB 832
Makes certain changes related to civil penalties for violations related to disease control.

SB 838

Exempts the State Parks and Recreation Department from the Public Contracting Code in conducting procurements with emerging small businesses and for specified purposes.
