#### Work Session

SB 150

CARRIED OVER FROM 3/18/2025 MEETING: Prohibits receiving compensation for performing certain services for or on behalf of an applicant or a claimant for a veteran's benefit except as provided in applicable federal or state law.

SB 947

CARRIED OVER FROM 3/18/2025 MEETING: Modifies terminology by changing statutory references to "militia" to "national guard."

HB 2341

Adds a uniformed service member's or veteran's e-mail address to the information that the Director of Human Services, Early Learning System Director, Director of Transportation and Director of the Oregon Health Authority are required to provide to the Director of Veterans' Affairs.

HCR 2

Declares a commitment to the health and safety of firefighters and to finding an urgent solution to the problem of firefighting personal protective gear that contains cancer-causing chemicals.

SCR 26

Reaffirms the State of Oregon's commitment to its relationship with Taiwan.

#### Public Hearing

SB 2

Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to the Salvage Chief (LSM380) Foundation for the purpose of repairing and upgrading a salvage vessel.
