SIGNIFICANT INITIATIVES OREGON STATE FIRE MARSHAL

Becoming a New Agency.

Senate Bill 762 authorized the OSFM to:

- Increase field staff for community risk reduction and modernize wildfire response
- Develop defensible space standards for Oregon
- Design and implement incentive programs to boost capacity and reduce risk
- Modernize response tools, such as pre-positioning and immediate response, outside of formal conflagration declarations
- Durable funding for Responses and capacity for the Oregon Fire Service- up staffing and engine program



2024 WILDFIRE SEASON OREGON STATE FIRE MARSHAL





REGULATORY SERVICES OREGON STATE FIRE MARSHAL

- Federal Emergency Planning & Community Right to Know Act (EPCRA)
- OSFM is the State Emergency Response Commission (SERC)
 - SERC Executive Committee reconvened in Nov 2024. 19 voting members
 - Guide and assist the SERC and LEPCs implement EPCRA







ANALYTICS & INTELLIGENCE OREGON STATE FIRE MARSHAL

Provide actionable data to improve public safety and prevent firerelated fatalities, injuries, and economic loss.

Core Functions:

- Program evaluation, forecasting, and predictive analytics.
- Interactive dashboards for trend analysis and decision-making.
- Risk reduction modeling using machine learning.
- Open data initiatives for transparency and accessibility.

Tools and Innovations:

- Fire Fatality Risk Map for injury risk probabilities.
- Oregon Community Risk Assessment Fire Tool (OrCRAFT) for structure fire risks.
- Public dashboards for data transparency.





FIRE AND LIFE SAFETY EDUCATION OREGON STATE FIRE MARSHAL

Statewide programs for fire prevention education and community wildfire risk reduction.

Approach:

- Community Risk Reduction (CRR) strategies.
- Promote behavior change through education and awareness.

Impact Goals:

- Reduce life loss, injuries, and property damage.
- Build fire resilient communities.



COMMUNITY RISK REDUCTION PROGRAMS OREGON STATE FIRE MARSHAL

Smoke & CO Alarms Program:

- 2024: 19 agencies participated; 629 alarms distributed.
- Classes for real estate/property managers: 13 classes, 231 attendees.

Fire & Fall Prevention for Older Adults Program:

- Focus: Empowering independent older adults.
 - Home Escape Planning materials and training.
- NFPA "Steps to Safety" Train-the-Trainer Program.

Top Fire Causes Program:

- Supports agencies addressing cooking, heating, and electrical fire risks.
- 25 agencies piloting educational kits.

COMMUNITY WILDFIRE RISK REDUCTION OREGON STATE FIRE MARSHAL

National Cohesive Wildland Fire Management Strategy:

- Fire-adapted communities.
- Resilient landscapes.
- Enhanced wildfire response capacity.

Accomplishments:

- Delivered 3 wildfire mitigation courses to 90 attendees
- \$1.1M invested in fire adaptation projects

Local Success Stories:

- Rufus, Sherman County: \$35K micro-grant for defensible space projects.
- Oakridge, Lane County: \$200K grant enabled 1st Fire Safe Council in Oregon.





FIRE AND LIFE SAFETY SERVICES **OREGON STATE FIRE MARSHAL**

- Provide technical expertise to Oregon fire agencies
- 366 total fire investigations to determine cause and origin
- 5,000 fire and life safety inspections
- 200 CMS surveys
- 1,200 code-related inquiries







FIRE AND LIFE SAFETY DIVISION OREGON STATE FIRE MARSHAL

Defensible Space Program

- Offers free assessments
 - 2,825 completed
 - 430 assessors representing 97 agencies trained
 - Provide guidance to homeowners on best practices

OREGON DEFENSIBLE SPACE & BEST PRACTICES


Trees and vegetation should be 10 feet from powerlines.

Trees and vegetation should be 10 feet from buildings and chimneys.

For trees and vegetation more than 18 feet tall, remove branches six feet from the ground.

> For trees and vegetation less than 18 feet tall, remove branches up to 1/3 the height of the tree.

Trees and vegetation should be 10 feet from other trees.



Removing or trimming trees near powerlines is dangerous. Only use an experienced, licensed contractor to perform this work.
