LC 1512: Requires the Secretary of State to maintain an online Oregon Rulemaking Information System and establishes requirements for agencies to make certain information available online to persons subject to the agency's rules.

LC 2018: Raises certain fees collected by county clerks.

LC 2020: Allows local elections officials to not take certain actions on a prospective initiative or referendum petition if it is filed between the 75th day prior to and the 35th day following the May or November election.

LC 2500: Makes the fees for copies of records filed with the county clerk the established statutory fees collected by the county clerk.

LC 2516: Authorizes a deputy county clerk to perform weddings.

LC 2679: Allows a precinct committeeperson who appears on the ballot to serve as a volunteer to open envelopes, handle ballots, prepare ballots for counting, and count ballots.
