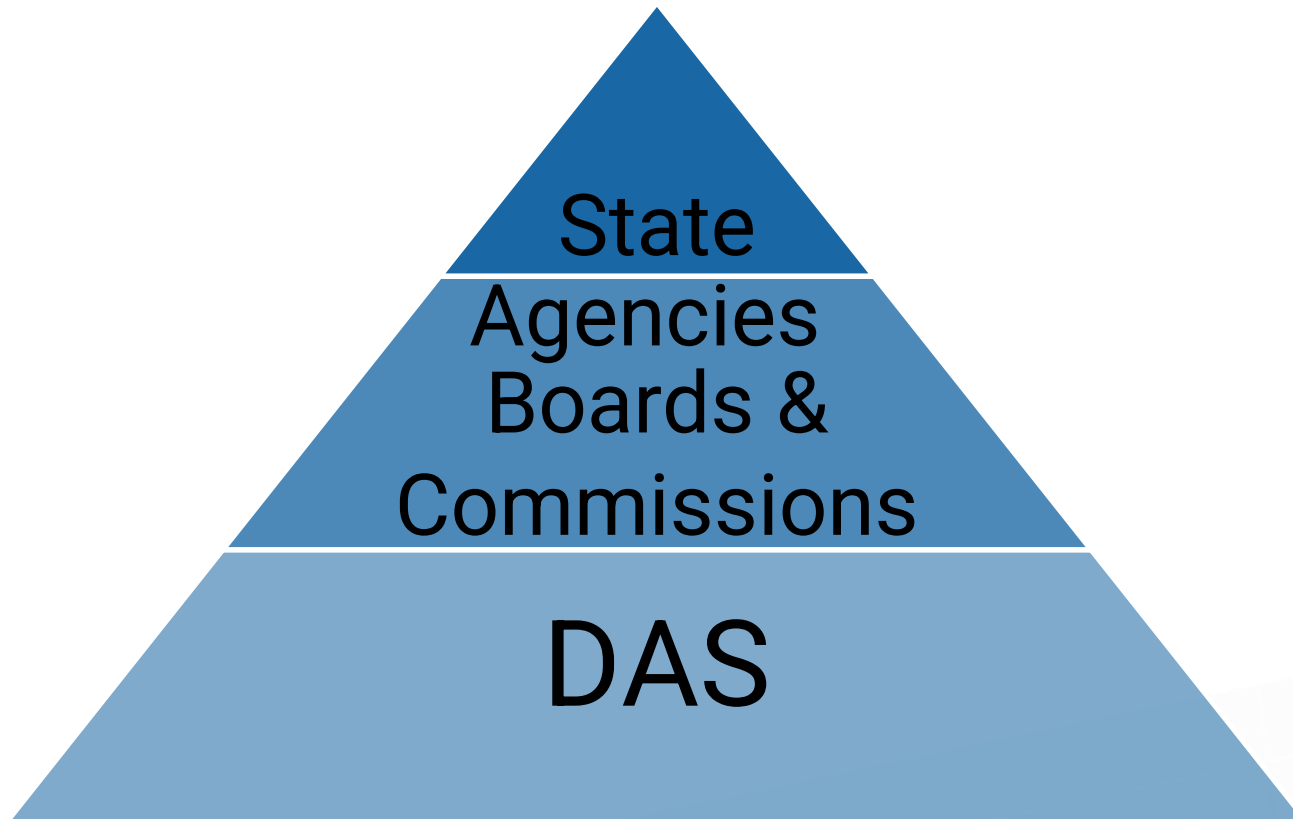


DAS provides leadership and policy direction for agencies- in certain cases.

DAS is the central administrative agency of Oregon state government providing management oversight, as well as technical and administrative support to other state agencies.



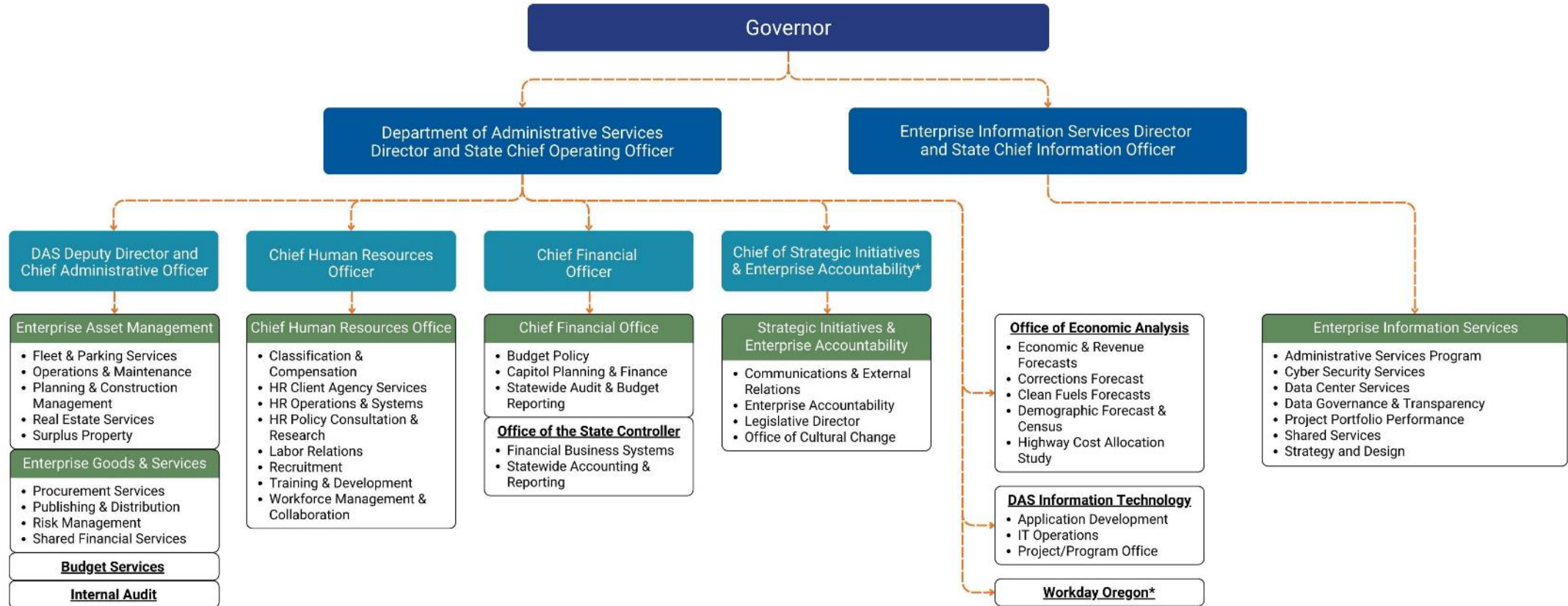

Historical Context



Prior to 1991-93: Oregon Executive Department | Department of General Services

- Policy oversight coordinated through the Executive Department, funded through General Fund.
- Services to agencies by the Department of General Services, funded through charges for services.

1993: Establishment of DAS

- The two departments were merged to create the Department of Administrative Services (DAS).
- New agency funding identified through agency assessments to cover policy oversight function.

Present: DAS Today

- The DAS budget remains assessment based for policy offices, with a mix of assessments and direct charges to agencies for administrative services provided.

DAS has organized and been organized in a variety of forms over time, shifting to support and guide state agencies at direction of current leadership.

DAS is excited about the opportunities in 2025-2027 to refine our focus on ***excellent service delivery, measuring performance and setting the gold standard for all state agencies.***

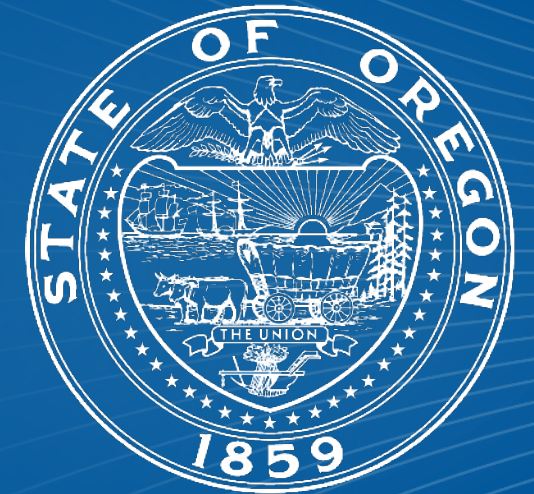
