**Measure Description**

The measure includes a one-time appropriation of \$6 million General Fund to the Oregon Department of Education (ODE) in the 2025-27 biennium to distribute as grants to community-based organizations and education service districts to address the causes of chronic absenteeism in school.

**Fiscal Analysis**

The fiscal impact of the measure is \$6 million General Fund in the 2025-27 biennium. The measure includes a one-time appropriation of \$6 million General Fund to distribute as Grant-in-Aid to community-based organizations and education service districts to address the causes of chronic absenteeism. Currently, ODE distributes approximately \$7 million in grants through the Integrated Community Partnership Grant and through education service district technical assistance grants. The measure seeks to understand and build additional capacity to address attendance barriers and the root causes of chronic absenteeism. ODE will incorporate the additional \$6 million into current structures held within the Office of Education, Innovation, and Improvement to distribute, monitor, and evaluate grants. While ODE may experience an increase in workload and need additional legal services associated with these grants, the impact to ODE’s operations is anticipated to be minimal.

The measure is not anticipated to have a fiscal impact on school districts.

The measure is not anticipated to have a fiscal impact in the 2027-29 biennium.

The measure declares an emergency and takes effect on July 1, 2025.
