

# House Bill 2442

Sponsored by Representatives YUNKER, DIEHL; Representatives BOICE, WRIGHT, Senators NASH, SMITH DB, WEBER (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells a person to show certain forms to register to vote. The Act ends the electronic voter registration system. (Flesch Readability Score: 63.2).

Requires evidence of citizenship for persons registering to vote for the first time in this state. Specifies when registration of qualified person occurs. Repeals the electronic voter registration system.

## A BILL FOR AN ACT

1  
2 Relating to providing proof of United States citizenship when registering to vote; creating new  
3 provisions; amending ORS 247.012, 247.025, 247.171 and 260.993; and repealing ORS 247.019.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2025 Act is added to and made a part of ORS chapter 247.**

6 **SECTION 2. (1) A person who is registering to vote in accordance with ORS 247.012 (1)**  
7 **for the first time must provide evidence of the person's United States citizenship with the**  
8 **registration.**

9 **(2) For purposes of subsection (1) of this section, evidence of United States citizenship**  
10 **may include the original or a legible photocopy of the person's:**

11 **(a) Birth certificate, including any legal documentation proving that the person's legal**  
12 **name has changed since birth.**

13 **(b) United States passport.**

14 **(c) United States naturalization documents.**

15 **(d) United States Bureau of Indian Affairs card number, tribal treaty card number or**  
16 **tribal enrollment number.**

17 **SECTION 3. ORS 247.171 is amended to read:**

18 247.171. (1) Except as provided in this subsection, the Secretary of State shall design, prepare  
19 and distribute state voter registration cards. The Secretary of State shall also distribute federal  
20 registration cards. Any person may apply in writing to the Secretary of State for permission to print,  
21 copy or otherwise prepare and distribute the registration cards designed by the Secretary of State.  
22 The secretary may revoke any permission granted under this subsection at any time. All registration  
23 cards shall be distributed to the public without charge.

24 (2) The Secretary of State shall approve any voter registration application form developed for  
25 use by any agency designated as a voter registration agency under ORS 247.208.

26 (3) Each voter registration card designed or approved by the Secretary of State shall describe  
27 the penalties for knowingly supplying false information on the registration card and shall contain  
28 space for a person to provide the following information:

1 (a) Full name;

2 (b) Residence address, mailing address or any other information necessary to locate the resi-  
3 dence of the person offering to register to vote;

4 (c) The name of the political party with which the person is affiliated, if any;

5 (d) Date of birth;

6 (e) An indication that the person is a citizen of the United States; and

7 (f) A signature attesting to the fact that the person is qualified to be an elector.

8 **(4) Each voter registration card designed by the Secretary of State must state that evi-**  
9 **dence of United States citizenship is required for persons who are registering to vote in this**  
10 **state for the first time and must list examples of documents that are accepted as evidence**  
11 **of citizenship.**

12 [(4)] (5) Any form containing a voter registration card may also include space for a person to  
13 provide:

14 (a) A telephone number where the person may be contacted; and

15 (b) If previously registered to vote in this state, the name then supplied by the person and the  
16 county and, if known, the address of previous registration.

17 [(5)] (6) A person shall not supply any information under subsection (3) or [(4)] (5) of this section  
18 knowing it to be false.

19 [(6)] (7) A county clerk or other person accepting registration cards shall not request any in-  
20 formation unless it is authorized by state or federal law.

21 [(7)] (8) A person shall attest to the information supplied on the voter registration card by  
22 signing the completed registration card.

23 [(8)] (9) Any completed and signed registration card described in subsection (3) of this section  
24 shall be the official registration card of the elector.

25 **SECTION 4.** ORS 247.171, as amended by section 7, chapter 492, Oregon Laws 2023, is amended  
26 to read:

27 247.171. (1) Except as provided in this subsection, the Secretary of State shall design, prepare  
28 and distribute state voter registration cards. The Secretary of State shall also distribute federal  
29 registration cards. Any person may apply in writing to the Secretary of State for permission to print,  
30 copy or otherwise prepare and distribute the registration cards designed by the Secretary of State.  
31 The secretary may revoke any permission granted under this subsection at any time. All registration  
32 cards shall be distributed to the public without charge.

33 (2) The Secretary of State shall approve any voter registration application form developed for  
34 use by any agency designated as a voter registration agency under ORS 247.208.

35 (3) Each voter registration card designed or approved by the Secretary of State shall describe  
36 the penalties for knowingly supplying false information on the registration card and shall contain  
37 space for a person to provide the following information:

 4 **of citizenship.**

5       [(4)] **(5)** Any form containing a voter registration card may also include space for a person to  
 6 provide:

7       (a) A telephone number where the person may be contacted; and

8       (b) If previously registered to vote in this state, the name then supplied by the person and the  
 9 county and, if known, the address of previous registration.

10       [(5)] **(6)** A person shall not supply any information under subsection (3) or [(4)] **(5)** of this section  
 11 knowing it to be false.

12       [(6)] **(7)** A county clerk or other person accepting registration cards shall not request any in-  
 13 formation unless it is authorized by state or federal law.

14       [(7)] **(8)** Except as provided in ORS 247.018, a person shall attest to the information supplied on  
 15 the voter registration card by signing the completed registration card.

16       [(8)] **(9)** Except as provided in subsection [(7)] **(8)** of this section, any completed and signed  
 17 registration card described in subsection (3) of this section shall be the official registration card of  
 18 the elector.

19       **SECTION 5.** ORS 247.012 is amended to read:

20       247.012. (1) A qualified person may register to vote or update a registration to vote by:

21       (a) Delivering by mail, having a person deliver or otherwise delivering a completed registration  
 22 card to any county clerk, the Secretary of State, any office of the Department of Transportation or  
 23 any designated voter registration agency as described in ORS 247.208;

24       (b) Personally delivering, or having a person deliver, the card to an official designated by a  
 25 county clerk under subsection (7) of this section; **or**

26       (c) Submitting the person's legal name, age, residence and citizenship information and electronic  
 27 signature to the Department of Transportation[; *or*].

28       [(d) *Completing a registration card using the electronic voter registration system described in ORS*  
 29 *247.019.*]

30       (2) If a registration card is mailed or delivered to:

31       (a) Any person other than a county clerk or the Secretary of State, the person shall forward the  
 32 card to a county clerk or the Secretary of State not later than the fifth day after receiving the card;  
 33 **or**

34       (b) The Secretary of State or a county clerk for a county other than the county in which the  
 35 person applying for registration resides, the Secretary of State or county clerk shall forward the  
 36 card to the county clerk for the county in which the person resides not later than the fifth day after  
 37 receiving the card.

38       [(3) *Registration of a qualified person occurs:*]

39       [(a) *When a legible, accurate and complete registration card is received in the office of any county*  
 40 *clerk, the Office of the Secretary of State, an office of the Department of Transportation, a designated*  
 41 *voter registration agency under ORS 247.208 or at a location designated by a county clerk under sub-*  
 42 *section (7) of this section;*]

43       [(b) *On the date a registration card is postmarked if the card is received after the 21st day imme-*  
 44 *diately preceding an election but is postmarked not later than the 21st day immediately preceding the*  
 45 *election and is addressed to an office of any county clerk, the Office of the Secretary of State, an office*

1 of the Department of Transportation or any designated voter registration agency as described in ORS  
 2 247.208; or]

3 [(c) In the case of a registration card missing a date of birth, containing an incomplete date of birth  
 4 or containing an unintentional scrivener's error that is supplied or corrected as described in subsection  
 5 (4) or (6) of this section, on the date that registration would have occurred if the registration card had  
 6 not been missing the date of birth, contained an incomplete date of birth or contained the scrivener's  
 7 error.]

8 [(4)(a)] **(3) The county clerk for the county in which the person resides shall register the**  
 9 **person:**

10 (a) Except as provided in ORS 247.125, if [a] **the person's** registration card is legible, accurate  
 11 and contains, at a minimum, the [registrant's] **person's** name, residence address, date of birth and  
 12 signature[, the county clerk shall register the person.]; **and**

13 **(b) For a person registering to vote in this state for the first time, if the person's reg-**  
 14 **istration card is accompanied by evidence of United States citizenship.**

15 [(b)] (4) If the information **or evidence of United States citizenship** required under [paragraph  
 16 (a) of this] subsection **(3) of this section** is missing [from the registration card] or the date of birth  
 17 is incomplete, the county clerk shall attempt to obtain the missing or incomplete information from  
 18 all sources available to the county clerk, including but not limited to current and previous addresses  
 19 and phone numbers of the registrant. The county clerk may also supply the registrant's date of birth  
 20 from any previous registration of the registrant. If the missing or incomplete information cannot be  
 21 obtained from sources available to the county clerk, the county clerk shall use reasonable efforts  
 22 to contact the registrant by phone, mail and electronic mail to obtain the missing or incomplete  
 23 information.

24 (5) If a registration card meets the requirements of subsection [(4)] **(3)** of this section but is  
 25 missing an indication of political party affiliation, the registrant [shall be] **is** considered not affil-  
 26 iated with any political party. This subsection does not apply if an elector is updating a registration.

27 (6) If a registration card contains an unintentional scrivener's error, the county clerk may at-  
 28 tempt to contact the person to correct the error.

29 (7) A county clerk may appoint officials to accept registration of persons at designated locations.  
 30 The appointments and locations shall be in writing and filed in the office of the county clerk. The  
 31 county clerk [shall be] **is** responsible for the performance of duties by those appointed.

32 (8) A registration [card received and accepted] **that occurs** under this section [shall be] **is** con-  
 33 sidered an active registration.

34 (9) A registration may be updated at any time.

35 **(10) The county clerk shall mail a written notice to each person who has attempted to**  
 36 **register to vote for the first time in this state under this section. The notice must indicate**  
 37 **whether the person is registered and must be mailed not later than seven business days after**  
 38 **the county clerk receives registration materials under subsection (1) or (2) of this section.**  
 39 **The registration of a qualified person occurs on the date the county clerk mails the notice**  
 40 **confirming the registration of the person.**

41 **SECTION 6.** ORS 247.012, as amended by section 4, chapter 492, Oregon Laws 2023, is amended  
 42 to read:

43 247.012. (1) A qualified person may register to vote or update a registration to vote by:

44 (a) Delivering by mail, having a person deliver or otherwise delivering a completed registration  
 45 card to any county clerk, the Secretary of State, any office of the Department of Transportation or

1 any designated voter registration agency as described in ORS 247.208;

2 (b) Personally delivering, or having a person deliver, the card to an official designated by a  
3 county clerk under subsection (7) of this section;

4 (c) Submitting the person's legal name, age, residence and citizenship information and electronic  
5 signature to the Department of Transportation; **or**

6 (d) Submitting the person's legal name, age, residence and citizenship information to the Oregon  
7 Health Authority for use in the Oregon Health Plan[; or].

8 *[(e) Completing a registration card using the electronic voter registration system described in ORS  
9 247.019.]*

10 (2) If a registration card is mailed or delivered to:

11 (a) Any person other than a county clerk or the Secretary of State, the person shall forward the  
12 card to a county clerk or the Secretary of State not later than the fifth day after receiving the card;  
13 or

14 (b) The Secretary of State or a county clerk for a county other than the county in which the  
15 person applying for registration resides, the Secretary of State or county clerk shall forward the  
16 card to the county clerk for the county in which the person resides not later than the fifth day after  
17 receiving the card.

18 *[(3) Registration of a qualified person occurs:]*

19 *[(a) When a legible, accurate and complete registration card is received in the office of any county  
20 clerk, the Office of the Secretary of State, an office of the Department of Transportation, a designated  
21 voter registration agency under ORS 247.208 or at a location designated by a county clerk under sub-  
22 section (7) of this section;]*

23 *[(b) On the date a registration card is postmarked if the card is received after the 21st day imme-  
24 diately preceding an election but is postmarked not later than the 21st day immediately preceding the  
25 election and is addressed to an office of any county clerk, the Office of the Secretary of State, an office  
26 of the Department of Transportation or any designated voter registration agency as described in ORS

28 *[(c) In the case of a registration card missing a date of birth, containing an incomplete date of birth  
29 or containing an unintentional scrivener's error that is supplied or corrected as described in subsection  
30 (4) or (6) of this section, on the date that registration would have occurred if the registration card had  
31 not been missing the date of birth, contained an incomplete date of birth or contained the scrivener's  
32 error.]*

33 **[(4)(a)(A)] (3) The county clerk for the county in which the person resides shall register  
34 the person:**

35 **(a)(A)** Except as provided in ORS 247.125, if [a] **the person's** registration card is legible, ac-  
36 curate and contains, at a minimum, the [registrant's] **person's** name, residence address, date of birth  
37 and signature[, the county clerk shall register the person.]; **or**

38 **(B)** *[The county clerk shall register a person]* Pursuant to ORS 247.018, regardless of whether the  
39 person's registration card contains a signature, if the person's registration card is legible, accurate  
40 and contains, at a minimum, the registrant's name, residence address and date of birth[.]; **and**

41 **(b) For a person registering to vote in this state for the first time, if the person's reg-  
42 istration card is accompanied by evidence of United States citizenship.**

43 *[(b)] (4) If the information or evidence of United States citizenship required under [paragraph  
44 (a)(A) of this] subsection (3) of this section is missing [from the registration card] or the date of  
45 birth is incomplete, or if the signature of a person described in [paragraph (a)(B) of this] subsection*

1 **(3) of this section** has not been submitted, the county clerk shall attempt to obtain the missing or  
 2 incomplete information from all sources available to the county clerk, including but not limited to  
 3 current and previous addresses and phone numbers of the registrant. The county clerk may also  
 4 supply the registrant's date of birth from any previous registration of the registrant. If the missing  
 5 or incomplete information cannot be obtained from sources available to the county clerk, the county  
 6 clerk shall use reasonable efforts to contact the registrant by phone, mail and electronic mail to  
 7 obtain the missing or incomplete information.

8 (5) If a registration card meets the requirements of subsection [(4)] **(3)** of this section but is  
 9 missing an indication of political party affiliation, the registrant *[shall be]* **is** considered not affil-  
 10 iated with any political party. This subsection does not apply if an elector is updating a registration.

11 (6) If a registration card contains an unintentional scrivener's error, the county clerk may at-  
 12 tempt to contact the person to correct the error.

 15 county clerk *[shall be]* **is** responsible for the performance of duties by those appointed.

 21 **whether the person is registered and must be mailed not later than seven business days after**  
 22 **the county clerk receives registration materials under subsection (1) or (2) of this section.**  
 23 **The registration of a qualified person occurs on the date the county clerk mails the notice**  
 24 **confirming the registration of the person.**

25 **SECTION 7.** ORS 260.993 is amended to read:

26 260.993. (1) The penalty for violation of ORS 260.532 is limited to that provided in ORS 260.532  
 27 (6) and (8).

28 (2) Violation of ORS 247.125 (1), 247.171 [(5)] **(6)**, 247.420 (2), 253.710, 260.402, 260.555, 260.558,  
 29 260.575, 260.645 or 260.665 (2) or (3) involving any action described in ORS 260.665 (2)(d) to (f) or  
 30 260.715 is a Class C felony.

31 (3) Violation of ORS 260.695 (5) is a Class A misdemeanor.

32 (4) Violation of ORS 247.171 [(6)] **(7)** is a Class C misdemeanor.

33 **SECTION 8. ORS 247.019 is repealed.**

34 **SECTION 9.** ORS 247.025 is amended to read:

35 247.025. To vote in an election:

36 (1) **Except as provided in ORS 247.012 (10)**, a person's registration card must be received at  
 37 an office or location described in ORS 247.012 not later than the time the office or location closes  
 38 for business on the 21st day immediately preceding the election, but in no case later than midnight  
 39 of the 21st day immediately preceding the election; **or**

40 (2) **Except as provided in ORS 247.012 (10)**, a person's registration card must be postmarked  
 41 not later than the 21st day immediately preceding the election and be addressed to an office of any  
 42 county clerk, the Office of the Secretary of State, an office of the Department of Transportation or  
 43 any designated voter registration agency as described in ORS 247.208[; or].

44 [(3) *A person's registration card must be delivered electronically as described in ORS 247.019 not*  
 45 *later than 11:59 p.m. of the 21st day immediately preceding the election.*]

1        **SECTION 10.** (1) Section 2 of this 2025 Act applies to persons who register to vote in this  
2 state for the first time on or after the operative date of section 2 of this 2025 Act.

3        (2) The amendments to ORS 247.171 by sections 3 and 4 of this 2025 Act apply to voter  
4 registration cards designed, prepared or distributed on or after the operative date of the  
5 amendments to ORS 247.171 by sections 3 and 4 of this 2025 Act and to persons who register  
6 to vote for the first time in this state on or after the operative date of the amendments to  
7 ORS 247.171 by sections 3 and 4 of this 2025 Act.

8        (3) The amendments to ORS 247.012 by sections 5 and 6 of this 2025 Act apply to voter  
9 registration cards received, delivered or completed on or after the operative date of the  
10 amendments to ORS 247.012 by sections 5 and 6 of this 2025 Act.

11
