House Bill 2444

Sponsored by Representatives YUNKER, DIEHL; Representatives BOICE, WRIGHT, Senators NASH, SMITH DB (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells a person to show certain forms to register to vote. The Act ends the electronic voter registration system. The Act declares an emergency and becomes law when the Governor signs it. (Flesch Readability Score: 63.4).

Requires evidence of citizenship for persons registering to vote in this state. Specifies when registration of qualified person occurs. Repeals the electronic voter registration system. Declares an emergency, effective on passage.
