

House Bill 3064

Sponsored by Representative BOSHART DAVIS, Senator SOLLMAN, Representatives LEVY E, ELMER, NERON; Representative DRAZAN, Senator WEBER (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Tells some health insurers, OEBB and PEBB to cover care for menopause symptoms. (Flesch Readability Score: 69.9).

Requires certain health insurers, the Oregon Educators Benefit Board and the Public Employees' Benefit Board to cover treatment for perimenopause, menopause and postmenopause.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2025 Act is added to and made a part of the Insurance Code.**

6 **SECTION 2. (1) All health benefit plans, as defined in ORS 743B.005, shall include cover-**
7 **age of the treatment of perimenopause, menopause and postmenopause, including but not**
8 **limited to the following:**

9 (a) **Hormone therapy including combination estrogen and hormone medicines, combina-**
10 **tion estrogen and progesterone medicines and estrogen-only medicines;**

11 (b) **SSRIs and SNRIs;**

12 (c) **Vaginal estrogen;**

13 (d) **Medications to prevent or treat osteoporosis;**

14 (e) **Neurokinin B antagonists;**

15 (f) **Topical hormone therapy; and**

16 (g) **Bioidentical hormones.**

17 **(2) This section is exempt from ORS 743A.001.**
