House Bill 3299

Sponsored by Representative EVANS

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act would allow for the creation of a bridge district in the area around Salem. (Flesch Readability Score: 74.2).

Authorizes the formation of a bridge district in the capital city region, consisting of Benton, Marion, Polk and Yamhill Counties. Authorizes the bridge district to levy property taxes for the purpose of planning, financing, constructing, operating and maintaining bridges over the Willamette River in the capital city region. Provides for the organization of a district board consisting of five members, one elected from each of the four counties in the capital city region and one elected from the district at large.

Sunsets on January 2, 2030.

Takes effect on the 91st day following adjournment sine die.
