**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

**Digest: The Act changes laws related to the regulation of water rights in this state. The Act goes into effect 91 days after sine die. (Flesch Readability Score: 71.2).**

*[Digest: The Act tells an agency to study rules about water. The Act tells the agency to report on the study. (Flesch Readability Score: 74.0).]*

*[Directs the Water Resources Department to study rules related to water. Directs the department to submit a report to the interim committees of the Legislative Assembly related to natural resources not later than September 15, 2026.]*

**Modifies provisions of law related to the regulation and administration of water rights in this state.**

**Takes effect on the 91st day following adjournment sine die.**

6 **Be It Enacted by the People of the State of Oregon:**

8 **ELECTRONIC FORMS OF DOCUMENTS**

9  
10 **SECTION 1. ORS 536.045 is added to and made a part of ORS chapter 536.**

11 **SECTION 2. ORS 536.045 is amended to read:**

12 536.045. (1) Notwithstanding any provision of ORS chapters 536 to 540, 543 or 543A that requires  
13 the mailing of a document, the submission of a document in written form or the provision of a cer-  
14 tified copy of a document, the Water Resources *[Department]* **Commission** may adopt rules:

15 (a) Allowing the submission of one or more types of document to the **commission or the Water**  
16 **Resources** Department by electronic means in lieu of submission by mailing or submission in writ-  
17 ten form;

18 (b) *[Allowing the department, with the consent of the recipient, to]* **Allowing the department or**  
19 **commission** to send one or more types of document in electronic form in lieu of mailing or other  
20 sending of the document in written form, **unless the recipient has requested mailing or other**  
21 **sending of the document in written form;** or

22 (c) Identifying acceptable means for verifying the authenticity of a document sent by electronic  
23 means in lieu of the provision of a certified copy of the document.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (2) *[The department may not adopt rules to require the submission of documents to the department*  
2 *by electronic means. The department may not require a recipient to consent to the receipt of documents*  
3 *from the department by electronic means.]* **Notwithstanding subsection (1) of this section**, the de-  
4 partment **or commission** may not use electronic means in lieu of service under ORCP 7 or notice  
5 under ORS 183.413 or 183.415.

6 (3) For purposes of determining timeliness or calculating deadlines, a document sent by elec-  
7 tronic means in accordance with *[department]* **law or commission** rules is considered to be deliv-  
8 ered when sent.

9 (4) Notwithstanding any provision of ORS chapters 536 to 540, 543 or 543A that specifies a fee  
10 amount, the department may reduce or waive the fee for a document that the department sends or  
11 receives by electronic means.

12 (5) **To satisfy a requirement to provide public notice, the department may publish notice**  
13 **in a newspaper of general circulation. The cost of the publication shall be paid by the appli-**  
14 **cant in advance to the department.**

16 **PUBLICATION IN A WEEKLY PUBLIC NOTICE**  
17

18 **SECTION 3.** ORS 537.145 is amended to read:

19 537.145. (1) If an application is made for a permit to appropriate water for hydroelectric pur-  
20 poses, the Water Resources Department shall give written notice of the filing of the application to  
21 the owner of any land that is:

- 22 (a) Adjacent to any portion of the stream in which the quantity of water will be decreased by  
23 the project; or  
24 (b) Adjacent to the site of the proposed hydroelectric project.

25 (2) The department shall also publish notice of the application *[once each week for at least two*  
26 *successive weeks and for such further time, if any, as the department shall determine, in a newspaper*  
27 *of general circulation in each county in which the project covered by the application is located]* **in the**  
28 **weekly public notice of the department.**

29 **SECTION 4.** ORS 537.252 is amended to read:

30 537.252. (1) When issuing a water right certificate under ORS 537.250 to a district, or to a gov-  
31 ernment agency for a district, the Water Resources Department may issue the water right certificate  
32 for land not described in the permit if:

- 33 (a) Water furnished by the district under the permit has been applied beneficially to the land;  
34 (b) The land not described in the permit that is proposed to be included in the certificate is in-  
35 cluded within the legally established boundaries of the district and is subject to the charges, as-  
36 sessments and liens of the district;  
37 (c) The certificate does not authorize a greater rate, duty or acreage than is authorized by the  
38 terms of the permit, and all other conditions of the permit are satisfied;  
39 (d) The inclusion of land not described in the permit will not result in injury to other existing  
40 water rights or in enlargement of the right authorized under the permit; and  
41 (e) The impact to the water source of including land not described in the permit will not differ  
42 significantly from the impact expected at the time the permit was issued for the lands described in  
43 the permit.

44 (2) If a district proposes to use water on lands not described in the permit, the Water Resources  
45 Department may issue a certificate that includes such additional lands if all of the conditions of

1 subsection (1) of this section are satisfied and if, no later than 60 days before the district actually  
2 applies the water to the lands not described in the permit, the district provides written notice to the  
3 department. The notice shall include a copy of the original permit map modified to show the lands  
4 to be added and lands to be removed from the description of the place of use of the water. Upon  
5 receipt of the notice from the district, the department shall provide public notice of the proposed  
6 change by means of publication in the department's weekly **public notice** *[notice and by publication*  
7 *once each week for two successive weeks in a newspaper having general circulation in the county or*  
8 *counties in which the affected lands are located. The cost of publication shall be paid by the district].*

9 (3) If a district has issued an order of inclusion or exclusion, the boundaries of the irrigation  
10 district shall be deemed to have been legally changed in the absence of approval of the Secretary  
11 of the Interior.

12 (4) As used in this section:

13 (a) "District" has the meaning given in ORS 540.505.

14 (b) "Legally established boundaries" means the boundaries of a district as established at the  
15 time of creation of the district and as the boundaries may have changed after creation of the district  
16 by an inclusion, exclusion or merger proceeding according to state law.

17 **SECTION 5.** ORS 540.520 is amended to read:

18 540.520. (1)(a) Except when the application is made under ORS 541.327 or when an application  
19 for a temporary transfer is made under ORS 540.523, if the holder of a water use subject to transfer  
20 for irrigation, domestic use, manufacturing purposes, or other use, for any reason desires to change  
21 the place of use, the point of diversion, or the use made of the water, an application to make such  
22 change, as the case may be, shall be filed with the Water Resources Department.

23 (b) A holder of a water right certificate that authorizes the storage of water may change the  
24 type of use identified in the water right certificate, as described in this section.

25 (2) The application required under subsection (1) of this section shall include:

26 (a) The name of the owner;

27 (b) The previous use of the water;

28 (c) A description of the premises upon which the water is used;

29 (d) A description of the premises upon which it is proposed to use the water;

30 (e) The use that is proposed to be made of the water;

31 (f) The reasons for making the proposed change; and

32 (g) Evidence that the water has been used over the past five years according to the terms and  
33 conditions of the owner's water right certificate or that the water right is not subject to forfeiture  
34 under ORS 540.610.

35 (3) If the application required under subsection (1) of this section is necessary to allow a change  
36 in a water right pursuant to ORS 537.348, is necessary to complete a project funded under ORS  
37 541.932, or is approved by the State Department of Fish and Wildlife as a change that will result in  
38 a net benefit to fish and wildlife habitat, the **Water Resources** Department, at the discretion of the  
39 Water Resources Director, may waive or assist the applicant in satisfying the requirements of sub-  
40 section (2)(c) and (d) of this section. The assistance provided by the department may include, but  
41 need not be limited to, development of an application map.

42 (4) If the application is to change the point of diversion, the transfer shall include a condition  
43 that the holder of the water right provide a proper fish screen at the new point of diversion, if re-  
44 quested by the State Department of Fish and Wildlife.

45 *[(5) Upon the filing of the application the department shall give notice by publication in a news-*

1 *paper having general circulation in the area in which the water rights are located, for a period of at*  
2 *least two weeks and not less than one publication each week. The notice shall include the date on which*  
3 *the last notice by publication will occur. The cost of the publication shall be paid by the applicant in*  
4 *advance to the department. In applications for only a change in place of use or for a change in the*  
5 *point of diversion of less than one-fourth mile, and where there are no intervening diversions between*  
6 *the old diversion of the applicant and the proposed new diversion, no newspaper notice need be pub-*  
7 *lished. The department shall include notice of such applications in the weekly notice published by the*  
8 *department.]*

9 [(6) *Within 30 days after the last publication of a newspaper notice of the proposed transfer or the*  
10 *mailing of the department's weekly notice, whichever is later, any person may file, jointly or severally,*  
11 *with the department, a protest against approval of the application.]*

12 **(5) The Water Resources Department shall undertake an initial review of an application**  
13 **under subsection (1) of this section.**

14 **(6)(a) Upon completion of the initial review, the department shall notify the applicant of**  
15 **its preliminary determinations, identify any outstanding information that is necessary to**  
16 **continue processing the application and allow the applicant 30 days from the date of notice**  
17 **to:**

18 **(A) Notify the department to stop processing the application; or**

19 **(B) Notify the department to continue processing the application and provide any out-**  
20 **standing information to the department.**

21 **(b) If, within 30 days from the date of the notice, the applicant does not notify the de-**  
22 **partment as provided in paragraph (a) of this subsection, does not provide all outstanding**  
23 **information as provided in paragraph (a)(B) of this subsection or notifies the department to**  
24 **stop processing the application, the department shall close the file for the application and**  
25 **take no further action on the application. The department may allow an applicant up to 60**  
26 **additional days to provide outstanding information if the applicant requests additional time**  
27 **and the department determines that the applicant is undertaking reasonable efforts to pro-**  
28 **vide the information in a timely manner to the department.**

29 **(c) If, within 30 days from the date of the notice or an additional time period allowed**  
30 **under paragraph (b) of this subsection, the applicant notifies the department to proceed with**  
31 **the application and provides any outstanding information necessary to continue processing**  
32 **the application, the department shall:**

33 **(A) Proceed with processing the application.**

34 **(B) Give notice of the initial review in the weekly public notice of the department and**  
35 **accept written public comments for 30 days.**

36 **(7) Upon issuance of a proposed final order, the department shall give notice of the order**  
37 **in the weekly public notice of the department. If the department determines that more than**  
38 **five water rights would be injured as a result of the change proposed in an application under**  
39 **subsection (1) of this section, the department shall publish notice once each week for two**  
40 **consecutive weeks in a newspaper of general circulation in the area in which the water rights**  
41 **are located. The cost of the publication shall be paid by the applicant in advance to the de-**  
42 **partment.**

43 [(7)] **(8) If a timely protest is filed, or in the opinion of the Water Resources Director a hearing**  
44 **is necessary to determine whether the proposed changes as described by the application would re-**  
45 **sult in injury to existing water rights, the department shall hold a hearing on the matter. Notice**

1 and conduct of the hearing shall be under the provisions of ORS chapter 183, pertaining to contested  
2 cases, and shall be held in the area where the rights are located unless all parties and persons who  
3 filed a protest under this subsection stipulate otherwise. **A hearing is not required if:**

- 4 (a) **All issues in the contested case are resolved pursuant to a settlement;**
- 5 (b) **The protest is withdrawn; or**
- 6 (c) **The protestant defaults.**

7 [(8)] (9) An application for a change of use under this section is not required if the beneficial  
8 use authorized by the water use subject to transfer is irrigation and the owner of the water right  
9 uses the water for incidental agricultural, stock watering and other uses related to irrigation use,  
10 so long as there is no increase in the rate, duty, total acreage benefited or season of use.

11 [(9)] (10) A water right transfer under subsection (1) of this section is not required for a general  
12 industrial use that was not included in a water right certificate issued for a specific industrial use  
13 if:

14 (a) The quantity of water used for the general industrial use is not greater than the rate allowed  
15 in the original water right and not greater than the quantity of water diverted to satisfy the au-  
16 thorized specific use under the original water right;

17 (b) The location where the water is to be used for general industrial use was owned by the  
18 holder of the original water right at the time the water right permit was issued; and

19 (c) The person who makes the change in water use provides the following information to the  
20 Water Resources Department:

21 (A) The name and mailing address of the person using water under the water right;

22 (B) The water right certificate number;

23 (C) A description of the location of the industrial facility owned by the holder of the original  
24 water right at the time the water right permit was issued; and

25 (D) A description of the general industrial use to be made of the water after the change.

26 **SECTION 6.** ORS 540.535 is amended to read:

27 540.535. After receipt of an exchange application, the Water Resources Commission shall give  
28 notice of the application **in the weekly public notice of the Water Resources Department** [by  
29 *publishing notice of the application in a newspaper having general circulation in the area in which the*  
30 *water uses are located at least once each week for at least two successive weeks. The cost of providing*  
31 *the notice by publication shall be paid in advance by the applicant to the commission].*

32 **SECTION 7.** ORS 543.220 is amended to read:

33 543.220. (1) If an application is made for a preliminary permit, after said application has been  
34 referred to hearing, the Water Resources Commission shall give written notice of the filing of the  
35 application to:

36 (a) Any municipality or other person or corporation that, in the judgment of the commission, is  
37 likely to be interested in or affected by the proposed project; and

38 (b) The owner of any land that is:

39 (A) Adjacent to any portion of the stream in which the quantity of water will be decreased by  
40 the project; or

41 (B) Adjacent to the site of the proposed project.

42 (2) The commission shall also publish notice of the application [*once each week for at least two*  
43 *successive weeks and for such further time, if any, as the commission shall determine, in a newspaper*  
44 *of general circulation in each county in which the project covered by the application is located] **in the**  
45 **weekly public notice of the Water Resources Department.***

1 (3) No application for the appropriation or use of water for the development of 1,000 theoretical  
2 horsepower or more shall be granted until at least six months after the application for a preliminary  
3 permit has been filed.

5 **PASSING ON CREDIT CARD FEES**

6  
7 **SECTION 8. Section 9 of this 2025 Act is added to and made a part of ORS chapter 536.**

8 **SECTION 9. (1) The Water Resources Department may accept payments by debit or  
9 credit card for any products or services offered by, or fees owed to, the department.**

10 **(2) The department may add a nonrefundable fee to the amount of any payment made  
11 by debit or credit card in an amount reasonably calculated to offset the impact to the de-  
12 partment of financial institution fees related to debit or credit card transactions.**

13  
14 **WITHDRAWAL OF WATERS FROM APPROPRIATION VIA RULE**

15  
16 **SECTION 10. ORS 536.410 is amended to read:**

17 536.410. (1) When the Water Resources Commission determines that it is necessary to [*insure*]  
18 **ensure** compliance with the state water resources policy or that it is otherwise necessary in the  
19 public interest to conserve the water resources of this state for the maximum beneficial use and  
20 control thereof that any unappropriated waters of this state, including unappropriated waters re-  
21 leased from storage or impoundment into the natural flow of a stream for specified purposes, be  
22 withdrawn from appropriation for all or any uses including exempt uses under ORS 537.545, the  
23 commission, on behalf of the state, may [*issue an order of*] **adopt a rule establishing** withdrawal.

24 (2) Prior to the [*issuance of the order of*] **adoption of the rule establishing** withdrawal, the  
25 commission shall hold a public hearing on the necessity for the withdrawal. Notice of the hearing  
26 shall be published in at least one issue each week for at least two consecutive weeks prior to the  
27 hearing in a newspaper of general circulation published in each county in which are located the  
28 waters proposed to be withdrawn.

29 (3) The [*order of*] **rule establishing** withdrawal shall specify with particularity the waters  
30 withdrawn from appropriation, the uses for which the waters are withdrawn[,] **and** the reason for  
31 the withdrawal [*and the duration of the withdrawal*]. The commission may [*modify or revoke the order*  
32 *at any time*] **amend or repeal the rule to modify or revoke the withdrawal.**

33 [(4) *Copies of the order of withdrawal and notices of any modification or revocation of the order*  
34 *of withdrawal shall be filed in the Water Resources Department.*]

35 [(5)] (4) While the [*order of*] **rule establishing** withdrawal is in effect, **a person may not sub-**  
36 **mit, and the Water Resources Department may not file or process,** [*no*] **an application for:**

37 (a) A permit to appropriate the waters withdrawn for the uses specified in the [*order and no*  
38 *application for*] **rule; or**

39 (b) A preliminary permit or license involving appropriations of such waters [*shall be received for*  
40 *filing by the Water Resources Commission*].

41 **SECTION 11. (1) The amendments to ORS 536.410 by section 10 of this 2025 Act apply to**  
42 **withdrawals of waters from appropriation that occur on or after the operative date specified**  
43 **in section 48 of this 2025 Act.**

44 (2) **Withdrawals of waters from appropriation under ORS 536.410 that are in effect on the**  
45 **operative date specified in section 48 of this 2025 Act shall remain in effect unless the with-**

1 **drawals are modified or revoked by the Water Resources Commission on or after the oper-**  
2 **ative date specified in section 48 of this 2025 Act.**

3  
4 **RETURNING APPLICATIONS THAT CANNOT BE APPROVED**

5  
6 **SECTION 12. Section 13 of this 2025 Act is added to and made a part of ORS chapter 536.**

7 **SECTION 13. The Water Resources Department shall publish, make publicly available and**  
8 **regularly update a list of restrictions where the source of water is:**

9 (1) **Designated as a critical ground water area under ORS 537.730.**

10 (2) **Subject to restrictions on allowed ground water uses by classification under ORS**  
11 **536.340.**

12 (3) **Withdrawn from appropriation under ORS chapter 538 or by rule or order of the**  
13 **Water Resources Commission under ORS 536.410.**

14 **SECTION 14. ORS 537.150 is amended to read:**

15 537.150. (1)(a) Within 15 days after receiving an application, the Water Resources Department  
16 shall determine whether the application contains the information listed under ORS 537.140 (1) and  
17 is complete and not defective, including the payment of all [*fees*] **applicable fees or fee amounts**  
18 required under ORS 537.140 (5).

19 (b) If the department determines that the application is incomplete or defective or that not all  
20 [*fees*] **applicable fees or fee amounts** have been paid, the department shall return the fees paid and  
21 the application.

22 (2) Upon determining that an application contains the information listed under ORS 537.140 (1)  
23 and is complete and not defective, the department shall indorse on the application the date upon  
24 which the application was received at the department, which shall be the priority date for any water  
25 right issued in response to the application. All applications that comply with the provisions of law  
26 shall be recorded in a suitable book kept for that purpose.

27 (3) If an application is complete and not defective, the department shall determine whether the  
28 proposed use is prohibited [*by ORS chapter 538*] **pursuant to a restriction under section 13 (3)**  
29 **of this 2025 Act, if the department has information sufficient to make the determination at**  
30 **the time of application intake.** If the proposed use is prohibited [*by ORS chapter 538*] **as described**  
31 **in this subsection,** the department shall [*reject*] **return** the application and [*return*] **all or a portion**  
32 **of the fees paid** to the applicant with an explanation of the [*statutory prohibition*] **reason for the**  
33 **return.**

34 (4) If the proposed use is not prohibited [*by ORS chapter 538*] **under subsection (3) of this**  
35 **section,** the department shall undertake an initial review of the application and make a preliminary  
36 determination of:

37 (a) Whether the proposed use is restricted or limited by statute or rule;

38 (b) The extent to which water is available from the proposed source during the times and in the  
39 amounts requested; and

40 (c) Any other issue the department identifies as a result of the initial review that may preclude  
41 approval of or restrict the proposed use.

42 (5)(a) Upon completion of the initial review and no later than 30 days after determining an ap-  
43 plication to be complete and not defective as described in subsection (1) of this section, the depart-  
44 ment shall notify the applicant of its preliminary determinations and allow the applicant [*14*] **90 days**  
45 from the date of [*mailing*] **notice** within which to notify the department to stop processing the ap-

1 plication or to proceed with the application.

2 (b) If, within 90 days from the date of the notice, the applicant notifies the department to  
3 stop processing the application or does not notify the department whether to proceed with  
4 processing the application, the department shall *[return the application and all fees paid in excess*  
5 *of \$310. If the department receives no timely response from the applicant, the department shall proceed*  
6 *with the application.] close the file for the application and take no further action on the ap-*  
7 *plication.*

8 (c) If, within 90 days from the date of the notice, the applicant notifies the department  
9 to proceed with the application and pays any remaining portion of the applicable examination  
10 fees, as described in section 29 of this 2025 Act, the department shall:

11 (A) Proceed with processing the application; and

12 (B) Give notice of the initial review in the weekly public notice of the department and  
13 accept written public comments for 30 days. The notice must include a request for comments  
14 on the application and information pertaining to how an interested person may obtain future  
15 notices about the application and a copy of the proposed final order.

16 *[(6) Within seven days after proceeding with the application under subsection (5) of this section, the*  
17 *department shall give public notice of the application in the weekly notice published by the department.*  
18 *The notice shall include a request for comments on the application and information pertaining to how*  
19 *an interested person may obtain future notices about the application and a copy of the proposed final*  
20 *order.]*

21 ~~[(7)]~~ (6) Within 30 days after the public notice under subsection ~~[(6)]~~ (5) of this section, any  
22 person interested in the application shall submit written comments to the department. Any person  
23 who asks to receive a copy of the department's proposed final order shall submit to the department  
24 the fee required under ORS 536.050 (1).

25 **SECTION 15.** (1) On and after the operative date specified in section 48 of this 2025 Act,  
26 the Water Resources Department shall return any pending application described in ORS  
27 537.150 for which:

28 (a) Receipt by the department occurred before the operative date specified in section 48  
29 of this 2025 Act;

30 (b) A proposed final order has not been issued before the operative date specified in sec-  
31 tion 48 of this 2025 Act; and

32 (c) The proposed use of water is prohibited pursuant to a restriction described in section  
33 13 (3) of this 2025 Act that was in effect at the time the application was received.

34 (2) The department shall return all or a portion of the fees paid for pending applications  
35 returned under subsection (1) of this section.

36 **SECTION 16.** Section 15 of this 2025 Act is repealed on January 2, 2050.

37 **SECTION 17.** ORS 537.211 is amended to read:

38 537.211. (1) The approval of an application referred to in ORS 537.140 or 537.400 shall be set  
39 forth in a water right permit issued by the Water Resources Department. The permit shall specify  
40 the details of the authorized use and shall set forth any terms, limitations and conditions as the  
41 department considers appropriate including but not limited to any applicable condition required  
42 under ORS 537.289. A copy of the permit shall be filed as a public record in the department. The  
43 permit shall be mailed to the applicant, and upon receipt of the permit the permittee may proceed  
44 with the construction of the necessary works and may take all action required to apply the water  
45 to the designated beneficial use and to perfect the proposed appropriation.



1 (2) Except as provided in subsection [(6)] (7) of this section, if an application under ORS 537.140  
2 or 537.400 indicates that the applicant does not have written authorization or an easement permit-  
3 ting access to nonowned land crossed by the proposed ditch, canal or other work, the department  
4 may issue a final order approving the application if the approval includes a condition requiring the  
5 applicant to obtain such written authorization, or easement or ownership of such land and to pro-  
6 vide the department with a copy of the written authorization, easement or evidence of ownership.

7 (3) If an application referred to in ORS 537.140 or 537.400 is rejected, the department shall enter  
8 a written order setting forth the reasons for the rejection. The applicant shall take no action toward  
9 construction of the works or use of the water. The department shall mail a copy of the order to the  
10 applicant.

11 (4) The holder of a water right permit may change the point of diversion, change the point of  
12 appropriation, change the point of diversion to allow the appropriation of ground water or use the  
13 water on land to which the right is not appurtenant if:

14 (a) The use of water on land to which the right is not appurtenant, the change of point of di-  
15 version or the change in point of appropriation does not result in injury to an existing water right;

16 (b) For a proposed change in the place of use of the water, the land on which the water is to  
17 be used is owned or controlled by the holder of the permit and is contiguous to the land to which  
18 the permit is appurtenant;

19 (c) All other terms of the permit remain the same, including but not limited to the beneficial  
20 use for which the water is used and the number of acres to which water is applied;

21 (d) Prior approval is obtained from the district if the water is transported or conveyed by an  
22 irrigation district organized under ORS chapter 545, a drainage district organized under ORS chap-  
23 ter 547, a water improvement district organized under ORS chapter 552, a water control district  
24 organized under ORS chapter 553 or a district improvement company or a corporation organized  
25 under ORS chapter 554;

26 (e) The holder of the permit provides written notice to the department at least 60 days before  
27 making any changes to the lands, point of diversion or point of appropriation described in the per-  
28 mit;

29 [(f) *The holder of the permit complies with the publication requirements of ORS 540.520 (5), if ap-*  
30 *plicable;*]

31 [(g)] (f) Diversion is provided with a proper fish screen, if requested by the State Department  
32 of Fish and Wildlife; and

33 [(h)] (g) For a request to transfer the point of diversion to allow the appropriation of ground  
34 water, the proposed change meets the standards set forth in ORS 540.531 (2) or (3).

35 **(5) The Water Resources Department may deny a change in the point of appropriation**  
36 **under subsection (4) of this section if the proposed point of appropriation is for a source of**  
37 **ground water restricted under section 13 of this 2025 Act and the proposed use is subject to**  
38 **the restriction.**

39 [(5)] (6) Notwithstanding the requirements of subsection (4)(b) of this section, the holder of a  
40 water right permit may change the place of use of all or any portion of water under the permit to  
41 land that is not contiguous to the land to which the permit is appurtenant if:

42 (a) The change to noncontiguous land is in furtherance of mitigation or conservation efforts  
43 undertaken for the purposes of benefiting a species listed as sensitive, threatened or endangered  
44 under ORS 496.171 to 496.192 or the federal Endangered Species Act of 1973 (16 U.S.C. 1531 to 1544),  
45 as determined by the listing agency; and

1 (b) All other requirements of subsection (4) of this section are met.

2 [(6)] (7) For an application made by or on behalf of a public corporation, the department may  
3 issue a permit approving the application without requiring the applicant to obtain prior written  
4 authorization or an easement permitting access to nonowned lands affected by the proposed project.  
5 However, nothing in this subsection shall be construed to allow any person to trespass on the lands  
6 of another person.

7 [(7)] (8) When the department receives notice under subsection (4)(e) of this section, the de-  
8 partment shall publish the notice in the department's weekly public notice of water right applica-

10 [(8)] (9) If the use of water under the permit is for operation of a mining operation as defined  
11 in ORS 517.952:

12 (a) Review of the application and approval or denial of the application shall be coordinated with  
13 the consolidated application process under ORS 517.952 to 517.989. However, such review and ap-  
14 proval or denial shall take into consideration all policy considerations for the appropriation of water  
15 as set forth in this chapter and ORS chapter 536.

16 (b) The permit may be issued for exploration under ORS 517.702 to 517.740, but the permit shall  
17 be conditioned on the applicant's compliance with the consolidated application process.

18 (c) The permit shall include a condition that additional conditions may be added to the use of  
19 water when a water right certificate is issued, or when the use of water is changed pursuant to ORS  
20 540.520 and 540.530 to use for a mine.

21 [(9)] (10) As used in this section, "contiguous" includes land separated from the land to which  
22 a water right is appurtenant by roads, utility corridors, irrigation ditches or publicly owned rights  
23 of way.

25 537.409. (1) In lieu of the process set forth in ORS 537.140 to 537.211 for applying for a water  
26 right permit, an [*owner of a reservoir*] **applicant for a reservoir permit** may submit an application  
27 to the Water Resources Department to issue a water right permit under ORS 537.211 or a certificate  
28 under ORS 537.250 according to the process set forth in this section if the reservoir:

29 (a) Has a storage capacity of less than 9.2 acre-feet or a dam or impoundment structure less  
30 than 10 feet in height;

31 (b) Does not injure any existing water right;

32 (c) Does not pose a significant detrimental impact to existing fishery resources as determined  
33 on the basis of information submitted by the State Department of Fish and Wildlife; [*and*]

35 **(e) Is not prohibited under ORS chapter 538.**

36 (2) An application for a water right permit for a reservoir under subsection (1) of this section  
37 shall provide sufficient information to demonstrate compliance with the criteria set forth in sub-  
38 section (1) of this section. The application shall:

39 (a) Include the quantity of water to be stored by the reservoir, a map indicating the location  
40 of the reservoir and the source of the water used to fill the reservoir; and

41 (b) Be accompanied by the fee established in ORS 536.050 (1)(q).

42 (3) The map required under subsection (2) of this section need not be prepared by a water right  
43 examiner certified under ORS 537.798. The map submitted with the application shall comply with

12 **SECTION 25.** ORS 537.230 is amended to read:

13 537.230. (1) As used in this section, “undeveloped portion” means the difference between the  
14 maximum rate or duty specified in a water right permit and the maximum rate or duty diverted as  
15 of the later of:

16 (a) June 29, 2005;

17 (b) The time specified in the permit to perfect the water right; or

18 (c) The time specified in the last-approved extension of time to perfect the water right.

19 (2) Except for a holder of a permit for municipal [*use*], **quasi-municipal, group domestic or**  
20 **group domestic expanded uses**, the holder of a water right permit shall prosecute the construction  
21 of any proposed irrigation or other work with reasonable diligence and complete the construction  
22 within a reasonable time, as fixed in the permit by the Water Resources Department, not to exceed  
23 [*five*] **seven** years from the date of approval.

24 (3) The holder of a permit for municipal use shall commence and complete the construction of  
25 any proposed works within 20 years from the date on which a permit for municipal use is issued  
26 under ORS 537.211. The construction must proceed with reasonable diligence and be completed  
27 within the time specified in the permit, not to exceed 20 years. However, the department may order  
28 and allow an extension of time to complete construction or to perfect a water right beyond the time

5 *gation or other works shall be completed or the right perfected. In determining the extension, the de-*  
6 *partment shall give due weight to the considerations described under ORS 539.010 (5) and to whether*  
7 *other governmental requirements relating to the project have significantly delayed completion of con-*

41 and allow an extension of time to complete construction or to perfect a water right beyond the time

18 within 30 days after the date of approval, the permit holder shall file a certificate of completion with  
19 the Water Resources Department, disclosing:

29 efiticial use date allowed in the permit, the permit holder shall submit the survey as required by the  
30 Water Resources Department to the department along with the certificate of completion required  
31 under subsection (4) of this section. If any property described in the permit is not included in the  
32 request for a water right certificate, the holder of the permit shall state the identity of the record  
33 owner of that property.

34 [(6)] (7) After the department has received a certificate of completion and a copy of the survey  
35 as required by subsections [(4) and (5)] (5) and (6) of this section that show, to the satisfaction of  
36 the department, that an appropriation has been perfected in accordance with the provisions of ORS

31 date of the water right purchased, leased or received as a gift. At the request of the person the  
32 Water Resources Commission shall issue a new certificate for the in-stream water right showing the

10 time for the delivery of allegations of injury, the department shall issue an order approving the re-  
11 quest if the department finds that the leasing of the water right for in-stream use can be effected  
12 without injury to other existing water rights or can be conditioned to prevent injury to other ex-  
13 isting water rights. If the lease is for the split use of water between the existing water right and  
14 the in-stream water right during the same calendar year, the conditions imposed in the order ap-  
15 proving the request must include, but need not be limited to, compliance with subsection (3) of this  
16 section.

17 (6) The department at any time may revoke or modify an order issued for a lease under sub-  
18 section (2) of this section if the department determines that the use of the water right for in-stream  
19 use under the lease has resulted in or may result in injury to an existing water right.

20 **SECTION 37.** ORS 537.470 is amended to read:

21 537.470. (1) Upon receipt of an application for allocation of conserved water under ORS 537.465,  
22 the Water Resources Commission shall give notice of receipt of the application in accordance with  
23 ORS 540.520 [(5)] **(6)(c)(B)**.

24 (2) The commission shall allocate conserved water as provided in subsection (3) of this section

16 540.524. (1) Notwithstanding ORS 540.510 or 540.670, upon approval of an application submitted

540.580. (1) In accordance with this section, a district may by petition request that the Water Resources Department approve the permanent transfer of the place of use of water within a district as long as the proposed transfer complies with all of the following:

(a) The rate, duty and total number of acres to which water is to be applied under the water use subject to transfer are not exceeded;

(b) The use authorized under the water use subject to transfer remains the same;

(c) The change in place of use will not result in injury to any existing water right; and

(3) If a district allows a change in the place of use of water before obtaining the approval of the department, the district shall:

(a) Notify each affected landowner that the change is subject to the approval of the department and that the department may reject the transfer or may require mitigation to avoid injury to other water right holders; and

(b) Notify the department in advance of the change. The notice shall include:

(A) The name of the district and the certificate number of each water right that is the subject of the change;

1 (B) The names of the users within the district from whose lands and to whose lands water rights

3 (C) A general description of the users' lands by township, range, quarter quarter section and tax  
4 lot number, and of the water right, for each parcel from which and to which water rights are to be

30 (3) Within 30 days after the close of the period for public comment on the draft proposed final  
31 order, the team shall make any revisions necessary in response to comments received and submit a  
32 proposed final order to the department.

33 (4) The department shall complete the reauthorization process in accordance with the provisions  
34 of ORS 543A.120 to 543A.300.

35 **SECTION 46.** ORS 543A.120 is amended to read:

36 543A.120. (1) A proposed final order prepared by a Hydroelectric Application Review Team and  
37 submitted to the Water Resources Department under ORS 543A.040, 543A.055 or 543A.105 shall be  
38 based on the application of the standards set forth in ORS 543A.025 and shall reflect the complete  
39 review of the water right application for compliance with applicable statutes and rules.

40 (2) The proposed final order shall cite findings of fact and conclusions of law and shall include  
41 but need not be limited to:

42 (a) Confirmation or modification of the preliminary determinations made in the initial review;

43 (b) A brief statement that explains the criteria considered relevant to the decision, including the  
44 applicable basin program, the compatibility of the proposed use with applicable land use plans and  
45 information set forth in the application report or final report on studies;

- 1 (c) An assessment of water availability and the amount of water necessary for the proposed use;
- 2 (d) An assessment of whether the proposed use would result in injury to existing water rights;
- 3 (e) An assessment of whether the proposed use would impair or be detrimental to the public
- 4 interest as provided in ORS 543A.025;
- 5 (f) A draft certificate, including any proposed conditions, or a recommendation to deny the ap-
- 6 plication; and
- 7 (g) The date by which protests to the proposed final order must be received by the department.
- 8 (3) The department shall mail copies of the proposed final order, as submitted by the team, to
- 9 the applicant and to persons who have requested copies and paid the fee required under ORS 536.050
- 10 (1)(p). The department also shall give public notice of the proposed final order in the weekly **public**
- 11 notice published by the department.
- 12 (4) Any person may request standing for purposes of participating in any contested case pro-
- 13 ceeding on the proposed final order or for judicial review of a final order. A request for standing
- 14 shall be in writing and shall be accompanied by the fee established under ORS 536.050 (1)(n).
- 15 (5) Any person may submit a protest against a proposed final order. A protest shall be in writing
- 16 and shall include:
- 17 (a) The name, address and telephone number of the protestant;
- 18 (b) A description of the protestant's interest in the proposed final order and, if the protestant
- 19 claims to represent the public interest, a precise statement of the public interest represented;
- 20 (c) A detailed description of how the action proposed in the proposed final order would impair
- 21 or be detrimental to the protestant's interest;
- 22 (d) A detailed description of how the proposed final order is in error or deficient and how to
- 23 correct the alleged error or deficiency;
- 24 (e) Any citation of legal authority supporting the protest, if known; and
- 25 (f) The protest fee required under ORS 536.050 (1)(j).
- 26 (6) Requests for standing and protests on the proposed final order shall be submitted within 45
- 27 days after publication of the notice of the proposed final order in the weekly **public** notice published
- 28 by the department. Any person who asks to receive a copy of the department's final order shall
- 29 submit to the department the fee required under ORS 536.050 (1)(p), unless the person has previously
- 30 requested copies and paid the required fee.
- 31 (7) The Hydroelectric Application Review Team shall review any protest received and provide
- 32 to the Water Resources Director a recommended response to any protest received.
- 33 (8) Within 120 days after the close of the period for receiving protests and after consultation
- 34 with the Hydroelectric Application Review Team, the director shall:
- 35 (a) Issue a final order as provided under ORS 543A.130; or
- 36 (b) Schedule a contested case hearing if a protest has been submitted and if:
- 37 (A) Upon review of the issues, the director finds that there are significant disputes related to
- 38 the proposed reauthorization of the project; or
- 39 (B) Within 30 days after the close of the period for submitting protests, the applicant requests
- 40 a contested case hearing.
- 41 (9) At the request of the applicant, the department may extend the time periods set forth in
- 42 subsection (8) of this section for a reasonable period of time.
- 43 (10) If the application is for reauthorization of a water right for a federally licensed project, the
- 44 department may postpone the issuance of the final order until the Federal Energy Regulatory Com-
- 45 mission license is issued.

**SECTION 48. Sections 9, 13, 24, 29 and 31a of this 2025 Act and the amendments to ORS 536.045, 536.410, 537.145, 537.147, 537.150, 537.153, 537.211, 537.225, 537.230, 537.252, 537.348, 537.409, 537.470, 537.610, 537.620, 537.621, 537.630, 538.450, 540.520, 540.524, 540.535, 540.570, 540.580, 540.585, 543.220, 543A.035, 543A.040, 543A.055 and 543A.120 by sections 2 to 7, 10, 14, 17 to 20, 25, 26, 32, 33 and 34 to 46 of this 2025 Act become operative on April 1, 2026.**

**EARLY AGENCY ACTION**

**SECTION 49. The Water Resources Department and the Water Resources Commission may take any action before the operative date specified in section 48 of this 2025 Act that is necessary to enable the department and the commission to exercise, on and after the operative date specified in section 48 of this 2025 Act, all of the duties, functions and powers conferred on the department and the commission by the provisions of this 2025 Act.**

**EFFECTIVE DATE**

**SECTION 50. This 2025 Act takes effect on the 91st day after the date on which the 2025 regular session of the Eighty-third Legislative Assembly adjourns sine die.**
