SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act changes laws related to the regulation of water rights in this state. The Act goes into effect 91 days after sine die. (Flesch Readability Score: 71.2).

Modifies provisions of law related to the regulation and administration of water rights in this state.

Takes effect on the 91st day following adjournment sine die.

10 **SECTION 1. ORS 536.045 is added to and made a part of ORS chapter 536.**

11 **SECTION 2. ORS 536.045 is amended to read:**

12 536.045. (1) Notwithstanding any provision of ORS chapters 536 to 540, 543 or 543A that requires
13 the mailing of a document, the submission of a document in written form or the provision of a cer-
14 tified copy of a document, the Water Resources [*Department*] **Commission** may adopt rules:

15 (a) Allowing the submission of one or more types of document to the **commission or the Water**
16 **Resources** Department by electronic means in lieu of submission by mailing or submission in writ-
17 ten form;

18 (b) [*Allowing the department, with the consent of the recipient, to*] **Allowing the department or**
19 **commission to** send one or more types of document in electronic form in lieu of mailing or other
20 sending of the document in written form, **unless the recipient has requested mailing or other**
21 **sending of the document in written form;** or

22 (c) Identifying acceptable means for verifying the authenticity of a document sent by electronic
23 means in lieu of the provision of a certified copy of the document.

24 (2) [*The department may not adopt rules to require the submission of documents to the department*
25 *by electronic means. The department may not require a recipient to consent to the receipt of documents*

3 (3) For purposes of determining timeliness or calculating deadlines, a document sent by elec-
4 tronic means in accordance with [department] **law or commission** rules is considered to be deliv-
5 ered when sent.

6 (4) Notwithstanding any provision of ORS chapters 536 to 540, 543 or 543A that specifies a fee
7 amount, the department may reduce or waive the fee for a document that the department sends or
8 receives by electronic means.

9 (5) **To satisfy a requirement to provide public notice, the department may publish notice**
10 **in a newspaper of general circulation. The cost of the publication shall be paid by the appli-**
11 **cant in advance to the department.**

13 **PUBLICATION IN A WEEKLY PUBLIC NOTICE**

14
15 **SECTION 3.** ORS 537.145 is amended to read:

16 537.145. (1) If an application is made for a permit to appropriate water for hydroelectric pur-
17 poses, the Water Resources Department shall give written notice of the filing of the application to
18 the owner of any land that is:

19 (a) Adjacent to any portion of the stream in which the quantity of water will be decreased by
20 the project; or

21 (b) Adjacent to the site of the proposed hydroelectric project.

22 (2) The department shall also publish notice of the application [*once each week for at least two*
23 *successive weeks and for such further time, if any, as the department shall determine, in a newspaper*
24 *of general circulation in each county in which the project covered by the application is located*] **in the**
25 **weekly public notice of the department.**

26 **SECTION 4.** ORS 537.252 is amended to read:

27 537.252. (1) When issuing a water right certificate under ORS 537.250 to a district, or to a gov-
28 ernment agency for a district, the Water Resources Department may issue the water right certificate
29 for land not described in the permit if:

30 (a) Water furnished by the district under the permit has been applied beneficially to the land;

31 (b) The land not described in the permit that is proposed to be included in the certificate is in-
32 cluded within the legally established boundaries of the district and is subject to the charges, as-
33 sessments and liens of the district;

34 (c) The certificate does not authorize a greater rate, duty or acreage than is authorized by the
35 terms of the permit, and all other conditions of the permit are satisfied;

36 (d) The inclusion of land not described in the permit will not result in injury to other existing
37 water rights or in enlargement of the right authorized under the permit; and

38 (e) The impact to the water source of including land not described in the permit will not differ
39 significantly from the impact expected at the time the permit was issued for the lands described in
40 the permit.

41 (2) If a district proposes to use water on lands not described in the permit, the Water Resources
42 Department may issue a certificate that includes such additional lands if all of the conditions of
43 subsection (1) of this section are satisfied and if, no later than 60 days before the district actually
44 applies the water to the lands not described in the permit, the district provides written notice to the
45 department. The notice shall include a copy of the original permit map modified to show the lands

1 to be added and lands to be removed from the description of the place of use of the water. Upon
2 receipt of the notice from the district, the department shall provide public notice of the proposed
3 change by means of publication in the department's weekly **public notice** [*notice and by publication*
4 *once each week for two successive weeks in a newspaper having general circulation in the county or*
5 *counties in which the affected lands are located. The cost of publication shall be paid by the district*].

6 (3) If a district has issued an order of inclusion or exclusion, the boundaries of the irrigation
7 district shall be deemed to have been legally changed in the absence of approval of the Secretary
8 of the Interior.

9 (4) As used in this section:

10 (a) "District" has the meaning given in ORS 540.505.

11 (b) "Legally established boundaries" means the boundaries of a district as established at the
12 time of creation of the district and as the boundaries may have changed after creation of the district
13 by an inclusion, exclusion or merger proceeding according to state law.

14 **SECTION 5.** ORS 540.520 is amended to read:

15 540.520. (1)(a) Except when the application is made under ORS 541.327 or when an application
16 for a temporary transfer is made under ORS 540.523, if the holder of a water use subject to transfer
17 for irrigation, domestic use, manufacturing purposes, or other use, for any reason desires to change
18 the place of use, the point of diversion, or the use made of the water, an application to make such
19 change, as the case may be, shall be filed with the Water Resources Department.

20 (b) A holder of a water right certificate that authorizes the storage of water may change the
21 type of use identified in the water right certificate, as described in this section.

22 (2) The application required under subsection (1) of this section shall include:

23 (a) The name of the owner;

24 (b) The previous use of the water;

25 (c) A description of the premises upon which the water is used;

26 (d) A description of the premises upon which it is proposed to use the water;

27 (e) The use that is proposed to be made of the water;

28 (f) The reasons for making the proposed change; and

29 (g) Evidence that the water has been used over the past five years according to the terms and
30 conditions of the owner's water right certificate or that the water right is not subject to forfeiture
31 under ORS 540.610.

32 (3) If the application required under subsection (1) of this section is necessary to allow a change
33 in a water right pursuant to ORS 537.348, is necessary to complete a project funded under ORS
34 541.932, or is approved by the State Department of Fish and Wildlife as a change that will result in
35 a net benefit to fish and wildlife habitat, the **Water Resources** Department, at the discretion of the
36 Water Resources Director, may waive or assist the applicant in satisfying the requirements of sub-
37 section (2)(c) and (d) of this section. The assistance provided by the department may include, but
38 need not be limited to, development of an application map.

39 (4) If the application is to change the point of diversion, the transfer shall include a condition
40 that the holder of the water right provide a proper fish screen at the new point of diversion, if re-
41 quested by the State Department of Fish and Wildlife.

42 [(5) Upon the filing of the application the department shall give notice by publication in a news-
43 paper having general circulation in the area in which the water rights are located, for a period of at
44 least two weeks and not less than one publication each week. The notice shall include the date on which
45 the last notice by publication will occur. The cost of the publication shall be paid by the applicant in

1 *advance to the department. In applications for only a change in place of use or for a change in the*
2 *point of diversion of less than one-fourth mile, and where there are no intervening diversions between*
3 *the old diversion of the applicant and the proposed new diversion, no newspaper notice need be pub-*
4 *lished. The department shall include notice of such applications in the weekly notice published by the*
5 *department.]*

6 [(6) *Within 30 days after the last publication of a newspaper notice of the proposed transfer or the*
7 *mailing of the department's weekly notice, whichever is later, any person may file, jointly or severally,*
8 *with the department, a protest against approval of the application.]*

9 **(5) The Water Resources Department shall undertake an initial review of an application**
10 **under subsection (1) of this section.**

11 **(6)(a) Upon completion of the initial review, the department shall notify the applicant of**
12 **its preliminary determinations, identify any outstanding information that is necessary to**
13 **continue processing the application and allow the applicant 30 days from the date of notice**
14 **to:**

15 **(A) Notify the department to stop processing the application; or**

16 **(B) Notify the department to continue processing the application and provide any out-**
17 **standing information to the department.**

18 **(b) If, within 30 days from the date of the notice, the applicant does not notify the de-**
19 **partment as provided in paragraph (a) of this subsection, does not provide all outstanding**
20 **information as provided in paragraph (a)(B) of this subsection or notifies the department to**
21 **stop processing the application, the department shall close the file for the application and**
22 **take no further action on the application. The department may allow an applicant up to 60**
23 **additional days to provide outstanding information if the applicant requests additional time**
24 **and the department determines that the applicant is undertaking reasonable efforts to pro-**
25 **vide the information in a timely manner to the department.**

26 **(c) If, within 30 days from the date of the notice or an additional time period allowed**
27 **under paragraph (b) of this subsection, the applicant notifies the department to proceed with**
28 **the application and provides any outstanding information necessary to continue processing**
29 **the application, the department shall:**

30 **(A) Proceed with processing the application.**

31 **(B) Give notice of the initial review in the weekly public notice of the department and**
32 **accept written public comments for 30 days.**

33 **(7) Upon issuance of a proposed final order, the department shall give notice of the order**
34 **in the weekly public notice of the department. If the department determines that more than**
35 **five water rights would be injured as a result of the change proposed in an application under**
36 **subsection (1) of this section, the department shall publish notice once each week for two**
37 **consecutive weeks in a newspaper of general circulation in the area in which the water rights**
38 **are located. The cost of the publication shall be paid by the applicant in advance to the de-**
39 **partment.**

40 [(7)] **(8) If a timely protest is filed, or in the opinion of the Water Resources Director a hearing**
41 **is necessary to determine whether the proposed changes as described by the application would re-**
42 **sult in injury to existing water rights, the department shall hold a hearing on the matter. Notice**
43 **and conduct of the hearing shall be under the provisions of ORS chapter 183, pertaining to contested**
44 **cases, and shall be held in the area where the rights are located unless all parties and persons who**
45 **filed a protest under this subsection stipulate otherwise. A hearing is not required if:**

1 (a) All issues in the contested case are resolved pursuant to a settlement;

2 (b) The protest is withdrawn; or

3 (c) The protestant defaults.

4 [(8)] (9) An application for a change of use under this section is not required if the beneficial
5 use authorized by the water use subject to transfer is irrigation and the owner of the water right
6 uses the water for incidental agricultural, stock watering and other uses related to irrigation use,
7 so long as there is no increase in the rate, duty, total acreage benefited or season of use.

8 [(9)] (10) A water right transfer under subsection (1) of this section is not required for a general
9 industrial use that was not included in a water right certificate issued for a specific industrial use
10 if:

11 (a) The quantity of water used for the general industrial use is not greater than the rate allowed
12 in the original water right and not greater than the quantity of water diverted to satisfy the au-
13 thorized specific use under the original water right;

14 (b) The location where the water is to be used for general industrial use was owned by the
15 holder of the original water right at the time the water right permit was issued; and

16 (c) The person who makes the change in water use provides the following information to the
17 Water Resources Department:

18 (A) The name and mailing address of the person using water under the water right;

19 (B) The water right certificate number;

20 (C) A description of the location of the industrial facility owned by the holder of the original
21 water right at the time the water right permit was issued; and

22 (D) A description of the general industrial use to be made of the water after the change.

23 **SECTION 6.** ORS 540.535 is amended to read:

24 540.535. After receipt of an exchange application, the Water Resources Commission shall give
25 notice of the application **in the weekly public notice of the Water Resources Department** [by
26 *publishing notice of the application in a newspaper having general circulation in the area in which the*
27 *water uses are located at least once each week for at least two successive weeks. The cost of providing*
28 *the notice by publication shall be paid in advance by the applicant to the commission*].

29 **SECTION 7.** ORS 543.220 is amended to read:

30 543.220. (1) If an application is made for a preliminary permit, after said application has been
31 referred to hearing, the Water Resources Commission shall give written notice of the filing of the
32 application to:

33 (a) Any municipality or other person or corporation that, in the judgment of the commission, is
34 likely to be interested in or affected by the proposed project; and

35 (b) The owner of any land that is:

36 (A) Adjacent to any portion of the stream in which the quantity of water will be decreased by
37 the project; or

38 (B) Adjacent to the site of the proposed project.

39 (2) The commission shall also publish notice of the application [*once each week for at least two*
40 *successive weeks and for such further time, if any, as the commission shall determine, in a newspaper*
41 *of general circulation in each county in which the project covered by the application is located*] **in the**
42 **weekly public notice of the Water Resources Department.**

43 (3) No application for the appropriation or use of water for the development of 1,000 theoretical
44 horsepower or more shall be granted until at least six months after the application for a preliminary
45 permit has been filed.

PASSING ON CREDIT CARD FEES

SECTION 8. Section 9 of this 2025 Act is added to and made a part of ORS chapter 536.

SECTION 9. (1) The Water Resources Department may accept payments by debit or credit card for any products or services offered by, or fees owed to, the department.

(2) The department may add a nonrefundable fee to the amount of any payment made by debit or credit card in an amount reasonably calculated to offset the impact to the department of financial institution fees related to debit or credit card transactions.

WITHDRAWAL OF WATERS FROM APPROPRIATION VIA RULE

SECTION 10. ORS 536.410 is amended to read:

536.410. (1) When the Water Resources Commission determines that it is necessary to *[insure]* ensure compliance with the state water resources policy or that it is otherwise necessary in the public interest to conserve the water resources of this state for the maximum beneficial use and control thereof that any unappropriated waters of this state, including unappropriated waters released from storage or impoundment into the natural flow of a stream for specified purposes, be withdrawn from appropriation for all or any uses including exempt uses under ORS 537.545, the commission, on behalf of the state, may *[issue an order of]* adopt a rule establishing withdrawal.

(2) Prior to the *[issuance of the order of]* adoption of the rule establishing withdrawal, the commission shall hold a public hearing on the necessity for the withdrawal. Notice of the hearing shall be published in at least one issue each week for at least two consecutive weeks prior to the hearing in a newspaper of general circulation published in each county in which are located the waters proposed to be withdrawn.

(3) The *[order of]* rule establishing withdrawal shall specify with particularity the waters withdrawn from appropriation, the uses for which the waters are withdrawn[,] and the reason for the withdrawal *[and the duration of the withdrawal]*. The commission may *[modify or revoke the order at any time]* amend or repeal the rule to modify or revoke the withdrawal.

[(4) Copies of the order of withdrawal and notices of any modification or revocation of the order of withdrawal shall be filed in the Water Resources Department.]

[(5)] (4) While the *[order of]* rule establishing withdrawal is in effect, a person may not submit, and the Water Resources Department may not file or process, *[no]* an application for:

(a) A permit to appropriate the waters withdrawn for the uses specified in the *[order and no application for]* rule; or

(b) A preliminary permit or license involving appropriations of such waters *[shall be received for filing by the Water Resources Commission]*.

SECTION 11. (1) The amendments to ORS 536.410 by section 10 of this 2025 Act apply to withdrawals of waters from appropriation that occur on or after the operative date specified in section 48 of this 2025 Act.

(2) Withdrawals of waters from appropriation under ORS 536.410 that are in effect on the operative date specified in section 48 of this 2025 Act shall remain in effect unless the withdrawals are modified or revoked by the Water Resources Commission on or after the operative date specified in section 48 of this 2025 Act.

RETURNING APPLICATIONS THAT CANNOT BE APPROVED

1 **SECTION 12.** Section 13 of this 2025 Act is added to and made a part of ORS chapter 536.

2 **SECTION 13.** The Water Resources Department shall publish, make publicly available and
3 regularly update a list of restrictions where the source of water is:

4 (1) Designated as a critical ground water area under ORS 537.730.

5 (2) Subject to restrictions on allowed ground water uses by classification under ORS
6 536.340.

7 (3) Withdrawn from appropriation under ORS chapter 538 or by rule or order of the
8 Water Resources Commission under ORS 536.410.

9 **SECTION 14.** ORS 537.150 is amended to read:

10 537.150. (1)(a) Within 15 days after receiving an application, the Water Resources Department
11 shall determine whether the application contains the information listed under ORS 537.140 (1) and
12 is complete and not defective, including the payment of all [fees] **applicable fees or fee amounts**
13 required under ORS 537.140 (5).

14 (b) If the department determines that the application is incomplete or defective or that not all
15 [fees] **applicable fees or fee amounts** have been paid, the department shall return the fees paid and
16 the application.

17 (2) Upon determining that an application contains the information listed under ORS 537.140 (1)
18 and is complete and not defective, the department shall indorse on the application the date upon
19 which the application was received at the department, which shall be the priority date for any water
20 right issued in response to the application. All applications that comply with the provisions of law
21 shall be recorded in a suitable book kept for that purpose.

22 (3) If an application is complete and not defective, the department shall determine whether the
23 proposed use is prohibited [by ORS chapter 538] **pursuant to a restriction under section 13 (3)**
24 **of this 2025 Act, if the department has information sufficient to make the determination at**
25 **the time of application intake.** If the proposed use is prohibited [by ORS chapter 538] **as described**
26 **in this subsection,** the department shall [reject] **return** the application and [return] **all or a portion**
27 **of the fees paid** to the applicant with an explanation of the [statutory prohibition] **reason for the**
28 **return.**

29 (4) If the proposed use is not prohibited [by ORS chapter 538] **under subsection (3) of this**
30 **section,** the department shall undertake an initial review of the application and make a preliminary
31 determination of:

32 (a) Whether the proposed use is restricted or limited by statute or rule;

33 (b) The extent to which water is available from the proposed source during the times and in the
34 amounts requested; and

35 (c) Any other issue the department identifies as a result of the initial review that may preclude
36 approval of or restrict the proposed use.

37 (5)(a) Upon completion of the initial review and no later than 30 days after determining an ap-
38 plication to be complete and not defective as described in subsection (1) of this section, the depart-
39 ment shall notify the applicant of its preliminary determinations and allow the applicant [14] **90** days
40 from the date of [mailing] **notice** within which to notify the department to stop processing the ap-
41 plication or to proceed with the application.

42 (b) If, **within 90 days from the date of the notice,** the applicant notifies the department to
43 stop processing the application **or does not notify the department whether to proceed with**
44 **processing the application,** the department shall [return the application and all fees paid in excess
45 of \$310. If the department receives no timely response from the applicant, the department shall proceed

1 *with the application.] close the file for the application and take no further action on the ap-*
2 *plication.*

3 **(c) If, within 90 days from the date of the notice, the applicant notifies the department**
4 **to proceed with the application and pays any remaining portion of the applicable examination**
5 **fees, as described in section 29 of this 2025 Act, the department shall:**

6 **(A) Proceed with processing the application; and**

7 **(B) Give notice of the initial review in the weekly public notice of the department and**
8 **accept written public comments for 30 days. The notice must include a request for comments**
9 **on the application and information pertaining to how an interested person may obtain future**
10 **notices about the application and a copy of the proposed final order.**

11 *[(6) Within seven days after proceeding with the application under subsection (5) of this section, the*
12 *department shall give public notice of the application in the weekly notice published by the department.*
13 *The notice shall include a request for comments on the application and information pertaining to how*
14 *an interested person may obtain future notices about the application and a copy of the proposed final*
15 *order.]*

16 *[(7)] (6) Within 30 days after the public notice under subsection [(6)] (5) of this section, any*
17 *person interested in the application shall submit written comments to the department. Any person*
18 *who asks to receive a copy of the department's proposed final order shall submit to the department*
19 *the fee required under ORS 536.050 (1).*

20 **SECTION 15. (1) Notwithstanding ORS 536.031 (1), on and after the operative date speci-**
21 **fied in section 48 of this 2025 Act, the Water Resources Department shall return any pending**
22 **application described in ORS 537.150 for which:**

23 **(a) Receipt by the department occurred before the operative date specified in section 48**
24 **of this 2025 Act;**

25 **(b) A proposed final order has not been issued before the operative date specified in sec-**
26 **tion 48 of this 2025 Act; and**

27 **(c) The proposed use of water is prohibited pursuant to a restriction described in section**
28 **13 (3) of this 2025 Act that was in effect at the time the application was received.**

29 **(2) The department shall return all or a portion of the fees paid for pending applications**
30 **returned under subsection (1) of this section.**

31 **SECTION 16. Section 15 of this 2025 Act is repealed on January 2, 2050.**

32 **SECTION 17. ORS 537.211 is amended to read:**

33 537.211. (1) The approval of an application referred to in ORS 537.140 or 537.400 shall be set
34 forth in a water right permit issued by the Water Resources Department. The permit shall specify
35 the details of the authorized use and shall set forth any terms, limitations and conditions as the
36 department considers appropriate including but not limited to any applicable condition required
37 under ORS 537.289. A copy of the permit shall be filed as a public record in the department. The
38 permit shall be mailed to the applicant, and upon receipt of the permit the permittee may proceed
39 with the construction of the necessary works and may take all action required to apply the water
40 to the designated beneficial use and to perfect the proposed appropriation.

41 (2) Except as provided in subsection [(6)] (7) of this section, if an application under ORS 537.140
42 or 537.400 indicates that the applicant does not have written authorization or an easement permit-
43 ting access to nonowned land crossed by the proposed ditch, canal or other work, the department
44 may issue a final order approving the application if the approval includes a condition requiring the
45 applicant to obtain such written authorization, or easement or ownership of such land and to pro-

1 vide the department with a copy of the written authorization, easement or evidence of ownership.

2 (3) If an application referred to in ORS 537.140 or 537.400 is rejected, the department shall enter
3 a written order setting forth the reasons for the rejection. The applicant shall take no action toward
4 construction of the works or use of the water. The department shall mail a copy of the order to the
5 applicant.

6 (4) The holder of a water right permit may change the point of diversion, change the point of
7 appropriation, change the point of diversion to allow the appropriation of ground water or use the
8 water on land to which the right is not appurtenant if:

9 (a) The use of water on land to which the right is not appurtenant, the change of point of di-
10 version or the change in point of appropriation does not result in injury to an existing water right;

11 (b) For a proposed change in the place of use of the water, the land on which the water is to
12 be used is owned or controlled by the holder of the permit and is contiguous to the land to which
13 the permit is appurtenant;

14 (c) All other terms of the permit remain the same, including but not limited to the beneficial
15 use for which the water is used and the number of acres to which water is applied;

16 (d) Prior approval is obtained from the district if the water is transported or conveyed by an
17 irrigation district organized under ORS chapter 545, a drainage district organized under ORS chap-
18 ter 547, a water improvement district organized under ORS chapter 552, a water control district
19 organized under ORS chapter 553 or a district improvement company or a corporation organized
20 under ORS chapter 554;

21 (e) The holder of the permit provides written notice to the department at least 60 days before
22 making any changes to the lands, point of diversion or point of appropriation described in the per-
23 mit;

24 *[(f) The holder of the permit complies with the publication requirements of ORS 540.520 (5), if ap-
25 plicable;]*

26 *[(g)]* (f) Diversion is provided with a proper fish screen, if requested by the State Department
27 of Fish and Wildlife; and

28 *[(h)]* (g) For a request to transfer the point of diversion to allow the appropriation of ground
29 water, the proposed change meets the standards set forth in ORS 540.531 (2) or (3).

30 **(5) The Water Resources Department may deny a change in the point of appropriation**
31 **under subsection (4) of this section if the proposed point of appropriation is for a source of**
32 **ground water restricted under section 13 of this 2025 Act and the proposed use is subject to**
33 **the restrictions, unless the proposed point of appropriation is:**

34 **(a)(A) In a critical ground water area designated under ORS 537.730;**

35 **(B) In the same aquifer as the existing point of appropriation; and**

36 **(C) In the same portion of the critical ground water area as the existing point of appro-
37 priation;**

38 **(b) In an area for which a ground water bank that is established by law or by rule miti-
39 gates the effects of the use of ground water; or**

40 **(c) Related to the recovery of stored ground water under an artificial recharge or aquifer
41 storage and recovery project.**

42 *[(5)]* (6) Notwithstanding the requirements of subsection (4)(b) of this section, the holder of a
43 water right permit may change the place of use of all or any portion of water under the permit to
44 land that is not contiguous to the land to which the permit is appurtenant if:

45 (a) The change to noncontiguous land is in furtherance of mitigation or conservation efforts

1 undertaken for the purposes of benefiting a species listed as sensitive, threatened or endangered
2 under ORS 496.171 to 496.192 or the federal Endangered Species Act of 1973 (16 U.S.C. 1531 to 1544),
3 as determined by the listing agency; and

4 (b) All other requirements of subsection (4) of this section are met.

5 [(6)] (7) For an application made by or on behalf of a public corporation, the department may

17 proval or denial shall take into consideration all policy considerations for the appropriation of water

19 (b) The permit may be issued for exploration under ORS 517.702 to 517.740, but the permit shall
20 be conditioned on the applicant's compliance with the consolidated application process.

31 537.620. (1) The Water Resources Department shall accept all applications for permits submitted
32 under ORS 537.615 in proper form.

33 (2)(a) Within 15 days after receiving the application, the department shall determine whether
34 the application contains the information listed under ORS 537.615 (2) and is complete and not de-
35 fective, including the payment of all [*fees*] **applicable fees or fee amounts** required under ORS

34 537.230. (1) As used in this section, “undeveloped portion” means the difference between the

37 (a) June 29, 2005;

38 (b) The time specified in the permit to perfect the water right; or

39 (c) The time specified in the last-approved extension of time to perfect the water right.

40 (2) Except for a holder of a permit for municipal [*use*], **quasi-municipal, group domestic or**
41 **group domestic expanded uses**, the holder of a water right permit shall prosecute the construction
42 of any proposed irrigation or other work with reasonable diligence and complete the construction
43 within a reasonable time, as fixed in the permit by the Water Resources Department, not to exceed
44 [*five*] **seven** years from the date of approval.

45 (3) The holder of a permit for municipal use shall commence and complete the construction of

1 any proposed works within 20 years from the date on which a permit for municipal use is issued
2 under ORS 537.211. The construction must proceed with reasonable diligence and be completed
3 within the time specified in the permit, not to exceed 20 years. However, the department may order
4 and allow an extension of time to complete construction or to perfect a water right beyond the time

15 537.700. The certificate shall be recorded and transmitted to the applicant as provided in ORS

17 [(7)] (8) The department may not issue a water right certificate for municipal use under this
18 section if:

19 (a) An extension of time is required; and

20 (b) The order approving the extension of time has not become final by operation of law or on
21 appeal.

22 (8) The procedure for cancellation of a permit shall be as provided in ORS 537.260.

23 (9) Notwithstanding ORS 537.410, for purposes of obtaining a water right certificate under sub-
24 section [(6)] (7) of this section for a supplemental water right, the holder of a permit shall have a
25 facility capable of handling the full rate and duty of water requested from the supplemental source
26 and be otherwise ready, willing and able to use the amount of water requested, up to the amount

(1) Notwithstanding the process for applying for a water right permit established in ORS 537.150 to 537.230, a person may, pursuant to this section, apply to the Water Resources Department for a water right permit to use stored water. A person applying under this section for a water right permit to use stored water shall submit:

(a) A fee, in the amount required by ORS 536.050 for applications to appropriate stored water.

(b) A completed application for a secondary permit, in a form determined by the department, that contains the information required of applications under ORS 537.140 and 537.400 (1).

(c) Evidence that the proposed use of the stored water is one of the authorized uses under the water right permit, certificate or decree that allows the storage of water.

(2) If an applicant provides, to the satisfaction of the department, the fee and the information required by subsection (1) of this section, the department may, after public notice and a 30-day opportunity to submit comments on the application, issue a water right permit upon determining that no public interest issues as identified in ORS 537.170 (8) have been raised through the comments submitted.

(3) If the department determines that public interest issues have been identified, then the department shall treat the application under this section as an application under ORS 537.150 and perform the public interest review required by ORS 537.153 (2).

(4) At a minimum, a water right permit issued by the department for use of stored water under this section shall be conditioned to require:

(a) Fish screens and by-pass devices and fish passage as may be required by the State Department of Fish and Wildlife; and

(b) A measuring device at each point of diversion authorized under the water right permit.

(5) Within 10 days of issuing a water right permit under this section, the department shall provide notice of the permit issuance in the weekly **public** notice published by the department and to persons who have submitted comments pursuant to subsection (2) of this section.

SECTION 35. ORS 537.225 is amended to read:

537.225. (1) Notwithstanding ORS 537.220 and 537.635, except as provided in subsection (6) of this section, a record landowner holding a water right permit for an irrigation, nursery, temperature control, stock watering or agricultural water use that has a subsequent completion date may apply for assignment of all or part of the water right permit and for the issuance of a replacement water right permit that reflects that assignment. To obtain the assignment and replacement water right permits, the applicant shall submit an application to the Water Resources Department that includes, at a minimum:

(a) A map prepared by a certified water right examiner and meeting department mapping standards that identifies the authorized place of use, rate of use, any applicable acre-feet allowances, tax lots and points of diversion or appropriation;

(b) A copy of the deed showing that the applicant is an owner of the land;

(c) An affidavit certifying that the water right has not been conveyed or withheld;

(d) A statement by the applicant that the most recent water use under the permit, if any, has been exercised within relevant terms and conditions of the permit; and

(e)(A) Agreements to the assignment and to the request for the issuance of replacement water right permits submitted jointly or individually by all owners of the land to which the water right is

1 appurtenant; or

2 (B) An assignment of interest and request for the issuance of replacement water right permits
3 submitted by one or more of the owners of land to which the water right is appurtenant and infor-
4 mation identifying the names, addresses and proportionate interests for those owners not submitting
5 the assignment and request.

6 (2) In addition to the application contents described in subsection (1) of this section, the de-
7 partment may require that the applicant provide any additional information the department deems
8 appropriate to determining whether to approve the application.

9 (3) Upon receiving an application under subsection (1) of this section, the department shall de-
10 termine and notify the applicant of the fees payable under ORS 536.050 for processing the applica-
11 tion. Upon receipt of the appropriate processing fees, the department shall:

12 (a) Verify the address of each owner of the lands identified on the map contained in the appli-

2 **SECTION 36.** ORS 537.348 is amended to read:

3 537.348. (1) Any person may purchase or lease all or a portion of an existing water right or
4 accept a gift of all or a portion of an existing water right for conversion to an in-stream water right.
5 Any water right converted to an in-stream water right under this section shall retain the priority
6 date of the water right purchased, leased or received as a gift. At the request of the person the
7 Water Resources Commission shall issue a new certificate for the in-stream water right showing the
8 original priority date of the purchased, gifted or leased water right. Except as provided in sub-
9 sections (2) to (6) of this section, a person who transfers a water right by purchase, lease or gift
10 under this subsection shall comply with the requirements for the transfer of a water right under

13 may lease all or a portion of the existing water right for use as an in-stream water right for a

17 the number of times that the lease may be renewed.

4 on other water rights, the commission shall allocate 25 percent of the remaining conserved water
5 to the state and 75 percent to the applicant, unless the applicant proposes a higher allocation to the
6 state or more than 25 percent of the funds used to finance the conservation measures comes from
7 federal or state public sources. If more than 25 percent of the funds used to finance the conservation
8 measures comes from federal or state public sources and is not subject to repayment, the commission
9 shall allocate to the state a percentage equal to the percentage of public funds used to finance the
10 conservation measures and allocate to the applicant a percentage equal to the percentage of other
11 funds used to finance the conservation measures. If the commission determines that the water allo-
12 cated to the state is necessary to support in-stream flow purposes in accordance with ORS 537.332
13 to 537.360, the water shall be converted to an in-stream water right. If the water allocated to the
14 state is not necessary to support in-stream flow purposes, it shall revert to the public for appropri-
15 ation by the next user in priority. In no event, however, shall the applicant receive less than 25
16 percent of the remaining conserved water unless the applicant proposes a higher allocation to the
17 state.

18 (4) The commission shall notify the applicant and any other person requesting notice, of the
19 action the commission intends to take under subsection (3) of this section. Any person objecting to
20 the proposed allocation may file a protest requesting a contested case hearing before the commis-

22 (7) Within 14 days after receiving a notice of intent submitted pursuant to subsection (5) of this
23 section, the department shall, in the weekly **public** notice published by the department, give public
24 notice of the submission of the notice of intent.

25 (8) The Confederated Tribes of the Umatilla Indian Reservation and the City of Pendleton have
26 entered into an agreement addressing the development and use of the City of Pendleton's water
27 rights in the Umatilla River and the impact on tribal interests from such development. The agree-
28 ment includes implementation of the minimum streamflow in the main stem of the Umatilla River
29 resulting from the exercise by the City of Pendleton of its surface water right of the north fork of
30 the Umatilla River under this section. The City of Pendleton shall exercise such right consistent
31 with the agreement or successor agreements between the City of Pendleton and the tribes provided
32 in this subsection. In no event will the City of Pendleton exercise the right granted under this sec-
33 tion so as to reduce streamflows in the Umatilla River to be less than state in-stream water rights
34 for the Umatilla River existing as of January 1, 2002.

35 **SECTION 39.** ORS 540.524 is amended to read:

36 540.524. (1) Notwithstanding ORS 540.510 or 540.670, upon approval of an application submitted
37 to the Water Resources Department, the holder of both a primary water right originating from a
38 surface water source and a supplemental water right permit or certificate originating from a ground
39 water source may substitute the use of the supplemental water right for the primary water right.
40 A substitution may not be made under this subsection if the use of the supplemental water right

29 the applicant and to persons who have requested copies and paid the fee required under ORS 536.050
30 (1)(p). The department also shall give public notice of the proposed final order in the weekly **public**
31 notice published by the department.

32 (4) Any person may request standing for purposes of participating in any contested case pro-
33 ceeding on the proposed final order or for judicial review of a final order. A request for standing
34 shall be in writing and shall be accompanied by the fee established under ORS 536.050 (1)(n).

35 (5) Any person may submit a protest against a proposed final order. A protest shall be in writing
36 and shall include:

37 (a) The name, address and telephone number of the protestant;

38 (b) A description of the protestant's interest in the proposed final order and, if the protestant
39 claims to represent the public interest, a precise statement of the public interest represented;

40 (c) A detailed description of how the action proposed in the proposed final order would impair
41 or be detrimental to the protestant's interest;

42 (d) A detailed description of how the proposed final order is in error or deficient and how to
43 correct the alleged error or deficiency;

44 (e) Any citation of legal authority supporting the protest, if known; and

45 (f) The protest fee required under ORS 536.050 (1)(j).

1 (6) Requests for standing and protests on the proposed final order shall be submitted within 45
2 days after publication of the notice of the proposed final order in the weekly **public** notice published
3 by the department. Any person who asks to receive a copy of the department's final order shall
4 submit to the department the fee required under ORS 536.050 (1)(p), unless the person has previously
5 requested copies and paid the required fee.

6 (7) The Hydroelectric Application Review Team shall review any protest received and provide
7 to the Water Resources Director a recommended response to any protest received.

8 (8) Within 120 days after the close of the period for receiving protests and after consultation
9 with the Hydroelectric Application Review Team, the director shall:

10 (a) Issue a final order as provided under ORS 543A.130; or

11 (b) Schedule a contested case hearing if a protest has been submitted and if:

12 (A) Upon review of the issues, the director finds that there are significant disputes related to
13 the proposed reauthorization of the project; or

14 (B) Within 30 days after the close of the period for submitting protests, the applicant requests
15 a contested case hearing.

16 (9) At the request of the applicant, the department may extend the time periods set forth in
17 subsection (8) of this section for a reasonable period of time.

18 (10) If the application is for reauthorization of a water right for a federally licensed project, the
19 department may postpone the issuance of the final order until the Federal Energy Regulatory Com-
20 mission license is issued.

41 **ative date specified in section 48 of this 2025 Act, all of the duties, functions and powers**
42 **conferred on the department and the commission by the provisions of this 2025 Act.**
