

House Bill 3595

Sponsored by Representative TRAN; Representatives CHAICHI, DOBSON, NGUYEN D, NGUYEN H, SANCHEZ, Senators JAMA, PHAM K

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes the Lunar New Year a state holiday. (Flesch Readability Score: 86.7). Establishes the Lunar New Year as a legal holiday in this state.

A BILL FOR AN ACT

2 Relating to the Lunar New Year; amending ORS 187.010.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 187.010 is amended to read:

5 187.010. (1) The following days are legal holidays in this state:

6 (a) Each Sunday.

7 (b) New Year's Day on January 1.

8 (c) Martin Luther King, Jr.'s Birthday on the third Monday in January.

9 (d) Presidents Day, for the purpose of commemorating Presidents Washington and Lincoln, on
10 the third Monday in February.

11 **(e) The day of the Lunar New Year on the date corresponding with the second new moon**
12 **following the winter solstice, or the third new moon following the winter solstice when an**
13 **intercalary month intervenes.**

14 [(e)] **(f)** Memorial Day on the last Monday in May.

15 [(f)] **(g)** Juneteenth on June 19.

16 [(g)] **(h)** Independence Day on July 4.

17 [(h)] **(i)** Labor Day on the first Monday in September.

18 [(i)] **(j)** Veterans Day on November 11.

19 [(j)] **(k)** Thanksgiving Day on the fourth Thursday in November.

20 [(k)] **(L)** Christmas Day on December 25.

21 (2) Each time a holiday, other than Sunday, listed in subsection (1) of this section falls on Sun-
22 day, the succeeding Monday shall be a legal holiday. Each time a holiday listed in subsection (1)
23 of this section falls on Saturday, the preceding Friday shall be a legal holiday.

24 (3) Any act authorized, required or permitted to be performed on a holiday as designated in this
25 section may be performed on the next succeeding business day; and no liability or loss of rights of
26 any kind shall result from such delay.

27 (4) In enumerating legal holidays in subsection (1) of this section, the Legislative Assembly does
28 not intend to limit or otherwise affect public or private collective bargaining or collective bargain-
29 ing agreements.
