Sec. 4. Notwithstanding any other law limiting expenditures, the amount of [\$56,496,994]
\$58,996,994 is established for a six-year period beginning July 1, 2021, as the maximum limit for
payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but
excluding lottery funds and federal funds, collected or received by the Higher Education Coordi-
nating Commission, for expenditures of proceeds from state bonds issued for the benefit of a com-
munity college, pursuant to agreements between the commission and a community college.

SECTION 3. This 2025 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect on its passage.
