SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Says that a person may not get money or an item of value for helping another person get a veteran's benefit except as federal or state law allows. Gives a person a right to sue another person for breaking the law. Takes effect 91 days after the session ends. (Flesch Readability Score: 62.4).

Prohibits receiving compensation for performing certain services for or on behalf of an applicant or a claimant for a veteran's benefit except as provided in applicable federal or state law. Punishes a violation of the Act as an unlawful practice under the Unlawful Trade Practices Act.

Takes effect on the 91st day following adjournment sine die.

8 (C) Receive an excessive or unreasonable fee for a service or function described in this 9 paragraph.

(b) The prohibitions described in paragraph (a) of this subsection apply to applications 10 or claims for a veteran's benefit that is available under ORS chapter 407 or 408 to the extent 11 12 that an applicant or a claimant is eligible to receive a service or function described in paragraph (a)(A)(i) or (ii) of this subsection at no charge from the Department of Veterans' Af-13 fairs or from a person that performs the service or function under a delegation of authority 14 15 from the department. A person may not charge an excessive or unreasonable fee in return 16 for performing a service or function described in paragraph (a)(A)(i) or (ii) of this subsection even if the person may receive compensation for performing the service or function because 17 18 the service or function is not otherwise available to the applicant or claimant at no charge.

(3) A person that in return for compensation performs a service or function described in
subsection (2)(a)(A) of this section shall specify the terms and conditions of the transaction
in a written agreement signed by all parties to the agreement. The agreement must adhere
to the criteria set forth in 38 C.F.R. 14.636(g).

(4) A violation of this section is an unlawful practice under ORS 646.608.

24 <u>SECTION 2.</u> ORS 646.608, as amended by section 6, chapter 410, Oregon Laws 2023, is amended 25 to read:

646.608. (1) A person engages in an unlawful practice if in the course of the person's business,
 vocation or occupation the person does any of the following:

(a) Passes off real estate, goods or services as the real estate, goods or services of another.

(b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap proval, or certification of real estate, goods or services.

31 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-32 ciation with, or certification by, another.

(d) Uses deceptive representations or designations of geographic origin in connection with real
 estate, goods or services.

(e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have
or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the
person does not have.

(f) Represents that real estate or goods are original or new if the real estate or goods are de-teriorated, altered, reconditioned, reclaimed, used or secondhand.

(g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
or that real estate or goods are of a particular style or model, if the real estate, goods or services
are of another.

(h) Disparages the real estate, goods, services, property or business of a customer or anotherby false or misleading representations of fact.

1 (i) Advertises real estate, goods or services with intent not to provide the real estate, goods or 2 services as advertised, or with intent not to supply reasonably expectable public demand, unless the 3 advertisement discloses a limitation of quantity.

4 (j) Makes false or misleading representations of fact concerning the reasons for, existence of, 5 or amounts of price reductions.

6 (k) Makes false or misleading representations concerning credit availability or the nature of the 7 transaction or obligation incurred.

8 (L) Makes false or misleading representations relating to commissions or other compensation to 9 be paid in exchange for permitting real estate, goods or services to be used for model or demon-10 stration purposes or in exchange for submitting names of potential customers.

(m) Performs service on or dismantles any goods or real estate if the owner or apparent owner
 of the goods or real estate does not authorize the service or dismantling.

(n) Solicits potential customers by telephone or door to door as a seller unless the person pro vides the information required under ORS 646.611.

(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate, discount or other value is contingent upon an event occurring after the time the customer enters into the transaction.

(p) Makes any false or misleading statement about a prize, contest or promotion used to publi cize a product, business or service.

(q) Promises to deliver real estate, goods or services within a certain period of time with intent
not to deliver the real estate, goods or services as promised.

25 (r) Organizes or induces or attempts to induce membership in a pyramid club.

(s) Makes false or misleading representations of fact concerning the offering price of, or the
 person's cost for real estate, goods or services.

(t) Concurrent with tender or delivery of any real estate, goods or services, fails to disclose any
known material defect or material nonconformity.

30 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

(v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers,
 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situation.

34 (w) Manufactures mercury fever thermometers.

(x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
 law, or is:

37 (A) Prescribed by a person licensed under ORS chapter 677; and

(B) Supplied with instructions on the careful handling of the thermometer to avoid breakage andon the proper cleanup of mercury should breakage occur.

(y) Sells a thermostat that contains mercury, unless the thermostat is labeled in a manner to inform the purchaser that mercury is present in the thermostat and that the thermostat may not be disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the mercury does not become part of the solid waste stream or wastewater. For purposes of this paragraph, "thermostat" means a device commonly used to sense and, through electrical communication with heating, cooling or ventilation equipment, control room temperature.

(2) A representation under subsection (1) of this section or ORS 646.607 may be any manifesta tion of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.

(3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose cuting attorney need not prove competition between the parties or actual confusion or misunder standing.

(4) An action or suit may not be brought under subsection (1)(u) of this section unless the Attorney General has first established a rule in accordance with the provisions of ORS chapter 183
declaring the conduct to be unfair or deceptive in trade or commerce.

(5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or
suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attorney, relief is limited to an injunction, and the prevailing party may be awarded reasonable attorney
fees.

30 <u>SECTION 3.</u> This 2025 Act takes effect on the 91st day after the date on which the 2025 31 regular session of the Eighty-third Legislative Assembly adjourns sine die.
