Senate Bill 388

Sponsored by Senator HAYDEN, Representative JAVADI; Senator BONHAM (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act tells the Oregon Health Policy Board to report on the success of Oregon's coordinated health care model. The Act makes changes to the membership, powers and duties of the board. (Flesch Readability Score: 61.0).

Requires the Oregon Health Policy Board to produce and provide to the interim committees of the Legislative Assembly related to health by December 31, 2026, a comprehensive report regarding the success in achieving the aims of the Oregon Integrated and Coordinated Health Care Delivery System.

Modifies the membership of the board and specifies duties of the chairperson of the board. Increases oversight and supervision responsibilities of the board over the Oregon Health Authority. Requires the board to submit an agency request budget for the board. Puts the Health Evidence Review Commission under the auspices of the board.

9 413.033. (1) The Oregon Health Authority is under the supervision and control of a director, who
10 is responsible for performing the duties, functions and powers of the authority.

(2) The Governor, in consultation with the Oregon Health Policy Board, shall appoint the
 Director of the Oregon Health Authority, who holds office at the pleasure of the Governor. The
 appointment of the director is subject to confirmation by the Senate in the manner provided by ORS
 171.562 and 171.565.

(3) In addition to the procurement authority granted by ORS 279A.050 (6)(b) and except as provided in ORS 279A.050 (7), the director has all powers necessary to effectively and expeditiously
carry out the duties, functions and powers vested in the authority by ORS 413.032.

(4) The director shall have the power to obtain such other services as the director considers necessary or desirable, including participation in organizations of state insurance supervisory officials and appointment of advisory committees. A member of an advisory committee so appointed may not receive compensation for services as a member, but, subject to any other applicable law regulating travel and other expenses of state officers, shall receive actual and necessary travel and other expenses incurred in performing official duties.

414.570. (1) There is established the Oregon Integrated and Coordinated Health Care Delivery 2930 System. The goals of the system [shall consist of state policies and actions that] are to make coor-31 dinated care organizations accountable for care management and provision of integrated and coor-32dinated health care for each organization's members, primarily managed within fixed global budgets, by providing care so that efficiency and quality improvements reduce medical cost inflation while 33 34 supporting the development of regional and community accountability for the health of the residents 35of each region and community, and while maintaining regulatory controls necessary to ensure quality and affordable health care for all Oregonians. 36
