

# Senate Bill 5533

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act creates an agency budget. (Flesch Readability Score: 73.8).

Appropriates moneys from the General Fund to the Oregon Military Department for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and federal service agreement reimbursements, but excluding lottery funds and other federal funds, collected or received by the department for certain purposes.

Limits biennial expenditures by the department from federal funds for certain purposes.

Declares an emergency, effective July 1, 2025.

## A BILL FOR AN ACT

2 Relating to the financial administration of the Oregon Military Department; and declaring an  
3 emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. There are appropriated to the Oregon Military Department, for the biennium**  
6 **beginning July 1, 2025, out of the General Fund, the following amounts, for the following**  
7 **purposes:**

- 8 (1) **Administration..... \$ 17,526,965**
- 9 (2) **Operations..... \$ 18,891,971**
- 10 (3) **Community support ..... \$ 1,452,288**
- 11 (4) **Debt service ..... \$ 14,870,532**

12 **SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts**  
13 **are established for the biennium beginning July 1, 2025, as the maximum limits for payment**  
14 **of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and re-**  
15 **imbursements from federal service agreements, but excluding lottery funds and federal funds**  
16 **not described in this section, collected or received by the Oregon Military Department, for**  
17 **the following purposes:**

- 18 (1) **Administration..... \$ 8,876,071**
- 19 (2) **Operations..... \$ 8,553,409**
- 20 (3) **Community support ..... \$ 12,160,176**

21 **SECTION 3. Notwithstanding any other law limiting expenditures, the following amounts**  
22 **are established for the biennium beginning July 1, 2025, as the maximum limits for payment**  
23 **of expenses from federal funds, other than those described in section 2 of this 2025 Act,**  
24 **collected or received by the Oregon Military Department, for the following purposes:**

- 25 (1) **Operations..... \$145,760,579**
- 26 (2) **Community support ..... \$ 23,676,775**

1       **(3) Capital improvement..... \$ 5,813,288**

2       **SECTION 4. This 2025 Act being necessary for the immediate preservation of the public**  
3 **peace, health and safety, an emergency is declared to exist, and this 2025 Act takes effect**  
4 **July 1, 2025.**
