Senate Bill 605

Sponsored by Senator CAMPOS, Representative SOSA; Senators FREDERICK, PATTERSON, Representatives CHAICHI, GOMBERG, NELSON, PHAM H (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Stops people who provide medical services to patients from telling a credit bureau that a patient owes a debt, or the amount of the debt. Allows a person to sue a person who breaks this law. (Flesch Readability Score: 68.7).

Prohibits medical service providers from reporting the amount or existence of medical debt to a consumer reporting agency. Prohibits a consumer reporting agency from including in a consumer report an item that the consumer reporting agency knows or should know is medical debt. Punishes a violation of the Act as an unlawful practice under the Unlawful Trade Practices Act.

except that the interest may not be less than two percent per annum or more than five percent perannum.

4 (b) Upon entry of a judgment against a patient described in paragraph (a) of this subsection, a 5 hospital, nonprofit hospital-affiliated clinic or other debt collector may increase the interest charged 6 on a medical debt up to the amount specified in ORS 82.010.

7 (9) A hospital, **nonprofit** hospital-affiliated clinic or other debt collector may not attempt to 8 collect a medical debt from a patient's child or other family member who is not financially respon-9 sible for the debt under ORS chapter 108.

(11)(a) A medical services provider that operates or engages in business in this state may
 not:

(A) Enter into a contract that creates medical debt unless the contract includes a
prominent and conspicuous notice that reads, in substance, "The person that holds any debt
you owe for medical services under this agreement may not report the debt to a credit bureau or consumer reporting agency. In addition to subjecting the person to other penalties
under law, reporting the debt may result in the debt becoming void and uncollectible."

(B) Report to a consumer reporting agency the amount or existence of any medical debt
or medical debt that a resident of this state owes to the medical services provider or that a
debt buyer has purchased from a medical services provider.

(b) A violation of paragraph (a) of this subsection is an unlawful practice under ORS 646.608 for which a person may bring an action under ORS 646.638 and obtain an order or judgment that, in addition to providing other relief available under ORS 646.638, voids and renders uncollectible the medical debt.

(12) A consumer reporting agency may not include in a consumer report an item that the
 consumer reporting agency knows or reasonably should know is medical debt. A violation of
 this subsection is an unlawful practice under ORS 646.608.
