Senate Bill 764

Sponsored by Senator NASH, Representative LEVY B (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes an interest in a family-owned business not taxed by the estate tax. (Flesch Readability Score: 61.8). Allows an exclusion from a taxable estate for the value of the interest in a family-owned busi-

ness. Applies to estates of decedents who die on or after January 1, 2026. Takes effect on the 91st day following adjournment sine die.

(5) In the case of a resident decedent owning, on the date of the decedent's death, real property 36 37 located outside Oregon or tangible personal property located outside Oregon, the tax imposed under this section shall be the amount determined under subsection (4) of this section multiplied by a ratio. 38 The numerator of the ratio shall be the sum of the value of the decedent's real property located in 39 Oregon, tangible personal property located in Oregon and intangible personal property. The numer-40 ator may not include any intangible personal property subject to a tax imposed, as a result of the 41 death of the decedent, by another state or country. The denominator of the ratio shall be the total 42 value of the decedent's gross estate. 43

(6) In the case of a nonresident decedent owning, on the date of the decedent's death, real
property located in Oregon or tangible personal property located in Oregon, the tax imposed under

2 The numerator of the ratio shall be the sum of the value of the decedent's real property located in

5 (7) Payment, in whole or in part, of estate taxes from funds of an estate or trust on any benefit 6 subject to tax under ORS 118.005 to 118.540 is not to be considered a further taxable benefit, when 7 such payment is directed by the decedent's will or by a trust agreement.

8 (8)(a) If the federal taxable estate is determined by making an election under section 2031(c), 9 2032, 2032A, 2056 or 2056A of the Internal Revenue Code or another provision of the Internal Re-10 venue Code, or if a federal estate tax return is not required under the Internal Revenue Code, an 11 executor may make separate elections for state estate tax purposes under that same provision.

(b) An executor may make elections under ORS 118.013, 118.140 and 118.145 and section 2 of
this 2025 Act and section 2056 of the Internal Revenue Code for state estate tax purposes.

14 (c) Elections described in this subsection are irrevocable.

15 <u>SECTION 4.</u> Section 2 of this 2025 Act and the amendments to ORS 118.010 by section 3
16 of this 2025 Act apply to estates of decedents who die on or after January 1, 2026.

SECTION 5. This 2025 Act takes effect on the 91st day after the date on which the 2025
regular session of the Eighty-third Legislative Assembly adjourns sine die.
