

Senate Bill 806

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Tina Kotek for Oregon Military Department)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: Allows the Civil Air Patrol to use ORNG facilities at no cost. (Flesch Readability Score: 67.7).

Allows the Civil Air Patrol to use Oregon National Guard armories and facilities for official business at no cost.

A BILL FOR AN ACT

2 Relating to the use of armories; amending ORS 396.540.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 396.540 is amended to read:

5 396.540. (1) Armories may be used by members and units of the organized militia in accordance
6 with regulations issued pursuant to this chapter and ORS chapters 398 and 399.

7 (2) Armories may be used by any veterans' organizations and their auxiliaries located in the
8 community where the armory is located, provided such use will not interfere with the use of the
9 facilities by the organized militia or result in risk to federal or state property, and provided that the
10 organization makes a written request therefor and pays for heat, lights, janitor service and other
11 expense required by such use.

12 (3) Armories may be used by any federal, state, county [*and*] **or** municipal bureau, agency or
13 department or by the Armed Forces of the United States, including the Coast Guard, or by the re-
14 serve components thereof for their official business, provided that such use does not interfere with
15 the members and units of the organized militia stationed in such armory, and provided that such use
16 is approved by the officer in charge thereof and by military superiors as prescribed by military de-
17 partment regulations issued pursuant to this chapter and ORS chapters 398 and 399.

18 (4) Armories may be rented for use by a person, firm, association or corporation, not specified
19 elsewhere in this section, for such purposes and upon such terms as may be approved by the officer
20 in charge of the armory and by military superiors as prescribed by military department regulations
21 issued pursuant to this chapter and ORS chapters 398 and 399 and provided that such use will not,
22 and only so long as such use does not, interfere with the use of the armory by the members and
23 units of the organized militia stationed therein.

24 (5) The Oregon National Guard Association described in ORS 399.460 may use an armory or
25 other military facility at no cost, provided that the use is approved by the officer in charge and by
26 military superiors as prescribed by military department regulations issued pursuant to this chapter
27 and ORS chapters 398 and 399.

28 **(6) The Civil Air Patrol, chartered under 36 U.S.C. 40301, or any wing thereof, may use**

1 **an armory or other military facility for their official business at no cost, provided that the**
2 **use does not interfere with the members and units of the organized militia stationed in the**

5 **to this chapter and ORS chapters 398 and 399.**
