SUMMARY

10 **Be It Enacted by the People of the State of Oregon:**

11 **SECTION 1.** ORS 30.847 is amended to read:

12 30.847. (1) A person or group of persons is subject to an action described in subsection (2) or (3)
13 of this section for engaging in paramilitary activity if the person or group of persons knowingly,
14 while acting as part of a private paramilitary organization or on behalf of or in furtherance of any
15 objective of a private paramilitary organization:

16 (a) While armed with a deadly weapon, publicly patrols or drills;

17 (b) While armed with a dangerous or deadly weapon:

18 (A) Publicly engages in techniques capable of causing physical injury or death;

19 (B) Substantially disrupts governmental operations or a government proceeding;

20 (C) Assumes, exercises or asserts, without legal authorization, the functions, powers or duties

21 of:

22 (i) A law enforcement officer, including any sheriff, police officer, marshal or other peace officer;

23 or

24 (ii) Any local, city, county, state or federal official; or

25 (D) Interferes with another person and thereby:

26 (i) Prevents the other person, or attempts to prevent the other person, from engaging in conduct

1 in which the other person has a legal right to engage; or

2 (ii) Causes the other person, or attempts to cause the other person, to engage in conduct from
3 which the other person has a legal right to abstain; or

4 (c) Trains to engage in any activity described in paragraph (a) or (b) of this subsection.

5 (2)(a) If the Attorney General has reasonable cause to believe that a person or group of persons
6 has engaged in, or is about to engage in, paramilitary activity as described in subsection (1) of this
7 section, the Attorney General may bring a civil action in the name of the State of Oregon for
8 injunctive relief in Marion County Circuit Court or any other circuit court of this state.

9 (b)(A) If it appears to the Attorney General that a person has possession, custody or control of
10 any information, document or other material that is relevant to an investigation of paramilitary
11 activity as described in subsection (1) of this section, or that could lead to the discovery of relevant
12 information in an investigation of paramilitary activity as described in subsection (1) of this section,
13 the Attorney General may cause an investigative demand to be served upon the person. The in-
14 vestigative demand may require the person:

15 (i) To appear and testify under oath at the time and place stated in the investigative demand;

16 (ii) To answer written interrogatories; or

17 (iii) To produce relevant documentary material or physical evidence for examination at the time
18 and place stated in the investigative demand.

19 (B) An investigative demand under this paragraph shall be served in the manner provided by
20 ORS 646.622 and may be enforced in the manner provided by ORS 646.626.

21 (c) When conducting investigations under this section, the Attorney General may not demand,
22 collect or maintain information about the political, religious or social views, associations or activ-
23 ities of any individual, group, association, organization, corporation, business or partnership unless
24 the information directly relates to an investigation into, and there are reasonable grounds to suspect
25 that the subject of the information is involved in, paramilitary activity as described in subsection
26 (1) of this section.

27 (3)(a) A person injured as a result of paramilitary activity as described in subsection (1) of this
28 section may bring a civil action, individually or jointly with other aggrieved persons, in the appro-
29 priate court for relief against the person or persons who engaged in the paramilitary activity.

30 (b) A plaintiff who prevails in a claim under this subsection may recover:

31 (A) Economic or noneconomic damages, as those terms are defined in ORS 31.705;

32 (B) Injunctive relief;

33 (C) Reasonable attorney fees; and

34 (D) Any other appropriate equitable relief.

35 (4) This section does not apply to:

36 *[(a) The Armed Forces of the United States or the National Guard, as those terms are defined in*
37 *10 U.S.C. 101, or any regularly organized state militia or unorganized or reserve militia called into*
38 *service by a state or the United States, including a defense force authorized under 32 U.S.C. 109(c).]*

39 **(a) The Armed Forces or the National Guard, as those terms are defined in 10 U.S.C. 101,**
40 **or the National Guard, as described in ORS 396.105, called into service by a state or by the**
41 **United States.**

42 (b) A group of individuals that associates as a military organization solely for historical pur-
43 poses or fictional performances, or that parades in public as part of a bona fide veterans' organiza-
44 tion, so long as the group does not carry or use ammunition or explosives.

45 (c) Students in an education institution authorized by a state or federal government to teach

1 military science as a prescribed part of the course of instruction, when under the supervision of a
2 military instructor.

3 (d) Members of an organization that is authorized under state or federal law to provide
4 paramilitary, law enforcement or security services training or to engage in paramilitary activity or
5 the provision of law enforcement or security services, when performing the functions authorized by
6 law and, in the case of paramilitary activity and law enforcement services, when under the direction
7 and control of a governmental authority.

8 (e) Any lawful activity of the State Department of Fish and Wildlife.

9 (f) Any activity intended to teach or practice self-defense or self-defense techniques, such as
10 karate clubs or self-defense clinics, and similar lawful activity.

11 (g) Any facility, program or lawful activity related to firearms instruction and training intended
12 to teach the safe handling and use of firearms, or any other lawful sports or activities related to the
13 individual recreational use or possession of firearms, including but not limited to hunting activities,
14 target shooting, self-defense, firearms collection or any organized activity, including but not limited
15 to any hunting club, rifle club, rifle range or shooting range, which does not include a criminal
16 conspiracy as defined in ORS 161.450 or the knowledge of or the intent to cause or further acts of
17 physical violence or damage to persons or property.

18 (5) As used in this section:

19 (a) "Dangerous weapon" has the meaning given that term in ORS 161.015.

20 (b) "Deadly weapon" has the meaning given that term in ORS 161.015.

21 (c) "Private paramilitary organization" means any group of three or more persons associating
22 under a command structure for the purpose of functioning in public or training to function in public
23 as a combat, combat support, law enforcement or security services unit.

24 (d) "State" means the District of Columbia or a state, commonwealth, territory or possession of
25 the United States.

26 **SECTION 2.** ORS 90.472 is amended to read:

27 90.472. (1) As used in this section, "state service member" means a member of the [*organized*
28 *militia*] **National Guard as described in ORS 396.105** who is called into active service of the state
29 by the Governor under ORS 399.065 (1) for 90 or more consecutive days.

30 (2) A tenant may terminate a rental agreement upon written notice if the tenant provides the
31 landlord with proof of official orders showing that the tenant is a state service member.

32 (3) A termination of a rental agreement under this section is effective the earlier of:

33 (a) Thirty days after the date the next rental payment is due; or

34 (b) On the last day of the month after the month in which written notice is given.

35 (4) Notwithstanding ORS 90.300 (7)(a)(A) and 90.430, a tenant who terminates a lease under
36 subsection (2) of this section is not:

37 (a) Subject to a penalty, fee, charge or loss of deposit because of the termination; or

38 (b) Liable for any rent beyond the effective date of the termination as determined under sub-
39 section (3) of this section.

40 **SECTION 3.** ORS 105.111 is amended to read:

41 105.111. (1) As used in this section, "state service member" means a member of the [*organized*
42 *militia*] **National Guard as described in ORS 396.105** who is called into active service of the state
43 by the Governor under ORS 399.065 (1) for 30 or more consecutive days.

44 (2) In an action pursuant to ORS 105.110, the court may stay the eviction of the defendant for
45 up to 90 days if:

1 (a) The defendant is a state service member;

2 (b) The agreed-upon rent does not exceed \$1,200 per month; and

3 (c) The premises are occupied chiefly for dwelling purposes by the spouse, children or other
4 dependents of the defendant.

5 (3) If the defendant requests a stay of the eviction for up to 90 days and the defendant can prove
6 that the ability of the defendant to pay the agreed-upon rent is materially affected by being called
7 into active service, the court may grant the stay of the eviction.

8 **SECTION 4.** ORS 109.056 is amended to read:

9 109.056. (1) Except as provided in subsection (2) or (3) of this section, a parent or guardian of
10 a minor or incapacitated person, by a properly executed power of attorney, may delegate to another
11 person, for a period not exceeding six months, any of the powers of the parent or guardian regarding
12 care, custody or property of the minor child or ward, except the power to consent to marriage or
13 adoption of a minor ward.

14 (2) A parent or guardian of a minor child may delegate the powers designated in subsection (1)
15 of this section to a school administrator for a period not exceeding 12 months.

16 (3)(a) As used in this subsection, "servicemember-parent" means a parent or guardian:

17 (A) Who is:

18 (i) A member of the [*organized militia of this state*] **National Guard as described in ORS**
19 **396.105;**

20 (ii) A member of the Reserves of the Army, Navy, Air Force, Marine Corps or Coast Guard of
21 the United States;

22 (iii) A member of the commissioned corps of the National Oceanic and Atmospheric Adminis-
23 tration; or

24 (iv) A member of the Public Health Service of the United States Department of Health and Hu-
25 man Services detailed by proper authority for duty with the Army or Navy of the United States; and

26 (B) Who is required to enter and serve in the active military service of the United States under
27 a call or order by the President of the United States or to serve on state active duty as defined in
28 the Oregon Code of Military Justice.

29 (b) A servicemember-parent of a minor child may delegate the powers designated in subsection
30 (1) of this section for a period not exceeding the term of active duty service plus 30 days.

31 (c) Except as provided in paragraph (d) of this subsection, if the minor child is living with the
32 child's other parent, a delegation under paragraph (b) of this subsection must be to the parent with
33 whom the minor child is living unless a court finds that the delegation would not be in the best
34 interests of the minor child.

35 (d) When the servicemember-parent has joint custody of the minor child with the child's other
36 parent or another individual, and the servicemember-parent is married to an individual other than
37 the child's other parent, the servicemember-parent may delegate the powers designated in subsection
38 (1) of this section to the spouse of the servicemember-parent for a period not exceeding the term of
39 active duty service plus 30 days, unless a court finds that the delegation would not be in the best
40 interests of the minor child.

41 **SECTION 5.** ORS 166.660 is amended to read:

42 166.660. (1) A person commits the crime of unlawful paramilitary activity if the person:

43 (a) Exhibits, displays or demonstrates to another person the use, application or making of any
44 firearm, explosive or incendiary device or any technique capable of causing injury or death to per-
45 sons and intends or knows that such firearm, explosive or incendiary device or technique will be

1 unlawfully employed for use in a civil disorder; or

2 (b) Assembles with one or more other persons for the purpose of training with, practicing with
3 or being instructed in the use of any firearm, explosive or incendiary device or technique capable
4 of causing injury or death to persons with the intent to unlawfully employ such firearm, explosive
5 or incendiary device or technique in a civil disorder.

6 (2)(a) Nothing in this section makes unlawful any act of any law enforcement officer performed
7 in the otherwise lawful performance of the officer's official duties.

8 (b) Nothing in this section makes unlawful any activity of the State Department of Fish and
9 Wildlife, or any activity intended to teach or practice self-defense or self-defense techniques, such
10 as karate clubs or self-defense clinics, and similar lawful activity, or any facility, program or lawful
11 activity related to firearms instruction and training intended to teach the safe handling and use of
12 firearms, or any other lawful sports or activities related to the individual recreational use or pos-
13 session of firearms, including but not limited to hunting activities, target shooting, self-defense,
14 firearms collection or any organized activity including, but not limited to any hunting club, rifle
15 club, rifle range or shooting range which does not include a conspiracy as defined in ORS 161.450
16 or the knowledge of or the intent to cause or further a civil disorder.

17 (3) Unlawful paramilitary activity is a Class C felony.

18 (4) As used in this section:

19 (a) "Civil disorder" means acts of physical violence by assemblages of three or more persons
20 which cause damage or injury, or immediate danger thereof, to the person or property of any other
21 individual.

22 (b) "Firearm" has the meaning given that term in ORS 166.210.

23 (c) "Explosive" means a chemical compound, mixture or device that is commonly used or in-
24 tended for the purpose of producing a chemical reaction resulting in a substantially instantaneous
25 release of gas and heat, including but not limited to dynamite, blasting powder, nitroglycerin,
26 blasting caps and nitrojelly, but excluding fireworks as defined in ORS 480.111, black powder,
27 smokeless powder, small arms ammunition and small arms ammunition primers.

28 (d) "Law enforcement officer" means any duly constituted police officer of the United States,
29 any state, any political subdivision of a state or the District of Columbia, and also includes members
30 of the military reserve forces or National Guard as defined in **10 U.S.C. 101(c)** [*10 U.S.C. 101 (9),*
31 *members of the organized militia of any state or territory of the United States, the Commonwealth of*
32 *Puerto Rico or the District of Columbia not included within the definition of National Guard as defined*
33 *by 10 U.S.C. 101 (9)*], members of the Armed Forces of the United States and such persons as are
34 defined in ORS 161.015 (4) when in the performance of official duties.

35 **SECTION 6.** ORS 181A.893 is amended to read:

36 181A.893. (1) It is unlawful:

37 (a) For an entity that employs private security providers to use a name that implies that the
38 entity is, or is affiliated with, an existing law enforcement unit or public safety agency as defined
39 in ORS 181A.355, the [*organized militia*] **National Guard** as described in ORS 396.105, the Armed
40 Forces of the United States, a federal law enforcement agency or a federal intelligence agency.

41 (b) For a private security provider or an entity that employs private security providers to pos-
42 sess or use in the scope of employment equipment, vehicles, uniforms or titles that imply that the
43 provider or entity is affiliated with a public or private safety agency as defined in ORS 181A.355.

44 (2) The Board on Public Safety Standards and Training, in consultation with the Department of
45 Public Safety Standards and Training, shall adopt rules related to the requirements of subsection (1)

1 of this section.

2 (3) This section does not apply to special campus security providers commissioned under ORS
3 352.118 or private security providers on campuses of institutions of higher education regulated under
4 ORS 181A.972.

5 **SECTION 7.** ORS 307.286 is amended to read:

6 307.286. (1) Upon compliance with ORS 307.289, there shall be exempt from taxation up to
7 \$60,000 of the assessed value of the homestead of any resident of this state who is:

8 (a) Serving in the Oregon National Guard, military reserve forces or [*organized militia*] **National**
9 **Guard** of any other state or territory of the United States; and

10 (b) Performing service:

11 (A) Under Title 10 of the United States Code or pursuant to a deployment made under the au-
12 thority of the Emergency Management Assistance Compact; and

13 (B) For more than 178 consecutive days, if at least one of the days falls within the tax year for
14 which the exemption is claimed.

15 (2) For each tax year beginning on or after July 1, 2006, the amount of the exemption allowed
16 under subsection (1) of this section shall equal 103 percent of the amount of the exemption for the
17 prior tax year.

18 (3) As used in this section, “homestead” means residential property that is owned by a person
19 described in subsection (1) of this section and that, but for military service, would be occupied as
20 a residence by the person.

21 **SECTION 8.** ORS 314.091 is amended to read:

22 314.091. (1) This section applies to a taxpayer who is a member of the Armed Forces of the
23 United States who is on active duty for 90 consecutive days or more or who is a member of the
24 Oregon National Guard, the military reserve forces or the [*organized militia*] **National Guard** of any
25 other state or territory of the United States who performs service in a status under Title 10 of the
26 United States Code for a period of 90 consecutive days or more.

27 (2) If a taxpayer described in subsection (1) of this section has an unpaid tax liability for a tax
28 due under ORS chapter 316 that arose during a period in which service is performed as described
29 in subsection (1) of this section, the unpaid tax liability, and all interest and penalties associated
30 with the unpaid tax liability, shall be held in abeyance until a date that is six months after the date
31 that the taxpayer’s active duty or status under Title 10 of the United States Code ceases.

32 **SECTION 9.** ORS 396.005 is amended to read:

33 396.005. As used in this chapter and ORS chapter 399:

34 (1) “Active service” includes:

35 (a) Active service of the state.

36 (b) Service performed on full-time duty status under Title 10 of the United States Code.

37 (c) Service performed on full-time duty status under Title 32 of the United States Code when
38 performed under an authority other than the Governor.

39 (2) “Active service of the state” means service performed while on full-time duty status for
40 training, operational duty or other service of the [*organized militia*] **National Guard** under the au-
41 thority of the Governor, whether paid from state funds or federal funds under Title 32 of the United
42 States Code.

43 (3) “State active duty” means full-time duty status for training, operational duty or other ser-
44 vice, other than inactive duty, of the [*organized militia*] **National Guard** performed under the au-
45 thority of the Governor and paid from state funds.

1 **SECTION 10.** ORS 396.015 is amended to read:

2 396.015. (1) The terms [*“unorganized militia,” “all or any part of the organized militia,” and “or-*
3 *ganized militia or any force thereof,”*] **“National Guard,” “all or any part of the National**
4 **Guard” and “National Guard or any part thereof,”** whenever used in this chapter and ORS
5 chapters 398 and 399, unless a different meaning is plainly required by the context, shall be deemed
6 to include any unit, command, component, element, headquarters, staff or cadre thereof as well as
7 any member thereof.

8 **(2) The term “National Guard” whenever used in this chapter and ORS chapters 398 and**
9 **399, unless a different meaning is plainly required by the context, shall mean “National**
10 **Guard” as that term is described in ORS 396.105.**

11 **SECTION 11.** ORS 396.025 is amended to read:

12 396.025. (1) It is the intent of this chapter and ORS chapters 398 and 399 to provide for the
13 Oregon Military Department and for the [*state Militia*] **National Guard of this state** and for the
14 organization, equipment, regulation and use thereof.

15 (2) All matters relating to the organization, discipline and government of the [*organized*
16 *militia*] **National Guard**, not otherwise provided for in this chapter and ORS chapters 398 and 399
17 or in military department regulations issued pursuant thereto, shall be decided by the customs and
18 usage of the appropriate force or forces of the Armed Forces of the United States.

19 **SECTION 12.** ORS 396.105 is amended to read:

20 396.105. [(1) *The militia of the state shall be divided into the organized militia and the unorganized*
21 *militia.*]

22 [(2) *The organized militia shall be composed of the Oregon Army National Guard and the Oregon*
23 *Air National Guard, which forces together with an inactive National Guard shall comprise the Oregon*
24 *National Guard; the Oregon Civil Defense Force whenever such a force shall be duly organized; and*
25 *such additional forces as may be created by the Governor.*]

26 [(3) *The unorganized militia shall consist of all able-bodied residents of the state between the ages*
27 *of 18 and 45 who are not serving in any force of the organized militia or who are not on the state re-*
28 *tired list and who are or who have declared their intention to become citizens of the United States;*
29 *subject, however, to such exemptions from military duty as are created by the laws of the United*
30 *States.*]

31 **The National Guard of this state shall be composed of:**

32 **(1) The Oregon Army National Guard and the Oregon Air National Guard, whose forces**
33 **together with an inactive National Guard shall comprise the Oregon National Guard;**

34 **(2) The Oregon Civil Defense Force whenever such a force shall be duly organized; and**

35 **(3) Such additional forces as may be created by the Governor.**

36 **SECTION 13.** ORS 396.115 is amended to read:

37 396.115. The following persons shall be exempt from [*militia*] **National Guard** service:

38 (1) Persons exempt from [*militia*] **National Guard** service by the laws of the United States.

39 (2) Regular or duly ordained ministers of religion, or duly elected church officials regularly
40 conducting church services, or those recognized by their church as devoting the major portion of
41 their time to the practice of religion.

42 (3) Students preparing for the ministry in accredited theological or divinity schools.

43 (4) Persons whose religious tenets or conscientious scruples forbid them to bear arms.

44 **SECTION 14.** ORS 396.120 is amended to read:

45 396.120. (1) The following persons of the [*organized militia*] **National Guard** may administer

1 oaths for the purposes of military administration, including military justice, and affidavits may be
2 taken for those purposes before those persons who shall have the general powers of a notary public:

3 (a) The State Judge Advocate and all Assistant State Judge Advocates.

4 (b) All law specialists.

5 (c) All summary courts-martial.

6 (d) All adjutants, assistant adjutants, acting adjutants, personnel adjutants and other persons
7 of equivalent responsibility who may be assigned a different position title by their respective force.

8 (e) All legal officers.

9 (f) The president, law officer, trial counsel and assistant trial counsel for all general and special
10 courts-martial.

11 (g) The president and the counsel for the court of any court of inquiry.

12 (h) All officers designated to take a deposition.

13 (i) All persons detailed to conduct an investigation.

14 (j) All other persons designated by military department regulations issued by the Governor.

15 (2) The signature without seal of any such person, together with the title of office, is prima facie
16 evidence of authority.

17 **SECTION 15.** ORS 396.125 is amended to read:

18 396.125. (1) The Governor of this state, by virtue of office, is the Commander in Chief of the
19 *[militia]* **National Guard** of this state, and may issue military regulations for the governance of the
20 *[militia]* **National Guard**. Military regulations issued by the Governor shall have the full force and
21 effect of law. To the extent a regulation issued under this section conflicts with any other law of
22 this state, the regulation shall supersede the conflicting law.

23 (2) In issuing regulations under this section, the Governor may give consideration to the laws
24 and regulations of the United States relating to the organization, discipline and training of the
25 *[militia]* **National Guard**, to the provisions of this chapter and ORS chapters 398 and 399 and to the
26 laws and regulations governing the United States Army and United States Air Force.

27 (3) The Governor may delegate to the Adjutant General authority to issue the regulations de-
28 scribed in this section for the governance of the *[militia]* **National Guard**.

29 **SECTION 16.** ORS 396.128 is amended to read:

30 396.128. (1) If the Adjutant General issues regulations for the governance of the *[organized*
31 *militia]* **National Guard** as provided under ORS 396.125, the Adjutant General shall specify in the
32 regulations a date on which the regulations become operative for the purposes of all conduct subject
33 to the regulations occurring on or after the specified date. To the extent a regulation issued under
34 this section conflicts with a provision of this chapter, ORS chapter 398 or 399 or any other law of
35 this state, the regulation shall supersede the conflicting provision or law.

36 (2) Regulations issued by the Adjutant General under this section and ORS 396.125 that have
37 become operative shall be known and cited as “the Oregon Code of Military Justice.”

38 **SECTION 16a.** ORS 396.128 is added to and made a part of ORS chapter 396.

39 **SECTION 17.** ORS 396.130 is amended to read:

40 396.130. (1) The Governor may order the *[organized militia]* **National Guard** or any part thereof
41 to serve outside the borders of this state or of the United States in order to perform military duty
42 of every description and to participate in parades, reviews, cruises, conferences, encampments, ma-
43 neuvers or other training, and to participate in small arms and other military competitions and to
44 attend service schools.

45 (2) The provisions of this chapter and ORS chapters 398 and 399 shall apply to the members of

1 the *[organized militia]* **National Guard** while serving without the state and while going to and re-
 2 turning from such service without the state in like manner and to the same extent as while serving
 3 within the state.

4 **SECTION 18.** ORS 396.135 is amended to read:

5 396.135. When the *[militia]* **National Guard** of the state or any part thereof is called forth under
 6 the Constitution and laws of the United States, the Governor shall order out for service the *[or-*
 7 *ganized militia]* **National Guard** or *[such]* **any** part thereof as may be necessary, and if the number
 8 available is insufficient the Governor may call for and accept from the *[unorganized militia]* **general**
 9 **public** as many volunteers as are required for service in the *[organized militia]* **National Guard** or

20 **SECTION 20.** ORS 396.160 is amended to read:

21 396.160. (1) The Adjutant General shall be the Director of the Oregon Military Department, and

24 (2) The Adjutant General shall be charged, under the direction of the Governor, with the

30 **EMERGENCY MANAGEMENT**
31 **ASSISTANCE COMPACT**
32 **Article I - Purposes and Authorities**
33

34 This compact is made and entered into by and between the participating member states which
35 enact this compact, hereinafter called party states. For the purposes of this compact, the term
36 “states” is taken to mean the several states, the Commonwealth of Puerto Rico, the District of
37 Columbia, and all U.S. territorial possessions.

38 The purpose of this compact is to provide for mutual assistance between the states entering into
39 this compact in managing any emergency or disaster that is duly declared by the Governor of the
40 affected state(s), whether arising from natural disaster, technological hazard, man-made disaster,
41 civil emergency aspects of resources shortages, community disorders, insurgency, or enemy attack.

42 This compact shall also provide for mutual cooperation in emergency-related exercises, testing,
43 or other training activities using equipment and personnel simulating performance of any aspect of
44 the giving and receiving of aid by party states or subdivisions of party states during emergencies,
45 such actions occurring outside actual declared emergency periods. Mutual assistance in this com-

1 pact may include the use of the states' National Guard forces, either in accordance with the Na-
2 tional Guard Mutual Assistance Compact or by mutual agreement between states.

3
4 Article II - General Implementation

5
6 Each party state entering into this compact recognizes many emergencies transcend political
7 jurisdictional boundaries and that intergovernmental coordination is essential in managing these and
8 other emergencies under this compact. Each state further recognizes that there will be emergencies
9 which require immediate access and present procedures to apply outside resources to make a prompt
10 and effective response to such an emergency. This is because few, if any, individual states have all
11 the resources they may need in all types of emergencies or the capability of delivering resources to
12 areas where emergencies exist.

13 The prompt, full, and effective utilization of resources of the participating states, including any
14 resources on hand or available from the Federal Government or any other source, that are essential
15 to the safety, care, and welfare of the people in the event of any emergency or disaster declared by
16 a party state, shall be the underlying principle on which all articles of this compact shall be un-
17 derstood.

18 On behalf of the Governor of each state participating in the compact, the legally designated
19 state official who is assigned responsibility for emergency management will be responsible for for-
20 mulation of the appropriate interstate mutual aid plans and procedures necessary to implement this
21 compact.

22
23 Article III - Party State Responsibilities

24
25 A. It shall be the responsibility of each party state to formulate procedural plans and programs
26 for interstate cooperation in the performance of the responsibilities listed in this article. In formu-
27 lating such plans, and in carrying them out, the party states, insofar as practical, shall:

28 (1) Review individual state hazards analyses and, to the extent reasonably possible, determine
29 all those potential emergencies the party states might jointly suffer, whether due to natural disaster,
30 technological hazard, man-made disaster, emergency aspects of resource shortages, civil disorders,
31 insurgency, or enemy attack.

32 (2) Review party states' individual emergency plans and develop a plan which will determine the
33 mechanism for the interstate management and provision of assistance concerning any potential
34 emergency.

35 (3) Develop interstate procedures to fill any identified gaps and to resolve any identified incon-
36 sistencies or overlaps in existing or developed plans.

37 (4) Assist in warning communities adjacent to or crossing the state boundaries.

38 (5) Protect and assure uninterrupted delivery of services, medicines, water, food, energy and
39 fuel, search and rescue, and critical lifeline equipment, services, and resources, both human and
40 material.

41 (6) Inventory and set procedures for the interstate loan and delivery of human and material re-
42 sources, together with procedures for reimbursement or forgiveness.

43 (7) Provide, to the extent authorized by law, for temporary suspension of any statutes or ordi-
44 nances that restrict the implementation of the above responsibilities.

45 B. The authorized representative of a party state may request assistance of another party state

1 by contacting the authorized representative of that state. The provisions of this compact shall only
2 apply to requests for assistance made by and to authorized representatives. Requests may be verbal
3 or in writing. If verbal, the request shall be confirmed in writing within 30 days of the verbal re-
4 quest. Requests shall provide the following information:

5 (1) A description of the emergency service function for which assistance is needed including, but
6 not limited to, fire services, law enforcement, emergency medical, transportation, communications,
7 public works and engineering, building, inspection, planning and information assistance, mass care,
8 resource support, health and medical services, and search and rescue.

9 (2) The amount and type of personnel, equipment, materials and supplies needed, and a reason-
10 able estimate of the length of time they will be needed.

11 (3) The specific place and time for staging of the assisting party's response and a point of con-
12 tact at that location.

13 C. There shall be frequent consultation between state officials who have assigned emergency
14 management responsibilities and other appropriate representatives of the party states with affected
15 jurisdictions and the United States Government, with free exchange of information, plans, and re-
16 source records relating to emergency capabilities.

17
18 Article IV - Limitations

19
20 Any party state requested to render mutual aid or conduct exercises and training for mutual
21 aid shall take such action as is necessary to provide and make available the resources covered by
22 this compact in accordance with the terms hereof; provided that it is understood that the state
23 rendering aid may withhold resources to the extent necessary to provide reasonable protection for
24 such state. Each party state shall afford to the emergency forces of any party state, while operating
25 within its state limits under the terms and conditions of this compact, the same powers except that
26 of arrest unless specifically authorized by the receiving state, duties, rights, and privileges as are
27 afforded forces of the state in which they are performing emergency services. Emergency forces will
28 continue under the command and control of their regular leaders, but the organizational units will
29 come under the operational control of the emergency services authorities of the state receiving as-
30 sistance. These conditions may be activated, as needed, only subsequent to a declaration of a state
31 of emergency or disaster by the Governor of the party state that is to receive assistance or upon
32 commencement of exercises or training for mutual aid and shall continue so long as the exercises
33 or training for mutual aid are in progress, the state of emergency or disaster remains in effect or
34 loaned resources remain in the receiving state(s), whichever is longer.

35
36 Article V - Licenses and Permits

37
38 Whenever any person holds a license, certificate, or other permit issued by any state party to
39 the compact evidencing the meeting of qualifications for professional, mechanical, or other skills,
40 and when such assistance is requested by the receiving party state, such person shall be deemed
41 licensed, certified, or permitted by the state requesting assistance to render aid involving such skill
42 to meet a declared emergency or disaster, subject to such limitations and conditions as the Governor
43 of the requesting state may prescribe by executive order or otherwise.

44
45 Article VI - Liability

1 Officers or employees of a party state rendering aid in another state pursuant to this compact
2 shall be considered agents of the requesting state for tort liability and immunity purposes. No party
3 state or its officers or employees rendering aid in another state pursuant to this compact shall be
4 liable on account of any act or omission in good faith on the part of such forces while so engaged
5 or on account of the maintenance or use of any equipment or supplies in connection therewith. Good
6 faith in this article shall not include willful misconduct, gross negligence, or recklessness.

7
8 Article VII - Supplementary Agreements
9

10 Inasmuch as it is probable that the pattern and detail of the machinery for mutual aid among
11 two or more states may differ from that among the states that are party hereto, this compact con-
12 tains elements of a broad base common to all states, and nothing herein shall preclude any state
13 from entering into supplementary agreements with another state or affect any other agreements al-
14 ready in force between states. Supplementary agreements may comprehend, but shall not be limited
15 to, provisions for evacuation and reception of injured and other persons and the exchange of med-
16 ical, fire, police, public utility, reconnaissance, welfare, transportation and communications person-
17 nel, and equipment and supplies.

18
19 Article VIII - Compensation
20

21 Each party state shall provide for the payment of compensation and death benefits to injured
22 members of the emergency forces of that state and representatives of deceased members of such
23 forces in case such members sustain injuries or are killed while rendering aid pursuant to this
24 compact, in the same manner and on the same terms as if the injury or death were sustained within
25 their own state.

26
27 Article IX - Reimbursement
28

29 Any party state rendering aid in another state pursuant to this compact shall be reimbursed by
30 the party state receiving such aid for any loss or damage to or expense incurred in the operation
31 of any equipment and the provision of any service in answering a request for aid and for the costs
32 incurred in connection with such requests; provided, that any aiding party state may assume in
33 whole or in part such loss, damage, expense, or other cost, or may loan such equipment or donate
34 such services to the receiving party state without charge or cost; and provided further, that any two
35 or more party states may enter into supplementary agreements establishing a different allocation
36 of costs among those states. Article VIII expenses shall not be reimbursable under this provision.

37
38 Article X - Evacuation
39

40 Plans for the orderly evacuation and interstate reception of portions of the civilian population
41 as the result of any emergency or disaster of sufficient proportions to so warrant, shall be worked
42 out and maintained between the party states and the emergency management/services directors of
43 the various jurisdictions where any type of incident requiring evacuations might occur. Such plans
44 shall be put into effect by request of the state from which evacuees come and shall include the
45 manner of transporting such evacuees, the number of evacuees to be received in different areas, the

1 manner in which food, clothing, housing, and medical care will be provided, the registration of the
2 evacuees, the providing of facilities for the notification of relatives or friends, and the forwarding
3 of such evacuees to other areas or the bringing in of additional materials, supplies, and all other
4 relevant factors. Such plans shall provide that the party state receiving evacuees and the party state
5 from which the evacuees come shall mutually agree as to reimbursement of out-of-pocket expenses
6 incurred in receiving and caring for such evacuees, for expenditures for transportation, food, cloth-
7 ing, medicines and medical care, and like items. Such expenditures shall be reimbursed as agreed
8 by the party state from which the evacuees come. After the termination of the emergency or disas-
9 ter, the party state from which the evacuees come shall assume the responsibility for the ultimate
10 support of repatriation of such evacuees.

11
12 Article XI - Implementation

13
14 A. This compact shall become operative immediately upon its enactment into law by any two (2)
15 states; thereafter, this compact shall become effective as to any other state upon its enactment by
16 such state.

17 B. Any party state may withdraw from this compact by enacting a statute repealing the same,
18 but no such withdrawal shall take effect until 30 days after the Governor of the withdrawing state
19 has given notice in writing of such withdrawal to the Governors of all other party states. Such
20 action shall not relieve the withdrawing state from obligations assumed hereunder prior to the ef-
21 fective date of withdrawal.

22 C. Duly authenticated copies of this compact and of such supplementary agreements as may be
23 entered into shall, at the time of their approval, be deposited with each of the party states and with
24 the Federal Emergency Management Agency and other appropriate agencies of the United States
25 Government.

26
27 Article XII - Validity

28
29 This compact shall be construed to effectuate the purposes stated in Article I hereof. If any
30 provision of this compact is declared unconstitutional, or the applicability thereof to any person or
31 circumstances is held invalid, the constitutionality of the remainder of this compact and the appli-
32 cability thereof to other persons and circumstances shall not be affected thereby.

33
34 Article XIII - Additional Provisions

35
36 Nothing in this compact shall authorize or permit the use of military force by the National
37 Guard of a state at any place outside that state in any emergency for which the President is au-
38 thorized by law to call into federal service the [*militia*] **National Guard as defined in 10 U.S.C.**
39 **101(c)**, or for any purpose for which the use of the Army or the Air Force would in the absence of
40 express statutory authorization be prohibited under 18 U.S.C. 1385.

41

43 **SECTION 65.** ORS 480.111 is amended to read:

44 480.111. As used in ORS 480.111 to 480.165:

45 (1) "Cone fountain" means a cardboard or heavy paper cone that:

- 1 (a) Contains 50 grams or less of pyrotechnic composition;
- 2 (b) If mounted on a common base with other cones having less than one-half inch of separation,
3 results, when measured in combination with all other cones on the base, in a total pyrotechnic
4 composition of not more than 200 grams;
- 5 (c) If mounted on a common base with other cones having at least one-half inch of separation,
6 results, when measured in combination with all other cones on the base, in a total pyrotechnic
7 composition of not more than 500 grams; and
- 8 (d) Upon ignition has the same effect as a cylindrical fountain.
- 9 (2) "Consumer fireworks" means:
- 10 (a) A cone fountain, a cylindrical fountain, a flitter sparkler, a ground spinner, an illuminating
11 torch or a wheel, or a combination of two or more of those items; and
- 12 (b) Any other items, other than exempt fireworks, containing 500 grams or less of pyrotechnic
13 composition that the State Fire Marshal recognizes by rule to be suitable for retail sale to members
14 of the general public for individual use.
- 15 (3) "Cylindrical fountain" means a cylindrical tube that:
- 16 (a) Contains 75 grams or less of pyrotechnic composition;
- 17 (b) If mounted on a common base with other tubes having less than one-half inch of separation,
18 results, when measured in combination with all other tubes on the base, in a total pyrotechnic
19 composition of not more than 200 grams;
- 20 (c) If mounted on a common base with other tubes having at least one-half inch of separation,
21 results, when measured in combination with all other tubes on the base, in a total pyrotechnic
22 composition of not more than 500 grams;
- 23 (d) Upon ignition produces a shower of colored sparks and may produce a whistling effect; and
- 24 (e) Is provided with a means for restraining the behavior of the item, such as a spike for in-
25 sertation into the ground, a wood or plastic base for placing on the ground or, if designed to be
26 handheld, a wood or cardboard handle.
- 27 (4) "Display fireworks" means pyrotechnic devices that:
- 28 (a) Are designed for travel into the air or to project effects from a fixed position; and
- 29 (b)(A) Are classified by the United States Department of Transportation as Division 1.3 com-
30 patibility group G explosives or Division 1.4 compatibility group G explosives; or
- 31 (B) Contain more than 500 grams of pyrotechnic composition and are classified by the United
32 States Department of Transportation as Division 1.4 compatibility group E or S explosives.
- 33 (5) "Exempt fireworks" means the following:
- 34 (a) Paper caps containing 0.25 grains or less of explosive mixture and toy guns, canes or other
35 devices designed for firing those caps.
- 36 (b) Snakes or similar smoke-producing items containing 100 grains or less of combustible sub-
37 stances.
- 38 (c) Model rockets and model rocket motors that are used to propel recoverable models of rocket.
- 39 (d) Novelties and trick noisemakers.
- 40 (e) Emergency signaling devices, if used in railroad, boat, motor vehicle or other means of
41 transportation for warning or illumination purposes.
- 42 (f) Blank cartridges of a type used:
- 43 (A) For theater or other shows;
- 44 (B) For signaling or ceremonial purposes in athletics or sports; or
- 45 (C) By the [*militia*] **National Guard as described in ORS 396.105**, an organization of war vet-

1 erans or other organizations, if parading an armed color guard.

2 (g) Cartridges, shells or gunpowder for use in legally permitted types of firearms.

3 (h) Military pyrotechnic and signaling devices classified by the United States Department of
4 Transportation as Division 1.4 compatibility group S explosives that are assigned to and in the
5 possession of the Armed Forces of the United States, or an authorized agent of the armed forces,
6 as inventory for use by the armed forces or agent in training active members of the armed forces
7 in their duties.

8 (i) Other items that in the judgment of the State Fire Marshal do not require regulation or re-
9 strictions on sale.

10 (6) "Explosive mixture" means a substance arranged in a manner to allow burning in less than
11 one second.

12 (7)(a) "Fireworks" means:

13 (A) Consumer fireworks;

14 (B) Display fireworks;

15 (C) Exempt fireworks;

16 (D) Pyrotechnic articles;

17 (E) Special effects; and

18 (F) Other pyrotechnic devices that:

19 (i) Are capable of producing audible, visual, mechanical or thermal effects through combustion,
20 deflagration or detonation; and

21 (ii) Contain chemical elements and compounds that are capable of burning independently of at-
22 mospheric oxygen or contain flammable liquid mixtures or flammable gas mixtures.

23 (b) "Fireworks" does not mean a candle, flaming club, flaming baton or other device that is de-
24 signed to keep the flame and thermal radiation in close proximity to the device.

25 (8) "Fireworks display" means an entertainment feature at which the public or a private group
26 is allowed to view a display or discharge that uses or explodes display fireworks or pyrotechnic
27 articles.

28 (9) "Flitter sparkler" means a narrow paper tube that:

29 (a) Contains five grams or less of pyrotechnic composition;

30 (b) Produces colored sparks upon ignition; and

31 (c) Is activated by igniting paper located at one end of the tube.

32 (10) "Ground spinner" means a small device similar to a wheel in design and effect that:

33 (a) Contains 20 grams or less of pyrotechnic composition;

34 (b) Vents from an orifice located on the side of the tube or elsewhere on the device; and

35 (c) When placed on the ground and ignited, spins rapidly and produces a shower of colored
36 sparks.

37 (11) "Illuminating torch" means a cylindrical tube that:

38 (a) Contains 100 grams or less of pyrotechnic composition; and

39 (b) Is provided with a means for restraining the behavior of the item, such as a spike for in-
40 sertation into the ground, a wood or plastic base for placing on the ground or, if designed to be
41 handheld, a wood or cardboard handle.

42 (12) "Local government" has the meaning given that term in ORS 174.116.

43 (13)(a) "Manufacture" means to make, construct, fabricate or produce fireworks.

44 (b) "Manufacture" does not mean:

45 (A) The assembly or fabrication of sets or mechanical pieces for fireworks displays; or

1 (B) Actions taken within the scope of a certification for conducting fireworks displays or for a
2 pyrotechnics operator.

3 (14) "Pyrotechnic articles" means devices that:

4 (a) Are designed for professional use;

5 (b) Are similar to consumer fireworks in chemical composition and construction;

6 (c) Contain 500 grams or less of pyrotechnic composition;

7 (d) Are not labeled as consumer fireworks; and

8 (e) Have identification numbers UN0431 or UN0432 in the United States Department of Trans-
9 portation Hazardous Materials Table set forth in 49 C.F.R. 172.101 or an amendment or replacement
10 of that identification standard recognized by the State Fire Marshal.

11 (15) "Pyrotechnic composition" means a mixture that is:

12 (a) Composed of a metal powder having a high combustion temperature and an oxidant; and

13 (b) Capable of an exothermic reaction that produces light, heat, smoke, sound or gas.

14 (16) "Pyrotechnic device" means consumer fireworks, display fireworks, pyrotechnic articles,
15 special effects and bird and animal control devices, and other combinations or compositions of ma-
16 terials, that produce audible, visual, mechanical or thermal effects.

17 (17) "Special effects" means articles containing pyrotechnic composition that, subject to au-
18 thorization from the appropriate jurisdiction, are:

19 (a) Manufactured, assembled, designed or discharged in connection with television, theater or
20 motion picture productions, concerts or conference centers; or

21 (b) Used for commercial, industrial, educational, recreational or entertainment purposes.

22 (18) "Wheel" means a pyrotechnic device that:

23 (a) Is designed to be attached to a post or tree by means of a nail or string;

24 (b) Has one or more driver units or tubes, each containing not more than 60 grams of
25 pyrotechnic composition;

26 (c) Contains a total of not more than 200 grams of pyrotechnic composition; and

27 (d) Upon ignition revolves and produces a shower of colored sparks and may produce a whistling
28 effect.

29 **SECTION 66.** ORS 480.120 is amended to read:

30 480.120. (1) No person shall sell, keep or offer for sale, expose for sale, possess, use, explode or
31 have exploded any fireworks within Oregon, except as follows:

32 (a) Sales by manufacturers and wholesalers to customers residing outside this state in accord-
33 ance with ORS 480.156;

34 (b) Sales to persons or organizations having obtained a permit from the State Fire Marshal for
35 supervised public display;

36 (c) Sales to railroads, boats, motor vehicle or other transportation agencies, to be used for sig-
37 nal, warning or illumination purposes in connection with such business;

8 of ORS 480.111 to 480.165.

9 **SECTION 67.** ORS 653.269 is amended to read:

10 653.269. The provisions of ORS 653.268 relating to pay for overtime shall not apply to:

11 (1) Labor employed in forest fire fighting.

12 (2) Employees of any irrigation system district actually engaged in the distribution of water for
13 irrigation or domestic use.

14 (3) Employees of a public employer, as defined in ORS 243.650, who are employed in fire pro-
15 tection or law enforcement activities, including security personnel in corrections institutions, as
16 those employees and activities are defined by rule of the Commissioner of the Bureau of Labor and
17 Industries.

18 (4) Employees of a people's utility district organized under ORS chapter 261.

19 (5) Employees exempted from overtime:

20 (a) By a public employer as defined in ORS 243.650 because of the executive, administrative,
21 supervisory or professional nature of their employment as the nature of such employment is defined
22 by rule of the Commissioner of the Bureau of Labor and Industries; or

23 (b) By a collective bargaining agreement expressly waiving application of ORS 653.268.

18 **SECTION 69.** ORS 659A.086 is amended to read:

19 659A.086. (1) An employee shall be granted a leave of absence by the employer of the employee
20 to perform active state service if:

21 (a) The employee is a member of the *[organized militia of this state]* **National Guard as de-**
22 **scribed in ORS 396.105** and is called into active service of the state under ORS 399.065 or 399.075.

23 (b) The employee is a member of the *[organized militia]* **National Guard, as defined in 10**
24 **U.S.C. 101(c)**, of another state and is called into active state service by the Governor of the re-
25 spective state.

26 (2) The employer shall grant the employee a leave of absence until release from active state
27 service permits the employee to resume the duties of employment. The regular employment position
28 of an employee on a leave of absence for active state service under this section is considered vacant
29 only for the period of the leave of absence. The employee is not subject to removal or discharge from
30 the position as a consequence of the leave of absence.

31 (3) Upon the termination of the leave of absence for active state service, an employee shall:

32 (a) Resume the duties of employment within seven calendar days; and

33 (b) Be restored to the employee's position or an equivalent position by the employer without loss

27 wages or other compensation to the individual for those services.

28 (c) "Employee class" means a group of similarly situated employees whose positions have been
29 designated by their employer in a policy or a collective bargaining agreement as having common
30 characteristics.

31 (d) "Employer" means any person who employs one or more employees in this state. The term
32 includes the State of Oregon or any county, city, district, authority, public corporation or entity and
33 any of their instrumentalities organized and existing under law or charter, but does not include the
34 federal government.

35 (e) "Total compensation" means the total of an employee's base salary, differentials and over-
36 time.
