**PROPOSED AMENDMENTS TO  
HOUSE BILL 2292**

1      On page 1 of the printed bill, delete lines 6 through 28 and insert:

2      **“SECTION 2. (1) An insurer that offers a health benefit plan, as**  
3      **defined in ORS 743B.005, that reimburses the cost of counseling, pre-**  
4      **vention services or screening for sexually transmitted infections, shall**  
5      **provide coverage for:**

6      **“(a) Drugs that have been approved by the United States Food and**  
7      **Drug Administration for the treatment or prevention of human**  
8      **immunodeficiency virus; and**

9      **“(b) Services necessary for the commencement or continuation of**  
10     **human immunodeficiency virus prevention drugs described in this**  
11     **section, including but not limited to office visits, testing, vaccinations**  
12     **and monitoring services.**

13     **“(2) The coverage under subsection (1) of this section must be pro-**  
14     **vided without any cost-sharing, coinsurance or deductibles applicable**  
15     **to the services.**

16     **“(3) This section is exempt from ORS 743A.001.**

17     **“SECTION 3. ORS 743B.425 is amended to read:**

18     **“743B.425. (1) An insurer offering a health benefit plan as defined in ORS**  
19     **743B.005 may not:**

20     **“(a) Require prior authorization:**

21     **“(A) During the first 60 days of treatment, including medication therapy,**

1 prescribed for opioid or opiate withdrawal; or  
2       “(B) For post-exposure prophylactic antiretroviral drugs or [*at least one*]  
3 preexposure prophylactic antiretroviral [*drug*] **drugs**; or  
4       “(b) Restrict the reimbursement for medication therapies, preexposure  
5 prophylactic antiretroviral drugs or post-exposure prophylactic antiretroviral  
6 drugs to in-network pharmacists or pharmacies[; or].

7       ~~“(c) Subject to ORS 742.008, require a deductible, copayment, coinsurance  
8 or other cost-sharing for the coverage of human immunodeficiency virus post-  
9 exposure prophylactic drugs or therapies prescribed following a possible expo-  
10 sure to human immunodeficiency virus.]~~

11       “(2) This section is not subject to ORS 743A.001.

12       “(3) This section does not prohibit prior authorization for opioids or  
13 opiates prescribed for purposes other than medication therapy or treatment  
14 of opioid or opiate abuse or addiction.

15       “(4) Subsection (1)(b) of this section does not apply to a health mainte-  
16 nance organization as defined in ORS 750.005.”.

17       On page 2, delete lines 1 through 5.

18       In line 17, after “authority” add “or a coordinated care organization”.
