**PROPOSED AMENDMENTS TO
HOUSE BILL 2357**

1 On page 12 of the printed bill, line 25, delete “A.1.” and insert “A.”.

2 Delete lines 28 through 31.

3 On page 16, after line 36, insert:

4 **“SECTION 3. (1) When the Occupational Therapy Compact Com-**
5 **mission described in section 1 of this 2025 Act adopts a rule pursuant**
6 **to the Occupational Therapy Licensure Compact described in section**
7 **1 of this 2025 Act, the Occupational Therapy Licensing Board shall,**
8 **within 90 days after the date on which the rule is adopted by the**
9 **commission, adopt the rule of the commission as a rule of the board.**

10 **“(2) Failure of the board to adopt the rule of the commission as a**
11 **rule of the board within the time described in subsection (1) of this**
12 **section shall constitute default under the Occupational Therapy**
13 **Licensure Compact described in section 1 of this 2025 Act.”.**

14 In line 37, delete “3” and insert “4”.

15 On page 17, line 9, delete “4” and insert “5”.

16 In line 16, delete “5” and insert “6”.

17 Delete lines 28 through 41 and insert:

18 **“SECTION 7. (1) The amendments to ORS 675.220 and 675.222 by**
19 **sections 4 and 5 of this 2025 Act apply to individuals authorized to work**
20 **as occupational therapists or occupational therapy assistants by com-**
21 **compact privilege on or after the operative date specified in section 8 of**

1 **this 2025 Act.**

2 **“(2) The amendments to ORS 675.330 by section 6 of this 2025 Act**
3 **apply to moneys received by the Occupational Therapy Licensing**
4 **Board on or after the operative date specified in section 8 of this 2025**
5 **Act.**

6 **“SECTION 8. (1) Sections 1 to 3 of this 2025 Act and the amend-**
7 **ments to ORS 675.220, 675.222 and 675.330 by sections 4 to 6 of this 2025**
8 **Act become operative on January 1, 2026.**

9 **“(2) The Occupational Therapy Licensing Board may take any**
10 **action before the operative date specified in subsection (1) of this sec-**
11 **tion that is necessary to enable the board to exercise, on and after the**
12 **operative date specified in subsection (1) of this section, all of the du-**
13 **ties, functions and powers conferred on the board by sections 1 to 3**
14 **of this 2025 Act and the amendments to ORS 675.220, 675.222 and 675.330**
15 **by sections 4 to 6 of this 2025 Act.”.**

16 In line 45, delete “8” and insert “9”.

17 On page 29, line 8, delete “A. 1.” and insert “A.”.

18 Delete lines 11 through 15.

19 On page 32, delete lines 18 through 20 and insert:

20 **“SECTION 10. The Legislative Assembly of the State of Oregon**
21 **hereby ratifies the Audiology and Speech-Language Pathology Inter-**
22 **state Compact set forth in section 9 of this 2025 Act.**

23 **“SECTION 11. (1) When the Audiology and Speech-Language**
24 **Pathology Compact Commission described in section 9 of this 2025 Act**
25 **adopts a rule pursuant to the Audiology and Speech-Language**
26 **Pathology Interstate Compact described in section 9 of this 2025 Act,**
27 **the State Board of Examiners for Speech-Language Pathology and**
28 **Audiology shall, within 90 days after the date on which the rule is**
29 **adopted by the commission, adopt the rule of the commission as a rule**
30 **of the board.**

1 **“(2) Failure of the board to adopt the rule of the commission as a**
2 **rule of the board within the time described in this section shall con-**
3 **stitute default under the Audiology and Speech-Language Pathology**
4 **Interstate Compact described in section 9 of this 2025 Act.”.**

5 In line 21, delete “10” and insert “12”.

6 On page 33, line 4, delete “8” and insert “9”.

7 In line 6, delete “11” and insert “13”.

8 In line 14, delete “8” and insert “9”.

9 In line 15, delete “12” and insert “14”.

10 In line 23, delete “8” and insert “9”.

11 Delete lines 25 through 39 and insert:

12 **“SECTION 15. (1) The amendments to ORS 681.230 and 681.250 by**
13 **sections 12 and 13 of this 2025 Act apply to an individual authorized to**
14 **work as an audiologist or speech-language pathologist by compact**
15 **privilege on or after the operative date specified in section 16 of this**
16 **2025 Act.**

17 **“(2) The amendments to ORS 681.480 by section 14 of this 2025 Act**
18 **apply to moneys received by the State Board of Examiners for**
19 **Speech-Language Pathology and Audiology on or after the operative**
20 **date specified in section 16 of this 2025 Act.**

21 **“SECTION 16. (1) Sections 9 to 11 of this 2025 Act and the amend-**
22 **ments to ORS 681.230, 681.250 and 681.480 by sections 12 to 14 of this**
23 **2025 Act become operative on January 1, 2026.**

24 **“(2) The State Board of Examiners for Speech-Language Pathology**
25 **and Audiology may take any action before the operative date specified**
26 **in subsection (1) of this section that is necessary to enable the board**
27 **to exercise, on and after the operative date specified in subsection (1)**
28 **of this section, all of the duties, functions and powers conferred on the**
29 **board by sections 9 to 11 of this 2025 Act and the amendments to ORS**
30 **681.230, 681.250 and 681.480 by sections 12 to 14 of this 2025 Act.”.**

1 In line 43, delete “15” and insert “17”.

2 On page 34, line 24, delete “8” and insert “9”.

3 Delete lines 28 through 40 and insert:

4 **“SECTION 18. The amendments to ORS 676.177 by section 17 of this**
5 **2025 Act apply to information disclosed on or after the effective date**
6 **of this 2025 Act.**
