**PROPOSED AMENDMENTS TO
HOUSE BILL 2554**

1 On page 15 of the printed bill, line 6, delete “B.1.” and insert “B.”.

2 Delete lines 11 through 14.

3 On page 20, after line 8, insert:

4 **“SECTION 3. (1) When the Social Work Licensure Compact Com-**
5 **mission described in section 1 of this 2025 Act adopts a rule pursuant**
6 **to the Social Work Licensure Compact described in section 1 of this**
7 **2025 Act, the State Board of Licensed Social Workers shall, within 90**
8 **days after the date on which the rule is adopted by the commission,**
9 **adopt the rule of the commission as a rule of the board.**

10 **“(2) Failure of the board to adopt the rule of the commission as a**
11 **rule of the board within the time described in this section shall con-**
12 **stitute default under the Social Work Licensure Compact described in**
13 **section 1 of this 2025 Act.”.**

14 In line 9, delete “3” and insert “4”.

15 In line 23, delete “4” and insert “5”.

16 In line 43, delete “5” and insert “6”.

17 On page 21, line 6, delete “6” and insert “7”.

18 Delete lines 33 through 45 and delete page 22 and insert:

19 **“SECTION 8. (1) The amendments to ORS 675.520 and 675.523 by**
20 **sections 4 and 5 of this 2025 Act apply to individuals authorized to**
21 **practice by a multistate authorization to practice or a multistate li-**

1 cense on or after the operative date specified in section 9 of this 2025
2 Act.

3 “(2) The amendments to ORS 675.597 by section 6 of this 2025 Act
4 apply to moneys received by the State Board of Licensed Social
5 Workers on or after the operative date specified in section 9 of this
6 2025 Act.

7 “(3) The amendments to ORS 676.177 by section 7 of this 2025 Act
8 apply to information disclosed on or after the operative date specified
9 in section 9 of this 2025 Act.

10 “SECTION 9. (1) Sections 1 to 3 of this 2025 Act and the amend-
11 ments to ORS 675.520, 675.523, 675.597 and 676.177 by sections 4 to 7 of
12 this 2025 Act become operative on January 1, 2026.

13 “(2) The State Board of Licensed Social Workers may take any
14 action before the operative date specified in subsection (1) of this sec-
15 tion that is necessary to enable the board to exercise, on and after the
16 operative date specified in subsection (1) of this section, all of the du-
17 ties, functions and powers conferred on the board by sections 1 to 3
18 of this 2025 Act and the amendments to ORS 675.520, 675.523, 675.597
19 and 676.177 by sections 4 to 7 of this 2025 Act.

20 “SECTION 10. This 2025 Act takes effect on the 91st day after the
21 date on which the 2025 regular session of the Eighty-third Legislative
22 Assembly adjourns sine die.”.
