**PROPOSED AMENDMENTS TO
HOUSE BILL 3351**

1 On page 3 of the printed bill, line 27, delete the comma and insert a pe-
2 riod.

3 Delete line 28.

4 In line 42, delete “2.a. Subject to subparagraph b of this paragraph,” and
5 insert “2.”.

6 Delete lines 44 and 45.

7 On page 4, delete line 1.

8 In line 37, delete “Subject to Section 11 (B)(2) of this Compact,”.

9 On page 7, line 22, delete “Subject to ORS 24.500,”.

10 On page 8, line 6, delete “Subject to ORS 676.177,”.

11 On page 9, delete lines 6 through 11 and insert:

12 “C. The Commission shall have the following powers and duties:

13 “1. Establish the fiscal year of the Commission;

14 “2. Establish bylaws;”.

15 In line 15, delete “, subject to Section 11 (B)(2) of this Compact,”.

16 On page 11, line 22, after “states” insert a period and delete the rest of
17 the line and line 23.

18 On page 12, line 23, delete “Subject to ORS 676.177, but”.

19 In line 34, after “Commission” insert a period and delete the rest of the
20 line.

21 On page 13, delete lines 7 through 15 and insert:

1 “B. The Commission shall exercise its rulemaking powers pursuant to the
2 criteria set forth in this Section and the rules adopted thereunder. Rules and
3 amendments shall become binding as of the date specified in each proposed
4 rule or amendment.”.

5 On page 14, line 44, delete “, subject to Section”.

6 In line 45, delete “11 (B)(2) of this Compact,”.

7 On page 15, line 45, after “appropriate” insert a period and delete the rest
8 of the line.

9 On page 16, delete lines 1 and 2.

10 In line 9, after the second “relief” insert “and damages”.

11 In line 14, after “law” insert a period and delete the rest of the line and
12 delete lines 15 and 16.

13 In line 26, delete “, subject to Section 11 (B)(2) of this Compact”.

14 On page 17, delete lines 16 through 22 and insert:

15 “D. Any lawful actions of the Commission, including rules and bylaws
16 properly promulgated by the Commission, are binding upon the member
17 states.”.

18 After line 31, insert:

19 **“SECTION 3. (1) When the Counseling Compact Commission de-**
20 **scribed in section 1 of this 2025 Act adopts a rule pursuant to the**
21 **Counseling Compact described in section 1 of this 2025 Act, the Oregon**
22 **Board of Licensed Professional Counselors and Therapists shall, within**
23 **90 days after the date on which the rule is adopted by the commission,**
24 **adopt the rule of the commission as a rule of the board.**

25 **“(2) Failure of the board to adopt the rule of the commission as a**
26 **rule of the board within the time described in this section shall con-**
27 **stitute default under the Counseling Compact described in section 1**
28 **of this 2025 Act.”.**

29 In line 32, delete “3” and insert “4” and delete “4” and insert “5”.

30 In line 34, delete “4” and insert “5”.

1 In line 45, delete “5” and insert “6”.

2 On page 18, line 1, delete “4” and insert “5”.

3 In line 7, delete “6” and insert “7”.

4 On page 19, line 6, delete “7” and insert “8”.

5 In line 27, delete “Except as prohibited by subsection (5) of this
6 section.”.

7 Delete lines 33 through 45 and delete page 20 and insert:

8 **“SECTION 9. (1) The amendments to ORS 675.805 by section 6 of this
9 2025 Act apply to moneys received by the Oregon Board of Licensed
10 Professional Counselors and Therapists on or after the operative date
11 specified in section 10 of this 2025 Act.**

12 **“(2) The amendments to ORS 675.825 by section 7 of this 2025 Act
13 apply to individuals authorized to practice by privilege to practice on
14 or after the operative date specified in section 10 of this 2025 Act.**

15 **“(3) The amendments to ORS 676.177 by section 8 of this 2025 Act
16 apply to information disclosed on or after the operative date specified
17 in section 10 of this 2025 Act.**

18 **“SECTION 10. (1) Sections 1 to 3 and 5 of this 2025 Act and the
19 amendments to ORS 675.805, 675.825 and 676.177 by sections 6 to 8 of
20 this 2025 Act become operative on January 1, 2028.**

21 **“(2) The Oregon Board of Licensed Professional Counselors and
22 Therapists may take any action before the operative date specified in
23 subsection (1) of this section that is necessary to enable the board to
24 exercise, on or after the operative date specified in subsection (1) of
25 this section, all of the duties, functions and powers conferred on the
26 board by sections 1 to 3 and 5 of this 2025 Act and the amendments to
27 ORS 675.805, 675.825 and 676.177 by sections 6 to 8 of this 2025 Act.**

28 **“SECTION 11. This 2025 Act takes effect on the 91st day after the
29 date on which the 2025 regular session of the Eighty-third Legislative
30 Assembly adjourns sine die.”.**
