17 **“PARENTAGE ESTABLISHMENT, PRESUMPTIONS,**

18 **VOLUNTARY ACKNOWLEDGMENT**

20 **“SECTION 1. Sections 2, 39 to 51, 55 to 62, 63 to 74, 84 to 88 and 102**  
21 **of this 2025 Act and ORS 109.259 are added to and made a part of ORS**

1 **chapter 109.**

2 **“SECTION 2. Definitions. As used in ORS chapter 109:**

3 **“(1) ‘Acknowledged parent’ means an individual who has signed an**  
4 **effective acknowledgment of parentage, as described in ORS 109.070.**

5 **“(2) ‘Adjudicated parent’ means an individual who has been adjudi-**  
6 **cated to be a parent of a child by a court with jurisdiction.**

7 **“(3)(a) ‘Alleged genetic parent’ means an individual who is alleged**  
8 **to be, or alleges that the individual is, a genetic parent or possible**  
9 **genetic parent of a child whose parentage has not been adjudicated.**

10 **“(b) ‘Alleged genetic parent’ does not include a presumed parent,**  
11 **an individual whose parentage rights have been terminated or declared**  
12 **not to exist, an individual whose nonparentage of the child has been**  
13 **adjudicated or a donor.**

14 **“(4) ‘Assisted reproduction’ means:**

15 **“(a) Intrauterine or intracervical insemination;**

16 **“(b) Donation of gametes;**

17 **“(c) Donation of embryos;**

18 **“(d) In-vitro fertilization and transfer of embryos;**

19 **“(e) Intracytoplasmic sperm injection; or**

20 **“(f) Any other method of causing pregnancy other than sexual**  
21 **intercourse.**

22 **“(5)(a) ‘Determination of parentage’ means the establishment of a**  
23 **parent-child relationship by a judicial or administrative proceeding or**  
24 **signing of a valid acknowledgment of parentage under ORS 109.119.**

25 **“(b) ‘Determination of parentage’ does not include an order or**  
26 **judgment entered under ORS 109.119.**

27 **“(6)(a) ‘Donor’ means an individual who provides gametes or**  
28 **embryos intended for use in assisted reproduction, whether or not for**  
29 **consideration.**

30 **“(b) ‘Donor’ does not include:**

1       “(A) Except as provided in section 70 of this 2025 Act, the parent  
2 who gives birth to a child conceived by assisted reproduction, a  
3 gestational surrogate or a genetic surrogate; or

4       “(B) An intended parent of a child conceived by assisted repro-  
5 duction, including under a surrogacy agreement.

6       “(7) ‘Gamete’ means sperm, egg or any part of a sperm or egg.

7       “(8) ‘Genetic testing’ means an analysis of genetic markers to  
8 identify or exclude a genetic relationship.

9       “(9) ‘Gestational surrogate’ means an individual who is not an in-  
10 tended parent and who agrees to become pregnant through assisted  
11 reproduction using embryos that are not the individual’s own, under  
12 a gestational surrogacy agreement.

13       “(10)(a) ‘Intended parent’ means an individual, married or unmar-  
14 ried, who manifests an intent to be legally bound as a parent of a child  
15 conceived by assisted reproduction, including under a gestational  
16 surrogacy agreement.

17       “(b) ‘Intended parent’ does not include the parent who gives birth  
18 to the child conceived by assisted reproduction.

19       “(11) ‘Presumed parent’ means an individual who is presumed to be  
20 a parent of a child under section 6 of this 2025 Act.

21       “(12) ‘Surrogacy agreement’ means an agreement between one or  
22 more intended parents and an individual who is not an intended parent  
23 in which the individual agrees to become pregnant through assisted  
24 reproduction and which provides that each intended parent is a parent  
25 of a child conceived under the agreement. Unless otherwise specified,  
26 the term refers to both a gestational surrogacy agreement and a ge-  
27 netic surrogacy agreement.

28       “(13) ‘Transfer’ means a procedure for assisted reproduction by  
29 which an embryo or sperm is placed in the body of the person who  
30 will give birth to the child.

1 **“SECTION 3.** ORS 109.065 is amended to read:

2 “109.065. [(1)] Parentage may be established between a person and a child  
3 by:

4 “[a] (1) The person having given birth to the child, **unless the child**  
5 **was conceived by assisted reproduction under a gestational surrogacy**  
6 **agreement;**

7 “[b] (2) An un rebutted presumption of parentage under [ORS 109.070]  
8 **section 6 of this 2025 Act;**

9 “[c] (3) An adjudication of the person’s [*maternity or paternity*] **parent-**  
10 **age by judicial proceeding;**

11 “[d] (4) Adoption of the child by the person;

12 “[e] (5) An effective acknowledgment of [*paternity by the man*] **parent-**  
13 **age** under ORS 109.070 or pursuant to the laws of another state, unless the  
14 acknowledgment has been rescinded or successfully challenged;

15 “[f] (6) [*Establishment of paternity*] **An adjudication of parentage** by  
16 an administrative order issued pursuant to ORS 25.501 to 25.556;

17 “[g] *Filiation Proceedings; or*

18 **“(7) Establishment of parentage under sections 55 to 62 of this 2025**  
19 **Act of a child conceived by assisted reproduction other than under a**  
20 **surrogacy agreement;**

21 **“(8) Establishment of parentage under sections 63 to 74 of this 2025**  
22 **Act of a child conceived by assisted reproduction under a gestational**  
23 **surrogacy agreement; or**

24 “[h] (9) Parentage being established or declared by another provision  
25 of law.

26 “[2] *A person is the mother of a child to whom the person gives birth.*]

27 **“SECTION 4. Section 5 and 6 of this 2025 Act and ORS 109.065 and**  
28 **109.072 are added to and made a part of ORS 109.060 to 109.090.**

29 **“SECTION 5. UPA 618. Child as a party; representation. (1) In a**  
30 **proceeding to adjudicate the parentage of a child, other than a pro-**

1 ceeding under ORS chapter 419B, the child is a permissive party to the  
2 proceeding if the child has not attained 18 years of age.

3 “(2) The court shall appoint an attorney to represent a child who  
4 has not attained 18 years of age in a proceeding described in subsection  
5 (1) of this section if requested by the child or, if the court finds that  
6 the interests of the child are not adequately represented, on the  
7 court’s own motion or on the motion of a party. A reasonable fee for  
8 an attorney so appointed under this paragraph may be charged against  
9 one or more of the parties or as a cost in the proceedings, but may  
10 not be charged against funds appropriated for public defense services.

11 “SECTION 6. UPA 204/608. Presumption of parentage. (1) An indi-  
12 vidual is rebuttably presumed to be the parent of a child if, unless the  
13 child was conceived by assisted reproduction under a gestational  
14 surrogacy agreement:

15 “(a) The individual is married to the parent who gave birth to the  
16 child at the time of the child’s birth, without a judgment of separa-  
17 tion, regardless of whether the marriage is void; or

18 “(b) The individual was married to the parent who gave birth to the  
19 child and the child is born within 300 days after the marriage is ter-  
20 minated by death, annulment or dissolution or after entry of a judg-  
21 ment of separation.

22 “(2) The parentage of a child that is established under subsection  
23 (1)(a) of this section may be challenged by the parent who gave birth  
24 to the child or by the child’s presumed parent. The parentage may not  
25 be challenged by any other person as long as the parent who gave birth  
26 to the child and the child’s presumed parent are cohabiting, unless the  
27 parent who gave birth to the child and the child’s presumed parent  
28 both consent to the challenge.

29 “(3)(a) An action or proceeding to challenge parentage of a child  
30 established under this section must be initiated before the child at-

1 tains 18 years of age unless the child initiates the action or proceeding.

2 “(b) If the court finds that it is just and equitable, giving consid-  
3 eration to the interests of the parties and the child, the court shall  
4 admit evidence offered to rebut the presumption.

5 “(c) A presumption of parentage cannot be rebutted after the child  
6 attains four years of age unless the court determines:

7 “(A) The presumed parent is not a genetic parent, never resided  
8 with the child and never held the child out as the presumed parent’s  
9 child;

10 “(B) The child has more than one presumed parent; or

11 “(C) The presumption arose due to fraud, duress or a material  
12 mistake of fact.

13 “(d) The four-year statute of limitation under paragraph (c) of this  
14 subsection does not apply if the presumed parent’s parentage of the  
15 child is being challenged:

16 “(A) Under section 28 of this 2025 Act based on the presumed parent  
17 having committed an act constituting rape, as defined in section 28  
18 of this 2025 Act, that resulted in the child’s conception; or

19 “(B) Under section 59 (2) of this 2025 Act, if the child was conceived  
20 by assisted reproduction, other than under a surrogacy agreement.

21 “(4) Except as provided in section 28 or 59 of this 2025 Act, if the  
22 parent who gave birth to a child is the only other person with a claim  
23 to parentage of the child in a proceeding to adjudicate a presumed  
24 parent’s parentage of the child, the court shall:

25 “(a) Adjudicate the presumed parent to be a parent of the child if:

26 “(A) No party to the proceeding challenges the presumed parent’s  
27 parentage of the child; or

28 “(B) The presumed parent is identified under section 45 of this 2025  
29 Act as a genetic parent of the child and that identification is not  
30 successfully challenged under section 45 of this 2025 Act; or

1       **“(b) Adjudicate the parentage of the child in the best interests of**  
2 **the child based on the factors under section 54 of this 2025 Act if:**

3       **“(A) The presumed parent is not identified under section 45 of this**  
4 **2025 Act as a genetic parent of the child and the presumed parent or**  
5 **the parent who gave birth to the child challenges the presumed**  
6 **parent’s parentage of the child; or**

7       **“(B) If another person, other than the presumed parent or the**  
8 **parent who gave birth to the child, asserts a claim to parentage of the**  
9 **child.**

10       **“(5) The court may enter a judgment under this section before the**  
11 **child’s birth but shall stay enforcement of the judgment until the birth**  
12 **of the child and shall order one or more of the parties to notify the**  
13 **court of the child’s birth.**

14       **“SECTION 7.** Section 6 of this 2025 Act is amended to read:

15       **“Sec. 6.** (1) An individual is rebuttably presumed to be the parent of a  
16 child if, unless the child was conceived by assisted reproduction under a  
17 gestational surrogacy agreement:

18       **“(a) The individual is married to the parent who gave birth to the child**  
19 **at the time of the child’s birth, without a judgment of separation, regardless**  
20 **of whether the marriage is void; [or]**

21       **“(b) The individual was married to the parent who gave birth to the child**  
22 **and the child is born within 300 days after the marriage is terminated by**  
23 **death, annulment or dissolution or after entry of a judgment of**  
24 **separation[.]; or**

25       **“(c) The individual is not married to the parent who gave birth to**  
26 **the child at the time of the child’s birth but the individual and the**  
27 **parent who gave birth intend to be married and the individual agrees**  
28 **to be and is named as a parent of the child on the child’s record of live**  
29 **birth.**

30       **“(2) The parentage of a child that is established under subsection (1)(a)**

1 of this section may be challenged by the parent who gave birth to the child  
2 or by the child's presumed parent. The parentage may not be challenged by  
3 any other person as long as the parent who gave birth to the child and the  
4 child's presumed parent are cohabiting, unless the parent who gave birth to  
5 the child and the child's presumed parent both consent to the challenge.

6 “(3)(a) An action or proceeding to challenge parentage of a child estab-  
7 lished under this section must be initiated before the child attains 18 years  
8 of age unless the child initiates the action or proceeding.

9 “(b) If the court finds that it is just and equitable, giving consideration  
10 to the interests of the parties and the child, the court shall admit evidence  
11 offered to rebut the presumption.

12 “(c) A presumption of parentage cannot be rebutted after the child attains  
13 four years of age unless the court determines:

14 “(A) The presumed parent is not a genetic parent, never resided with the  
15 child and never held the child out as the presumed parent's child;

16 “(B) The child has more than one presumed parent;

17 “(C) **The presumption arose under subsection (1)(c) of this section**  
18 **but the presumed parent did not marry the person who gave birth to**  
19 **the child; or**

20 “[C] (D) The presumption arose due to fraud, duress or a material mis-  
21 take of fact.

22 “(d) The four-year statute of limitation under paragraph (c) of this sub-  
23 section does not apply if the presumed parent's parentage of the child is be-  
24 ing challenged:

25 “(A) Under section 28 of this 2025 Act based on the presumed parent  
26 having committed an act constituting rape, as defined in section 28 of this  
27 2025 Act, that resulted in the child's conception; or

28 “(B) Under section 59 (2) of this 2025 Act, if the child was conceived by  
29 assisted reproduction, other than under a surrogacy agreement.

30 “(4) Except as provided in section 28 or 59 of this 2025 Act, if the parent



1 who gave birth to a child is the only other person with a claim to parentage  
2 of the child in a proceeding to adjudicate a presumed parent's parentage of  
3 the child, the court shall:

4 “(a) Adjudicate the presumed parent to be a parent of the child if:

5 “(A) No party to the proceeding challenges the presumed parent's par-  
6 entage of the child; or

7 “(B) The presumed parent is identified under section 45 of this 2025 Act  
8 as a genetic parent of the child and that identification is not successfully  
9 challenged under section 45 of this 2025 Act; or

10 “(b) Adjudicate the parentage of the child in the best interests of the  
11 child based on the factors under section 54 of this 2025 Act if:

12 “(A) The presumed parent is not identified under section 45 of this 2025  
13 Act as a genetic parent of the child and the presumed parent or the parent  
14 who gave birth to the child challenges the presumed parent's parentage of  
15 the child; or

16 “(B) If another person, other than the presumed parent or the parent who  
17 gave birth to the child, asserts a claim to parentage of the child.

18 “(5) The court may enter a judgment under this section before the child's  
19 birth but shall stay enforcement of the judgment until the birth of the child  
20 and shall order one or more of the parties to notify the court of the child's  
21 birth.

22 “**SECTION 8.** ORS 109.070 is amended to read:

23 “109.070. [(1) *The parentage of a person is rebuttably presumed if:*]

24 “[*(a) The person is married to the birth mother at the time of the child's*  
25 *birth, without a judgment of separation, regardless of whether the marriage*  
26 *is void.*]

27 “[*(b) The person is married to the birth mother and the child is born within*  
28 *300 days after the marriage is terminated by death, annulment or dissolution*  
29 *or after entry of a judgment of separation.*]

30 “[*(2) The parentage of a child established under subsection (1)(a) or (4)(a)*]

1 *of this section may be challenged in an action or proceeding by either spouse.*  
2 *The parentage may not be challenged by a person other than a spouse as long*  
3 *as the spouses are married and are cohabiting, unless both spouses consent to*  
4 *the challenge.]*

5 *“(3) If the court finds that it is just and equitable, giving consideration*  
6 *to the interests of the parties and the child, the court shall admit evidence of-*  
7 *ferred to rebut the presumption of parentage in subsection (1) of this section.]*

8 *“(4) The paternity of a person may be established by a voluntary ac-*  
9 *knowledgment as follows:]*

10 *“(a) By the marriage of the parents of a child after the birth of the child,*  
11 *and the parents filing with the State Registrar of the Center for Health Sta-*  
12 *tistics the voluntary acknowledgment of paternity form as provided by ORS*  
13 *432.098.]*

14 *“(b) By filing with the state registrar of the Center for Health Statistics*  
15 *the voluntary acknowledgment of paternity form as provided under ORS*  
16 *432.098. Except as otherwise provided in subsections (5) and (8) of this section,*  
17 *a filing under this paragraph establishes paternity for all purposes.]*

18 **“(1) A parent who gave birth to a child and a child’s alleged genetic**  
19 **parent may establish parentage of the child:**

20 **“(a) By filing with the State Registrar of the Center for Health**  
21 **Statistics a voluntary acknowledgment of parentage form as pre-**  
22 **scribed by rule under ORS 432.098:**

23 **“(A) On or after the child’s date of birth; or**

24 **“(B) After the child’s date of birth if the child’s parents marry after**  
25 **the child’s birth; or**

26 *“(c) (b) By establishment of [paternity] parentage through a voluntary*  
27 *acknowledgment of [paternity] parentage in another state.*

28 **“(2) Except as otherwise provided in subsections (5) and (8) of this**  
29 **section, a filing under subsection (1)(a) of this section establishes**  
30 **parentage for all purposes.**

1       **“(3) The voluntary acknowledgment of parentage form must con-**  
2 **tain:**

3       **“(a) A statement that the child whose parentage is being acknowl-**  
4 **edged does not have a presumed parent, other acknowledged parent,**  
5 **adjudicated parent or intended parent other than the parent who gave**  
6 **birth to the child;**

7       **“(b) A statement of the parents’ rights and responsibilities includ-**  
8 **ing any rights afforded to a parent who is under 18 years of age;**

9       **“(c) A statement of the alternatives to and consequences of signing**  
10 **the acknowledgment;**

11       **“(d) Lines for the Social Security numbers and addresses of the**  
12 **parents;**

13       **“(e) If the acknowledgment is witnessed by staff in the health care**  
14 **facility, a statement that the witness read to the parties the rights,**  
15 **responsibilities, alternatives and consequences listed on the acknowl-**  
16 **edgment prior to signing the acknowledgment;**

17       **“(f) A statement that the parties to the acknowledgment under-**  
18 **stand that the acknowledgment is the equivalent of an adjudication**  
19 **of parentage of the child and that a challenge to the acknowledgment**  
20 **is permitted only under limited circumstances; and**

21       **“(g) A place for the signatures of the parent who gave birth to the**  
22 **child and the individual whose parentage is being acknowledged to be:**

23       **“(A) Notarized; or**

24       **“(B) Witnessed by a staff member of the health facility where the**  
25 **child was born if witnessed within five days following the child’s birth.**

26       **“(4) Unless rescinded under subsection (5) of this section or suc-**  
27 **cessfully challenged under subsection (6) of this section an acknowl-**  
28 **edgment of parentage that complies with this section and ORS 432.098**  
29 **and has become effective as described in ORS 432.098 is equivalent to**  
30 **an adjudication of parentage of the child and confers on the acknowl-**

1 **edged parent all rights and duties of a parent.**

2 “(5)(a) A party to a voluntary acknowledgment of [*paternity*] **parentage**  
3 may rescind the acknowledgment **by filing with the state registrar a**  
4 **written rescission, signed by the party and notarized.**

5 **“(b) The rescission must be filed with the state registrar** within the  
6 earlier of:

7 “(A) Sixty days after [*filing*] the acknowledgment **becomes effective as**  
8 **described in ORS 432.098;** or

9 “(B) The date of **the first hearing before the court in** a proceeding re-  
10 lating to the child, including a proceeding to establish a support order, in  
11 which the party wishing to rescind the acknowledgment is also a party. [*For*  
12 *the purposes of this subparagraph, the date of a proceeding is the date on*  
13 *which an order is entered in the proceeding.*]

14 “[*b*) *To rescind the acknowledgment, the party shall sign and file with the*  
15 *State Registrar of the Center for Health Statistics a written document declar-*  
16 *ing the rescission.*]

17 “(6)(a) A signed voluntary acknowledgment of [*paternity*] **parentage** filed  
18 in this state may be challenged and set aside in circuit court at any time  
19 after the 60-day period referred to in subsection (5) of this section on the  
20 basis of fraud, duress or a material mistake of fact.

21 “(b) The challenge may be brought by:

22 “(A) A party to the acknowledgment;

23 “(B) The child named in the acknowledgment; or

24 “(C) The Department of Human Services or the administrator, as defined  
25 in ORS 25.010, if the child named in the acknowledgment is in the care and  
26 custody of the department under ORS chapter 419B and the department or  
27 the administrator reasonably believes that the acknowledgment was signed  
28 because of fraud, duress or a material mistake of fact.

29 **“(c) Notwithstanding paragraph (b) of this subsection, an acknowl-**  
30 **edgment of parentage described in subsection (1)(a)(B) of this section**

1 **may be challenged by the parent who gave birth to the child or by the**  
2 **child’s acknowledged parent. The parentage may not be challenged by**  
3 **any other person as long as the parent who gave birth to the child and**  
4 **the acknowledged parent are married and cohabiting, unless the par-**  
5 **ent who gave birth to the child and the acknowledged parent both**  
6 **consent to the challenge.**

7 “[*c*] (d) The challenge shall be initiated by filing a petition with the  
8 circuit court. Unless otherwise specifically provided by law, the challenge  
9 shall be conducted pursuant to the Oregon Rules of Civil Procedure.

10 **“(e) Every party to the acknowledgment must be made a party to**  
11 **the proceeding.**

12 **“(f) By signing an acknowledgment of parentage, a party to the**  
13 **acknowledgment submits to the personal jurisdiction in this state in**  
14 **a proceeding to challenge the acknowledgment, effective on the filing**  
15 **of the acknowledgment with the state registrar.**

16 “[*d*] (g) The party bringing the challenge has the burden of proof.

17 “[*e*] (h) Legal responsibilities arising from the acknowledgment, includ-  
18 ing child support obligations, may not be suspended during the challenge,  
19 except for good cause.

20 “[*f*] (i) If the court finds by a preponderance of the evidence that the  
21 acknowledgment was signed because of fraud, duress or material mistake of  
22 fact, the court shall set aside the acknowledgment unless, giving consider-  
23 ation to the interests of the parties and the child, the court finds that setting  
24 aside the acknowledgment would be substantially inequitable.

25 *“(7) [Within one year after a voluntary acknowledgment of paternity form*  
26 *is filed in this state and if blood tests, as defined in ORS 109.251, have not*  
27 *been completed,]* A party to [*the acknowledgment*] **a voluntary acknowl-**  
28 **edgment of parentage**, or the department if the child named in the ac-  
29 knowledgment is in the care and custody of the department under ORS  
30 chapter 419B, may apply to the administrator for an order for [*blood tests*]

1 **genetic testing** in accordance with ORS 25.554 **if:**

2 **“(a) The application is made within one year after the acknowledg-**  
3 **ment becomes effective, as described in ORS 432.098;**

4 **“(b) Genetic testing has not previously been completed; and**

5 **“(c) The administrator is not prohibited under ORS 25.554 (9) from**  
6 **reopening the issue of parentage and ordering genetic testing.**

7 **“(8)(a) A voluntary acknowledgment of [*paternity*] parentage is not valid**  
8 **if, before the party signed the acknowledgment:**

9 **“(A) The party signed a consent to the adoption of the child by another**  
10 **individual;**

11 **“(B) The party signed a document relinquishing the child to a child-caring**  
12 **agency as defined in ORS 418.205;**

13 **“(C) The party’s parental rights were terminated by a court; or**

14 **“(D) [*In an adjudication, the party was determined not to be the***  
15 ***biological*] The party was adjudicated not to be the parent of the child.**

16 **“(b) A voluntary acknowledgment of parentage is not valid if, at the**  
17 **time the acknowledgment is signed, an individual other than the par-**  
18 **ent who gave birth to the child is the child’s presumed parent, ac-**  
19 **knowledged parent, adjudicated parent or intended parent, including**  
20 **an intended parent of the child under a surrogacy agreement.**

21 **“[(b)] (c) Notwithstanding any provision of subsection [(4)(a)] (1)(a) or (b)**  
22 **of this section or ORS 432.098 to the contrary, an acknowledgment **does not****

29 **“(9) An unchallenged acknowledgment of parentage may not be**

1        **“SECTION 9.** ORS 109.070, as amended by section 8 of this 2025 Act, is  
2 amended to read:

3        “109.070. (1) A parent who gave **or will give** birth to a child and a child’s  
4 alleged genetic parent, **presumed parent or, if the child was conceived**  
5 **by assisted reproduction, other than under a surrogacy agreement,**  
6 **intended parent** may establish parentage of the child:

7        “(a) By filing with the State Registrar of the Center for Health Statistics  
8 a voluntary acknowledgment of parentage form as prescribed by rule under  
9 ORS 432.098:

10       “(A) **Before**, on or after the child’s date of birth; or

11       “(B) After the child’s date of birth if the child’s parents marry after the  
12 child’s birth; or

13       “(b) By establishment of parentage through a voluntary acknowledgment  
14 of parentage in another state.

15       “(2) Except as otherwise provided in subsections [(5)] **(6)** and [(8)] **(9)** of  
16 this section, a filing under subsection (1)(a) of this section establishes par-  
17 entage for all purposes.

18       “(3) The voluntary acknowledgment of parentage form must contain:

19       “(a) A statement that the child whose parentage is being acknowledged:

20        “(A) Does not have a presumed parent[,] other **than the individual**  
21 **seeking to establish parentage or has a presumed parent whose denial**  
22 **of parentage is being filed with the acknowledgment; and**

23        “(B) **Does not have another** acknowledged parent, adjudicated parent  
24 or intended parent other than the parent who gave **or will give** birth to the

1 “(e) If the acknowledgment is witnessed by staff in the health care facil-  
2 ity, a statement that the witness read to the parties the rights, responsibil-  
3 ities, alternatives and consequences listed on the acknowledgment prior to  
4 signing the acknowledgment;

5 “(f) A statement that the parties to the acknowledgment understand that  
6 the acknowledgment is the equivalent of an adjudication of parentage of the  
7 child and that a challenge to the acknowledgment is permitted only under  
8 limited circumstances; and

9 “(g) A place for the signatures of the parent who gave **or will give** birth  
10 to the child and the individual whose parentage is being acknowledged to  
11 be:

12 “(A) Notarized; or

13 “(B) Witnessed by a staff member of the health facility where the child  
14 was born if witnessed within five days following the child’s birth.

15 “**(4)(a) A presumed parent or an alleged genetic parent may deny**  
16 **parentage by signing a written denial of parentage.**

17 “**(b) The denial of parentage is effective only if:**

18 “**(A) An acknowledgment of parentage by another individual is filed**  
19 **with the state registrar before, concurrently or after the denial of**  
20 **parentage is filed with the state registrar;**

21 “**(B) The signature of the presumed parent or alleged genetic parent**  
22 **is notarized; and**

23 “**(C) The presumed parent or alleged genetic parent has not previ-**

28 “[~~(4)~~] **(5)** Unless rescinded under subsection [~~(5)~~] **(6)** of this section or  
29 successfully challenged under subsection [~~(6)~~] **(7)** of this section:

30 “**(a)** An acknowledgment of parentage that complies with this section and



1 ORS 432.098 and has become effective as described in ORS 432.098 is equiv-  
2 alent to an adjudication of parentage of the child and confers on the ac-  
3 knowledged parent all rights and duties of a parent.

4 **“(b) A denial of parentage by a presumed parent or alleged genetic**  
5 **parent that complies with this section and ORS 432.098 and has become**  
6 **effective as described in ORS 432.098 is equivalent to an adjudication**  
7 **of nonparentage.**

8 “[5)(a)] **(6)(a)** A party to a voluntary acknowledgment **or denial** of par-  
9 entage may rescind the acknowledgment **or denial** by filing with the state  
10 registrar a written rescission, signed by the party and notarized.

11 **“(b)** The rescission must be filed with the state registrar within the ear-  
12 lier of:

13 **“(A)** Sixty days after the acknowledgment **or denial** becomes effective as

15 “[b](A)] **(a)(A)** ‘Parentage judgment’ means a judgment or administrative  
16 order that:

17 “(i) Expressly or by inference determines the parentage of a child, or that  
18 imposes a child support obligation based on the parentage of a child; and

19 “(ii) Resulted from a proceeding in which [*blood tests were*] **genetic**  
20 **testing was** not performed and the issue of parentage was not challenged.

21 “(B) ‘Parentage judgment’ does not include a judgment or administrative

29 child support obligations established in the parentage judgment, and for a

1       “(A) A party to the parentage judgment.

2       “(B) The Department of Human Services if the child is in the care and  
3 custody of the Department of Human Services under ORS chapter 419B.

4       “(C) The Division of Child Support of the Department of Justice if the

6 a summons and a true copy of the petition on all parties as provided in

9 point counsel for the child. However, if requested to do so by the child, the  
10 court shall appoint counsel for the child. A reasonable fee for an attorney

2       “109.092. (1) When it is determined that a [*woman*] **person** is pregnant  
3 with a child, the [*woman*] **person** and any [*man*] **individual** to whom [*she*]  
4 **the pregnant person** is not married and with whom [*she*] **the pregnant**  
5 **person** engaged in sexual intercourse at approximately the time of con-  
6 ception have an obligation to recognize that the [*man*] **individual** may be  
7 the other person responsible for the conception.

8       “(2)(a) During the months of pregnancy, the [*man*] **individual** may join  
9 the [*woman*] **pregnant person** in acknowledging [*paternity*] **parentage** and  
10 assuming the rights and duties of expectant parenthood.

11       “(b) If the [*man*] **individual** acknowledges [*paternity*] **parentage** of the  
12 expected child and the [*woman*] **pregnant person** denies that [*he is the fa-*  
13 *ther*] **the individual is the genetic parent of the child** or refuses to join  
14 [*him*] **the individual** in acknowledging [*paternity*] **parentage**, the [*man*] **in-**

7 able notice in adoption or other court proceedings concerning the custody  
8 of the child, except for juvenile court proceedings, if the petitioner knows,  
9 or by the exercise of ordinary diligence should have known:

6 **“SECTION 39. UPA 501. Definitions. As used in sections 39 to 51 of**  
7 **this 2025 Act:**

8 **“(1) ‘Combined relationship index’ means the product of all tested**  
9 **relationship indices.**

10 **“(2) ‘Ethnic or racial group’ means, for the purpose of genetic**  
11 **testing, a recognized group that an individual identifies as the**  
12 **individual’s ancestry or part of the individual’s ancestry or that is**  
13 **identified by other information.**

14 **“(3) ‘Hypothesized genetic relationship’ means an asserted genetic**  
15 **relationship between an individual and a child.**

16 **“(4) ‘Probability of parentage’ means, for the ethnic or racial group**  
17 **to which an individual alleged to be a parent belongs, the probability**  
18 **that a hypothesized genetic relationship is supported, compared to the**  
19 **probability that a genetic relationship is supported between the child**  
20 **and a random individual of the ethnic or racial group used in the hy-**  
21 **pothesized genetic relationship, expressed as a percentage incorporat-**  
22 **ing the combined relationship index and a prior probability.**

23 **“(5) ‘Relationship index’ means a likelihood ratio that compares the**

2 **netic testing.**

3       **“(3) If two or more individuals are subject to court-ordered genetic**  
4 **testing, the court may order that testing be completed concurrently**  
5 **or sequentially.**

6       **“(4) Genetic testing of the person who gave birth to the child is not**  
7 **a condition precedent to testing of the child and an individual whose**  
8 **genetic parentage of the child is being determined. If the person who**  
9 **gave birth to the child is unavailable or declines to submit to genetic**  
10 **testing, the court may order genetic testing of the child and each in-**  
11 **dividual whose genetic parentage of the child is being adjudicated.**

12       **“(5) The court may deny a motion for genetic testing of the child**  
13 **and any other individual after considering the factors in section 54 of**  
14 **this 2025 Act if the genetic testing is requested in a proceeding:**

15       **“(a) To adjudicate the parentage of a child having a presumed par-**  
16 **ent;**

17       **“(b) To challenge an acknowledgment of parentage; or**

18       **“(c) Except as provided in section 70 (3) of this 2025 Act, to deter-**  
19 **mine whether a gestational surrogate is the genetic parent of a child**  
20 **believed to have been conceived by assisted reproduction under a**  
21 **gestational surrogacy agreement.**

22       **“(6) The court may only approve an individual’s request for genetic**  
23 **testing if the individual has standing to maintain a proceeding to ad-**  
24 **judicate parentage and any statute of limitations or time limits for**  
25 **initiating a proceeding to adjudicate parentage that are applicable to**  
26 **the individual have not expired.**

27       **“(7) If any individual declines to submit to genetic testing ordered**  
28 **by the court, the court or administrator may:**

29       **“(a) If the rights of others and the interests of justice so require,**  
30 **resolve the question of parentage against such person or enforce the**

1 court's or administrator's order; or

2 “(b) Find the individual in contempt of court.

3 “(8) Subject to the limitations in section 6 (2) of this 2025 Act and  
4 ORS 109.070 (6)(c), the Department of Human Services is not required

6 netic testing at the request of a party or a child's alleged genetic  
7 parent if the child is in the department's care and custody.

9 netic testing must be of a type reasonably relied on by experts in the

22 genetic testing, a testing laboratory shall determine the databases  
23 from which to select frequencies for use in calculating a relationship  
24 index. If an individual or the administrator objects to the laboratory's  
25 database determination, the following rules apply:

26 “(a) Not later than 30 days after receipt of the report of the test,  
27 the objecting individual or administrator may request the court to  
28 require the laboratory to recalculate the relationship index using an  
29 ethnic or racial group different from that used by the laboratory.

1 laboratory's database determination under this subsection shall:

2 “(A) If the requested frequencies are not available to the laboratory

6 “(c) The laboratory may use its own statistical estimate if there is

21 “(a) The individual has at least a 99 percent probability of parent-  
22 age, using a prior probability of 0.50, as calculated by using the com-  
23 bined relationship index obtained in the testing; and

26 der this section may challenge the genetic testing results only by other  
27 genetic testing satisfying the requirements of sections 39 to 51 of this

30 “(b) Identifies another individual as a possible genetic parent of the

1 **child other than:**

2 **“(A) The person who gave birth to the child; or**

3 **“(B) The individual identified under subsection (1) of this section.**

4 **“(3) Except as otherwise provided in section 50 of this 2025 Act, if**  
5 **more than one individual other than the person who gave birth is**  
6 **identified by genetic testing as a possible genetic parent of the child,**  
7 **the court shall order each individual to submit to further genetic**  
8 **testing to identify a genetic parent.**

9 **“SECTION 46. UPA 507. Cost of genetic testing. (1) Payment of the**  
10 **cost of initial genetic testing must be made:**

11 **“(a) By the Child Support Program if child support enforcement**  
12 **services are being provided under ORS 25.080;**

13 **“(b) By the individual or agency that made the request for genetic**  
14 **testing;**

15 **“(c) As agreed by the parties; or**

16 **“(d) As ordered by the court.**

17 **“(2) If the cost of genetic testing is paid by the Child Support Pro-**  
18 **gram, the program may seek reimbursement from the person or**  
19 **agency that requested the tests.**

20 **“(3) If the original test result is contested prior to the entry of an**  
21 **order or judgment establishing parentage, the court or the adminis-**  
22 **trator shall order additional testing upon request and advance pay-**  
23 **ment by the party making the request.**

24 **“SECTION 47. UPA 508. Additional genetic testing. The court or the**  
25 **administrator shall order additional genetic testing at the request of**  
26 **an individual who contests the result of the initial testing under sec-**  
27 **tion 45 of this 2025 Act. If initial genetic testing under section 45 of**  
28 **this 2025 Act identified an individual as a genetic parent of the child,**  
29 **the court or the administrator may not order additional testing unless**  
30 **the contesting individual pays for the testing in advance.**

1       **“SECTION 48. UPA 509. Genetic testing when specimen not avail-**  
2 **able.** (1) The court may order relatives of an alleged genetic parent to

18       **“SECTION 49. UPA 510. Deceased individual.** If an individual seek-  
19 ing genetic testing demonstrates good cause, the court may order ge-  
20 netic testing of a deceased individual.

21       **“SECTION 50. UPA 511. Identical siblings.** (1) If the court finds  
22 there is reason to believe that an alleged genetic parent has an iden-  
23 tical sibling and evidence that the sibling may be a genetic parent of  
24 the child, the court may order genetic testing of the sibling.

25       “(2) If more than one sibling is identified under section 45 of this  
26 2025 Act as a genetic parent of the child, the court may rely on non-  
27 genetic evidence to adjudicate which sibling is a genetic parent of the  
28 child.

29       **“SECTION 51. UPA 512. Confidentiality of genetic testing.** Release  
30 of a report of genetic testing for parentage is subject to the privacy

1 **protections under ORS 192.531 to 192.549.**

2 **“SECTION 52.** ORS 109.260 is amended to read:

3 **“109.260. [ORS 109.250 to 109.262] Sections 39 to 51 of this 2025 Act ap-**  
4 **ply to criminal cases for nonsupport under ORS 163.555 subject to the fol-**  
5 **lowing limitations and provisions:**

6 **“(1) An order for the tests shall be made only upon application of a party**  
7 **or on the court’s initiative.**

8 **“(2) The compensation of the experts shall be paid by the county in which**  
9 **the proceedings are had under order of court.**

10 **“(3) The court may direct a verdict of acquittal upon the conclusions of**

20 **age. (1) Except as otherwise provided in section 28 of this 2025 Act, in**  
21 **a proceeding to adjudicate competing claims of, or challenges under**  
22 **ORS 109.070 or 109.072 or section 6 (3) of this 2025 Act to, parentage of**  
23 **a child by two or more individuals, the court shall adjudicate parent-**  
24 **age in the best interest of the child, taking into consideration, at a**  
25 **minimum:**

26 **“(a) The age of the child;**

27 **“(b) The length of time during which each individual assumed the**  
28 **role of parent of the child;**

29 **“(c) The nature of the relationship between the child and each in-**  
30 **dividual;**



1 **the child’s presumed parent may be challenged under this section:**

2 **“(a) By the parent who gave birth to the child and the child’s pre-**  
3 **sumed parent;**

4 **“(b) If the parent who gave birth to the child and the child’s pre-**  
5 **sumed parent are married and cohabiting, by any person with standing**  
6 **under subsection (1) of this section if the parent who gave birth to the**  
7 **child and the child’s presumed parent both consent to the challenge;**  
8 **or**

9 **“(c) If the parent who gave birth to the child and the child’s pre-**  
10 **sumed parent are no longer married and cohabiting, by any person**  
11 **with standing under subsection (1) of this section.**

12 **“(3)(a) The court shall adjudicate an individual’s parentage of a**  
13 **child in a proceeding commenced under this section as provided in**  
14 **sections 55 to 62 of this 2025 Act.**

15 **“(b) If the child was conceived by assisted reproduction, other than**  
16 **under a surrogacy agreement, and a person other than the individual**  
17 **or the parent who gave birth to the child is a parent under sections**  
18 **55 to 62 of this 2025 Act, the court shall adjudicate the individual’s**  
19 **parentage of the child under section 54 of this 2025 Act.**

20 **“(4) Nothing in this section prohibits an individual from asserting**  
21 **a claim to or commencing an action to adjudicate the parentage of a**  
22 **child conceived by assisted reproduction, other than under a surrogacy**  
23 **agreement, under section 6 of this 2025 Act or ORS 109.070 or 109.072,**  
24 **as applicable.**

25 **“SECTION 56.** Section 55 of this 2025 Act is amended to read:

26 **“Sec. 55.** (1) Except as provided in subsection (2) of this section, a pro-  
27 ceeding under sections 55 to 62 of this 2025 Act to adjudicate the parentage  
28 of a child conceived by assisted reproduction, other than under a surrogacy  
29 agreement, may be commenced by:

30 **“(a) An alleged intended parent;**

1 “(b) The parent who gave birth to the child; [or]

2 “(c) The child’s presumed parent; **or**

3 **“(d) The child’s acknowledged parent.**

4 “(2) If the child was conceived by assisted reproduction, other than under  
5 a surrogacy agreement, the parentage of an individual who is the child’s  
6 presumed parent **or acknowledged parent under ORS 109.070 (1)(a)(B)**  
7 may be challenged under this section:

8 “(a) By the parent who gave birth to the child and the child’s presumed  
9 parent **or acknowledged parent;**

10 “(b) If the parent who gave birth to the child and the child’s presumed  
11 parent **or acknowledged parent** are married and cohabiting, by any person  
12 with standing under subsection (1) of this section if the parent who gave  
13 birth to the child and the child’s presumed parent **or acknowledged parent**

19 a proceeding commenced under this section as provided in sections 55 to 62  
20 of this 2025 Act.

21 “(b) If the child was conceived by assisted reproduction, other than under  
22 a surrogacy agreement, and a person other than the individual or the parent  
23 who gave birth to the child is a parent under sections 55 to 62 of this 2025  
24 Act, the court shall adjudicate the individual’s parentage of the child under  
25 section 54 of this 2025 Act.

26 “(4) Nothing in this section prohibits an individual from commencing an  
27 action to adjudicate or asserting a claim to the parentage of a child con-  
28 ceived by assisted reproduction, other than under a surrogacy agreement,  
29 under section 6 of this 2025 Act or ORS 109.070 or 109.072, as applicable.

30 **“SECTION 57. UPA 702. Parental status of donor. A donor is not a**



1 parent of a child conceived by assisted reproduction.

2 **“SECTION 58. UPA 703/704. Parentage of child of assisted repro-**  
3 **duction; consent.** (1) An individual’s parentage of a child conceived by  
4 assisted reproduction, other than under a surrogacy agreement:

5 **“(a) Is established by operation of law if:**

6 **“(A) Before, on or after the child’s birth, the individual consents in**  
7 **writing to the assisted reproduction;**

8 **“(B) The writing states that the individual intends to be a parent**  
9 **of the child; and**

10 **“(C) The writing is signed by the individual and the parent who gave**  
11 **birth to the child; or**

12 **“(b) May be established by judgment of the court if the individual**  
13 **did not consent in writing or the writing does not meet the require-**  
14 **ments of paragraph (a) of this subsection and a court finds by clear**  
15 **and convincing evidence that:**

16 **“(A) The individual and the parent who gave birth to the child en-**  
17 **tered into an express agreement before the child’s conception that the**  
18 **individual and the parent who gave birth to the child both would be**  
19 **parents of the child; or**

20 **“(B) The individual and the parent who gave birth to the child re-**  
21 **sided together in the same household with the child and both openly**  
22 **held out the child as the individual’s child:**

23 **“(i) For the first two years of the child’s life, including any period**  
24 **of temporary absence; or**

25 **“(ii) From the child’s birth until the death of the child or the death**  
26 **or incapacity of the individual, if, before the child attains two years**  
27 **of age, the child dies or the individual dies or becomes incapacitated,**  
28 **and a party proves by clear and convincing evidence that the parent**  
29 **who gave birth to the child and the individual both intended the indi-**  
30 **vidual would openly hold out the child as the individual’s child, but**

1 the individual was prevented from carrying out that intent by the  
2 death of the child or the individual's death or incapacity.

3 “(2) When determining whether an individual's absence was tem-  
4 porary under subsection (1) of this section, the court shall consider the  
5 totality of the circumstances, including whether the individual's ab-  
6 sence was due to military service.

7 “SECTION 59. UPA 705. Limitation on spouse's dispute of parent-  
8 age. The court shall find that an individual who is the presumed par-  
9 ent of a child conceived by assisted reproduction, other than under a  
10 surrogacy agreement, is not the parent of the child and that the  
11 presumption is rebutted if:

12 “(1)(a) The individual provided the gametes used in the assisted re-  
13 production;

14 “(b) The individual challenges the presumption within two years  
15 following the birth of the child; and

16 “(c) The court finds that the individual did not consent to the as-  
17 sisted reproduction before, on or after the birth of the child or with-  
18 drew consent as provided in section 61 of this 2025 Act; or

19 “(2)(a) The individual did not provide the gametes used in the as-  
20 sisted reproduction;

21 “(b) The individual did not consent to the assisted reproduction;

22 “(c) The individual and the parent who gave birth to the child have  
23 not cohabited since the date of the transfer that resulted in the preg-

25 “(d) The individual never openly held out the child as the

27 “SECTION 60. UPA 706. Effect of certain legal proceedings regard-  
28 ing marriage. If the marriage of a parent who gave birth to a child  
29 conceived by assisted reproduction, other than under a surrogacy  
30 agreement, is terminated through dissolution, annulment or legal

1 separation before the transfer that results in a pregnancy, the former  
2 spouse of the parent who gave birth to the child conceived by the as-  
3 sisted reproduction is not a parent of the child unless the former  
4 spouse consented in writing that the former spouse would be a parent  
5 of the child if a transfer resulting in pregnancy were to occur after a  
6 dissolution, annulment or legal separation, and the former spouse did  
7 not withdraw consent as provided in section 61 of this 2025 Act.

8 **“SECTION 61. UPA 707. Withdrawal of consent.** (1) An individual  
9 who consents to assisted reproduction, other than under a surrogacy  
10 agreement, may withdraw consent any time before a transfer that re-  
11 sults in a pregnancy by giving written notice of the withdrawal of  
12 consent to the person who agreed to give birth to a child conceived  
13 by the assisted reproduction.

14 **“(2) An individual who withdraws consent under subsection (1) of  
15 this section:**

16 **“(a) Is not a parent of a child conceived by the assisted reprod-  
17 uction under sections 55 to 62 of this 2025 Act; and**

18 **“(b) Is a donor if the individual provided the gametes that resulted  
19 in the pregnancy.**

20 **“(3) An individual who withdraws consent as provided in this sec-  
21 tion shall provide a copy of the withdrawal to the clinic or health care  
22 provider facilitating the assisted reproduction. Failure to give notice  
23 to the clinic or health care provider does not affect the validity of the  
24 withdrawal.**

25 **“SECTION 62. UPA 708. Parental status of deceased individual.** (1)  
26 **If an individual who intends to be a parent of a child conceived by  
27 assisted reproduction, other than under a surrogacy agreement, dies  
28 during the period between the date of transfer and the birth of the  
29 child, the individual’s death does not preclude the establishment of the  
30 individual’s parentage of the child in the same manner as if the indi-**

1 **vidual had died after the birth of the child.**

2 **“(2) If an individual who consented in writing to assisted repro-**  
3 **duction as described in section 58 (1)(a) of this 2025 Act dies before a**  
4 **transfer that results in pregnancy, the deceased individual is a parent**  
5 **of a child conceived by the transfer only if:**

6 **“(a)(A) The individual consented in writing that if assisted repro-**  
7 **duction were to occur after the death of the individual, the individual**  
8 **would be a parent of the child; or**

9 **“(B) The individual’s intent to be a parent of a child conceived by**  
10 **assisted reproduction after the individual’s death is established by**  
11 **clear and convincing evidence; and**

12 **“(b) The embryo is in utero not later than 24 months after the**  
13 **individual’s death.**

14

15 **“(Under gestational surrogacy agreement)**

16

17 **“SECTION 63. UPA 802. Eligibility to enter gestational surrogacy**  
18 **agreement. (1) An individual may enter into an agreement to act as a**  
19 **gestational surrogate only if the individual:**

20 **“(a) Has attained 21 years of age;**

21 **“(b) Has previously given birth to at least one child;**

22 **“(c) Has completed a medical evaluation related to the surrogacy**  
23 **arrangement and the medical evaluation was conducted by a licensed**  
24 **health care provider;**

25 **“(d) Has completed a mental health consultation by a licensed**  
26 **mental health care provider; and**

27 **“(e) Has retained, at the expense of the intended parent or parents,**  
28 **independent legal representation of the individual’s choice to represent**  
29 **the individual throughout the surrogacy arrangement regarding the**  
30 **terms of the surrogacy agreement and the potential legal conse-**

1 quences of the agreement.

2 “(2) An individual who intends to be a parent of a child conceived  
3 by assisted reproduction under a gestational surrogacy arrangement  
4 may enter into an agreement with a gestational surrogate if the indi-  
5 vidual:

6 “(a) Has attained 21 years of age;

7 “(b) Has completed a medical evaluation related to the surrogacy  
8 arrangement and the medical evaluation was conducted by a licensed  
9 health care provider;

10 “(c) Has completed a mental health consultation by a licensed  
11 mental health care provider; and

12 “(d) Has retained legal representation of the individual’s choice to  
13 represent the individual throughout the surrogacy arrangement re-  
14 garding the terms of the surrogacy agreement and the potential legal  
15 consequences of the agreement.

16 “SECTION 64. UPA 803. Requirements of gestational surrogacy  
17 agreement; process. A gestational surrogacy agreement must be exe-  
18 cuted in compliance with the following rules:

19 “(1)(a) At least one party must be a resident of this state;

20 “(b) The transfer that results in the pregnancy must occur in this  
21 state; or

22 “(c) The parties must all intend that the child be born in this state.

23 “(2) A gestational surrogate and each intended parent must meet  
24 the requirements of section 63 of this 2025 Act.

25 “(3) Each intended parent, the surrogate and the surrogate’s  
26 spouse, if any, must be parties to the agreement.

27 “(4) The agreement must be in writing and signed by each party  
28 listed in subsection (3) of this section.

29 “(5) The surrogate and each intended parent must acknowledge in  
30 writing receipt of a copy of the agreement.

1       “(6) The signature of each party to the agreement must be made  
2 under penalty of perjury or notarized.

3       “(7) The agreement must identify the attorneys the parties have  
4 retained to provide legal representation throughout the surrogacy ar-  
5 rangement.

6       “(8) The intended parent or parents must agree to pay for inde-  
7 pendent legal representation for the surrogate.

8       “(9) The agreement must be executed before a transfer that results  
9 in the agreed upon pregnancy.

10       “SECTION 65. UPA 804. Requirements of gestational or genetic  
11 surrogacy agreement; content. (1) A gestational surrogacy agreement  
12 must comply with the following requirements:

13       “(a) A surrogate agrees to attempt to become pregnant by means  
14 of assisted reproduction.

15       “(b) The surrogate and the surrogate’s spouse or former spouse, if  
16 any, have no claim to parentage of a child conceived by assisted re-  
17 production under the agreement.

18       “(c) The surrogate’s spouse, if any, must acknowledge and agree to  
19 comply with the obligations imposed on the surrogate by the agree-  
20 ment.

21       “(d) Except as otherwise provided in section 102 of this 2025 Act, the  
22 intended parent or, if there are two intended parents, each one jointly  
23 and severally, immediately on birth will be the exclusive parent or  
24 parents of the child, regardless of number of children born or gender  
25 or mental or physical condition of each child.

26       “(e) Except as otherwise provided in section 102 of this 2025 Act, the  
27 intended parent or, if there are two intended parents, each parent  
28 jointly and severally, immediately on birth will assume responsibility  
29 for the financial support of the child, regardless of number of children  
30 born or gender or mental or physical condition of each child.

1       “(f) The agreement must include information disclosing how each  
2 intended parent will cover the surrogacy-related expenses of the sur-  
3 surrogate and the medical expenses of the child. If health care coverage  
4 is used to cover the medical expenses, the disclosure must include a  
5 summary of the health care policy provisions related to coverage for  
6 surrogate pregnancy, including any possible liability of the surrogate,  
7 third party liability liens, other insurance coverage, and any notice  
8 requirement that could affect coverage or liability of the surrogate.  
9 Unless the agreement expressly provides otherwise, the review and  
10 disclosure do not constitute legal advice. If the extent of coverage is  
11 uncertain, a statement of that fact is sufficient to comply with this  
12 paragraph.

13       “(g) The agreement must permit the surrogate to make all health  
14 and welfare decisions regarding the surrogate and the pregnancy, in-  
15 cluding decisions regarding reproductive health care, as defined in  
16 ORS 435.190.

17       “(h) The agreement must include information about each party’s  
18 right under section 69 of this 2025 Act to terminate the surrogacy  
19 agreement.

20       “(2) A gestational surrogacy agreement may provide for:

21       “(a) Payment of consideration and reasonable expenses; and

22       “(b) Reimbursement of specific expenses if the agreement is termi-  
23 nated under section 69 of this 2025 Act.

24       “(3) A right created under a surrogacy agreement is not assignable  
25 and there is no third party beneficiary of the agreement other than  
26 the child.

27       “SECTION 66. UPA 805. Surrogacy agreement; effect of subsequent  
28 change of marital status. (1) Unless a gestational surrogacy agreement  
29 expressly provides otherwise, after the agreement is signed by all of  
30 the parties:

1       “(a) The subsequent marriage of a surrogate does not affect the  
2 validity of the agreement, the consent of the surrogate’s new spouse  
3 to the agreement is not required and the surrogate’s new spouse is not  
4 a presumed parent of a child conceived by assisted reproduction under  
5 the agreement; and

6       “(b) The subsequent dissolution, annulment or legal separation of  
7 the surrogate does not affect the validity of the agreement.

8       “(2) Unless a gestational surrogacy agreement expressly provides  
9 otherwise, after the agreement is signed by all of the parties:

10       “(a) The marriage of an intended parent does not affect the validity  
11 of a surrogacy agreement, the consent of the new spouse of the in-  
12 tended parent is not required and the new spouse of the intended  
13 parent is not, based on the agreement, a parent of a child conceived  
14 by assisted reproduction under the agreement; and

15       “(b) The dissolution, annulment or legal separation of an intended  
16 parent does not affect the validity of the agreement and unless the  
17 agreement is terminated under section 69 of this 2025 Act, the intended  
18 parents are the parents of any child conceived by assisted reproduction  
19 under the agreement.

20       “(3) Nothing in this section prohibits the parties before an embryo  
21 transfer that results in the agreed upon pregnancy from jointly  
22 amending the existing agreement.

23       “SECTION 67. UPA 806. Inspection of documents. (1) A petition and  
24 any other document related to a surrogacy agreement filed with the  
25 court shall be sealed, exempt from public disclosure under ORS 192.311  
26 to 192.478 and may not be disclosed except:

27       “(a) To a party to the proceeding;

28       “(b) To a child conceived by assisted reproduction under the agree-  
29 ment;

30       “(c) To an attorney of a party to the proceeding or a child conceived



1 by assisted reproduction under the agreement;

2 “(d) The court; or

3 “(e) Pursuant to a court order for good cause shown, and subject  
4 to the provisions of ORS 192.324.

5 “(2) The individual seeking to inspect the document may be re-  
6 quired to pay the expense of preparing a copy of the document to be  
7 inspected.

8 “SECTION 68. UPA 807. Exclusive, continuing jurisdiction. During  
9 the period after the execution of a gestational surrogacy agreement  
10 until 90 days after the birth of a child conceived by assisted repro-  
11 duction under the agreement, a court of this state conducting a pro-  
12 ceeding in which the parentage of the child is a relevant fact has  
13 exclusive, continuing jurisdiction over all matters arising out of the  
14 agreement. Nothing in this section grants the court jurisdiction to  
15 make or enforce a judgment of support or a child custody determi-  
16 nation if the court does not otherwise have such jurisdiction.

17 “SECTION 69. UPA 808. Termination of gestational surrogacy  
18 agreement. (1) A party to a gestational surrogacy agreement may  
19 terminate the agreement, at any time before an embryo transfer, by  
20 giving written notice of termination to all other parties. If an embryo  
21 transfer does not result in a pregnancy, a party may terminate the  
22 agreement at any time before a subsequent embryo transfer.

23 “(2) Unless a gestational surrogacy agreement provides otherwise,  
24 on termination of the agreement under subsection (1) of this section,  
25 the parties are released from the agreement, except that each intended  
26 parent remains responsible for expenses that are reimbursable under  
27 the agreement and incurred by the gestational surrogate through the  
28 date of termination.

29 “(3) Except in a case involving fraud, neither a gestational surro-  
30 gate nor the surrogate’s spouse or former spouse, if any, is liable to

1 the intended parent or parents for a penalty or liquidated damages, for  
2 terminating a gestational surrogacy agreement under this section.

3 **“SECTION 70. UPA 809. Parentage under gestational surrogacy**  
4 **agreement.** (1) Except as otherwise provided in subsection (3) of this  
5 section or section 71 (2) or 74 of this 2025 Act, on birth of a child con-  
6 ceived by assisted reproduction under a gestational surrogacy agree-  
7 ment, each intended parent is, by operation of law, a parent of the  
8 child.

9 “(2) Except as otherwise provided in subsection (3) of this section  
10 or section 74 of this 2025 Act, neither a gestational surrogate nor the  
11 surrogate’s spouse or former spouse, if any, is a parent of the child.

12 “(3)(a) If a child is alleged to be a genetic child of the individual  
13 who agreed to be a gestational surrogate, the court:

14 “(A) Shall order genetic testing of the child as provided in sections  
15 39 to 51 of this 2025 Act; or

16 “(B) Upon the joint request of the individual and the intended par-  
17 ent or parents, shall admit a report of genetic testing as evidence of  
18 the truth of the facts asserted in the report if the parties voluntarily  
19 consent to genetic testing that complies with sections 39 to 51 of this  
20 2025 Act.

21 “(b) If the individual is presumed to be a genetic parent of the child  
22 as provided in section 45 of this 2025 Act, the child is not a child con-  
23 ceived by assisted reproduction under a surrogacy agreement for pur-  
24 poses of establishing parentage of the child under ORS 109.065.

25 “(4) Except as otherwise provided in subsection (3) of this section  
26 or section 71 (2) or 74 of this 2025 Act, each intended parent of a child  
27 conceived by assisted reproduction under a gestational surrogacy  
28 agreement is a parent of the child if, due to a clinical or laboratory  
29 error, the child is not genetically related to an intended parent or to  
30 a donor who donated to the intended parent or parents, subject to any

1 other claim of parentage.

2 **“SECTION 71. UPA 810. Gestational surrogacy agreement; parent-**  
3 **age of deceased intended parent.** (1) Section 70 of this 2025 Act applies  
4 to an intended parent even if the intended parent dies during the pe-  
5 riod between the transfer resulting in a pregnancy and the birth of the  
6 child.

7 **“(2) Except as otherwise provided in section 74 of this 2025 Act, an**  
8 **intended parent who dies before the transfer resulting in a child con-**  
9 **ceived by assisted reproduction under a gestational surrogacy agree-**  
10 **ment is the child’s parent only if:**

11 **“(a) The agreement provides that the intended parent would be the**  
12 **parent of a child conceived by a transfer occurring after the intended**  
13 **parent’s death; and**

14 **“(b) The transfer occurs not later than 24 months after the death**  
15 **of the intended parent.**

16 **“SECTION 72. UPA 811. Gestational surrogacy agreement; judgment**  
17 **of parentage.** (1) Except as otherwise provided in section 70 (3) of this  
18 2025 Act, before, on or after the birth of a child conceived by assisted  
19 reproduction under a gestational surrogacy agreement, a party to the  
20 agreement may commence a proceeding in the circuit court for a  
21 judgment:

22 **“(a) Declaring that each intended parent is a parent of the child and**  
23 **ordering that parental rights and duties vest immediately on the birth**  
24 **of the child exclusively in each intended parent;**

25 **“(b) Declaring that the gestational surrogate and the surrogate’s**  
26 **spouse or former spouse, if any, are not the parents of the child;**

27 **“(c) To protect the privacy of the child and the parties, declaring**  
28 **that the court record is not open to inspection, except as authorized**  
29 **under section 67 of this 2025 Act;**

30 **“(d) If necessary, that the child be surrendered to the intended**

1 **parent or parents; and**

2 **“(e) For other relief the court determines necessary and proper.**

3 **“(2) The court may issue a judgment under subsection (1) of this**  
4 **section before the birth of the child but the court shall stay enforce-**  
5 **ment of the judgment until the birth of the child and shall order one**

11 **“(2) ‘Donor’ has the meaning given that term in section 2 of this**

1 25.287 concerning existing child support orders;

2 “(g) Shall establish and enforce obligations to provide medical insurance  
3 coverage for dependent children;

4 “(h) Shall ensure compliance with the provisions of 42 U.S.C. 651 to 669  
5 and 45 C.F.R. Chapter III as authorized by state law;

6 “(i) Shall carry out the policy of the State of Oregon regarding child  
7 support obligations as expressed in ORS 25.502; and

8 “(j) Shall ensure that child support orders are in compliance with the  
9 formula established by this chapter.

10 “(5) In any proceeding under subsection (4) of this section, the parties are  
11 those described in ORS 25.503.

16 have standing, solely by virtue of the consolidation, in every action subject  
17 to the order of consolidation. Parties must comply with provisions for  
18 intervention or participation in a particular action under the provisions of  
19 law applicable to that action.

20       “(4) Upon entry of an order of consolidation, all pending issues pertaining  
21 to the actions subject to the order shall be heard together in juvenile court.  
22 The court shall hear the juvenile matters first unless the court finds that it  
23 is in the best interest of the child or ward to proceed otherwise.

24       “(5) A judge shall make and modify orders and findings in actions subject  
25 to the order of consolidation upon the filing of proper motions and notice  
26 as provided by law applicable to the actions. Any findings, orders or mod-  
27 ifications must be consistent with the juvenile court orders, and persons who  
28 were parties to the juvenile court action may not relitigate issues in con-  
29 solidated actions.

30       “(6) The judge shall set out separately from orders entered under this

1 chapter or ORS chapter 419C any orders or judgments made in other actions  
2 subject to the consolidation order. The trial court administrator shall file the  
3 orders and judgments in the appropriate actions subject to the consolidation  
4 order. An order or judgment in an individual juvenile court action is final  
5 if it finally disposes of the rights and duties of the parties to that action,  
6 without reference to whether the order or judgment disposes of the rights  
7 and duties of the parties to another action with which the action has been  
8 consolidated.

9 “(7)(a) When the actions described in subsection (2) of this section exist  
10 in two or more circuit courts, the judges assigned to the actions shall confer  
11 to determine the appropriate court in which to consolidate and hear the  
12 actions. The judges shall confer not later than 10 judicial days after a court  
13 has received notice of the existence of an action in another circuit court.

14 “(b) If the judges agree on the circuit court in which the actions should  
15 be consolidated, the judges shall take such action as is necessary to consol-  
16 idate the actions in the circuit court.

17 “(c) If the judges do not agree on the circuit court in which the actions  
18 should be consolidated, the actions must be consolidated in the court in  
19 which the juvenile action is filed or, if more than one juvenile action is  
20 pending, in the court in which the first juvenile action was filed.

28 mons and a true copy of the petition on the parent, as provided in ORS

1 419B.839 (1)(d) or 419B.875 (1)(a)(C) also must be served with summons and

12 “(d) A statement that, if the parent is represented by an attorney, the  
13 parent has the responsibility to maintain contact with the parent’s attorney  
14 and to keep the attorney advised of the parent’s whereabouts.

15 “(e) A statement that, if the parent is represented by an attorney, the  
16 parent must appear personally at any hearing where the parent is required  
17 to appear. The statement must explain that ‘appear personally’ does not in-  
18 clude appearance through the parent’s attorney.

19 “(f) A statement that, if the court has granted the parent an exception in  
20 advance under ORS 419B.918, the parent may appear in any manner permit-  
21 ted by the court under ORS 419B.918.

22 “(5) If the summons requires the parent to appear before the court to ad-  
23 mit or deny the allegations of the petition or requires the parent to file a  
24 written answer to the petition, the summons must advise the parent that, if  
25 the parent contests the petition, the court:

26 “(a) Will schedule a hearing on the allegations of the petition and order  
27 the parent to appear personally; and

1 ployment of process, of a judicial, administrative or other action or pro-  
2 ceeding against the owner that was or could have been commenced before

6 judgment entered before the entry of the order of appointment;

8 “(a) For the future care and custody, by one party or jointly, of all minor  
9 children of the parties born, adopted or conceived during the marriage and  
10 for minor children born to the parties prior to the marriage, as the court  
11 may deem just and proper under ORS 107.137. The court may hold a hearing  
12 to decide the custody issue prior to any other issues. When appropriate, the  
13 court shall recognize the value of close contact with both parents and en-  
14 courage joint parental custody and joint responsibility for the welfare of the

16 “(b) For parenting time rights of the parent not having custody of such  
17 children and for visitation rights pursuant to a petition filed under ORS  
18 109.119. When a parenting plan has been developed as required by ORS  
19 107.102, the court shall review the parenting plan and, if approved, incorpo-

21 a final order, the parenting plan is determinative of parenting time rights.  
22 If the parents have been unable to develop a parenting plan or if either of

25 the noncustodial parent sufficient access to the child to provide for appro-

5 12101 et seq.), the court may consider the noncustodial parent's disability in

8 likely endanger the health, safety or welfare of the child. The court shall  
9 recognize the value of close contact with both parents and encourage, when  
10 practicable, joint responsibility for the welfare of such children and exten-  
11 sive contact between the minor children of the divided marriage and the  
12 parties. If the court awards parenting time to a noncustodial parent who has  
13 committed abuse, other than being convicted for rape as described in this  
14 paragraph, the court shall make adequate provision for the safety of the  
15 child and the other parent in accordance with the provisions of ORS 107.718

17 “(c) For the support of the children of the marriage by the parties. In  
18 ordering child support, the formula established under ORS 25.275 shall apply.  
19 The court may at any time require an accounting from the custodial parent  
20 with reference to the use of the money received as child support. The court  
21 is not required to order support for any minor child who has become self-  
22 supporting, emancipated or married or for any child who has ceased to attend  
23 school after becoming 18 years of age. A general judgment entered under this  
24 section may include an amount for support as requested in a petition filed  
25 under ORS 107.085 or under a motion for relief made pursuant to ORS 107.095

28 nonrequesting party, and the amount shall be considered a request for relief

1       “(d) For spousal support, an amount of money for a period of time as may  
2 be just and equitable for one party to contribute to the other, in gross or in  
3 installments or both. Unless otherwise expressly provided in the judgment  
4 and except for any unpaid balance of previously ordered spousal support, li-  
5 ability for the payment of spousal support shall terminate on the death of  
6 either party, and there shall be no liability for either the payment of spousal  
7 support or for any payment in cash or property as a substitute for the pay-  
8 ment of spousal support after the death of either party. The court may ap-  
9 prove an agreement for the entry of an order for the support of a party. A  
10 general judgment entered under this section may include an amount for

17 der, the court shall designate one or more categories of spousal support and  
18 shall make findings of the relevant factors in the decision. The court may

20       “(A) Transitional spousal support as needed for a party to attain educa-  
21 tion and training necessary to allow the party to prepare for reentry into the  
22 job market or for advancement therein. The factors to be considered by the  
23 court in awarding transitional spousal support include but are not limited  
24 to:

25       “(i) The duration of the marriage;

26       “(ii) A party’s training and employment skills;

27       “(iii) A party’s work experience;

28       “(iv) The financial needs and resources of each party;

29       “(v) The tax consequences to each party;

30       “(vi) A party’s custodial and child support responsibilities; and

1       “(vii) Any other factors the court deems just and equitable.

2       “(B) Compensatory spousal support when there has been a significant fi-  
3 nancial or other contribution by one party to the education, training, voca-  
4 tional skills, career or earning capacity of the other party and when an order  
5 for compensatory spousal support is otherwise just and equitable in all of the  
6 circumstances. The factors to be considered by the court in awarding  
7 compensatory spousal support include but are not limited to:

8       “(i) The amount, duration and nature of the contribution;

9       “(ii) The duration of the marriage;

10       “(iii) The relative earning capacity of the parties;

11       “(iv) The extent to which the marital estate has already benefited from  
12 the contribution;

13       “(v) The tax consequences to each party; and

14       “(vi) Any other factors the court deems just and equitable.

15       “(C) Spousal maintenance as a contribution by one spouse to the support  
16 of the other for either a specified or an indefinite period. The factors to be  
17 considered by the court in awarding spousal maintenance include but are not  
18 limited to:

19       “(i) The duration of the marriage;

20       “(ii) The age of the parties;

21       “(iii) The health of the parties, including their physical, mental and  
22 emotional condition;

23       “(iv) The standard of living established during the marriage;

24       “(v) The relative income and earning capacity of the parties, recognizing  
25 that the wage earner’s continuing income may be a basis for support distinct  
26 from the income that the supported spouse may receive from the distribution  
27 of marital property;

28       “(vi) A party’s training and employment skills;

29       “(vii) A party’s work experience;

30       “(viii) The financial needs and resources of each party;

1       “(ix) The tax consequences to each party;

2       “(x) A party’s custodial and child support responsibilities; and

3       “(xi) Any other factors the court deems just and equitable.

4       “(e) For the delivery to one party of such party’s personal property in the  
5 possession or control of the other at the time of the giving of the judgment.

6       “(f) For the division or other disposition between the parties of the real  
7 or personal property, or both, of either or both of the parties as may be just  
8 and proper in all the circumstances. In determining the division of property  
9 under this paragraph, the following apply:

10       “(A) A retirement plan or pension or an interest therein shall be consid-  
11 ered as property.

12       “(B) The court shall consider the contribution of a party as a homemaker  
13 as a contribution to the acquisition of marital assets.

14       “(C) Except as provided in subparagraph (D) of this paragraph, there is  
15 a rebuttable presumption that both parties have contributed equally to the  
16 acquisition of property during the marriage, whether such property is jointly  
17 or separately held.

18       “(D)(i) Property acquired by gift to one party during the marriage and  
19 separately held by that party on a continuing basis from the time of receipt  
20 is not subject to a presumption of equal contribution under subparagraph (C)

22       “(ii) For purposes of this subparagraph, ‘property acquired by gift’ means  
23 property acquired by one party through gift, devise, bequest, operation of  
24 law, beneficiary designation or inheritance.

25       “(E) Subsequent to the filing of a petition for annulment or dissolution  
26 of marriage or separation, the rights of the parties in the marital assets shall  
27 be considered a species of co-ownership, and a transfer of marital assets un-  
28 der a judgment of annulment or dissolution of marriage or of separation en-  
29 tered on or after October 4, 1977, shall be considered a partitioning of jointly  
30 owned property.

1       “(F) The court shall require full disclosure of all assets by the parties in  
2 arriving at a just property division.

3       “(G) In arriving at a just and proper division of property, the court shall  
4 consider reasonable costs of sale of assets, taxes and any other costs rea-  
5 sonably anticipated by the parties.

6       “(H)(i) If a party has been awarded spousal support in lieu of a share of  
7 property, the court shall so state on the record and shall order the obligor  
8 to provide for and maintain life insurance in an amount commensurate with  
9 the obligation and designating the obligee as beneficiary for the duration of  
10 the obligation.

11       “(ii) The obligee or attorney of the obligee shall cause a certified copy  
12 of the judgment to be delivered to the life insurance company or companies.

13       “(iii) If the obligee or the attorney of the obligee delivers a true copy of  
14 the judgment to the life insurance company or companies, identifying the  
15 policies involved and requesting such notification under this section, the  
16 company or companies shall notify the obligee, as beneficiary of the insur-  
17 ance policy, whenever the policyholder takes any action that will change the  
18 beneficiary or reduce the benefits of the policy. Either party may request  
19 notification by the insurer when premium payments have not been made. If  
20 the obligor is ordered to provide for and maintain life insurance, the obligor  
21 shall provide to the obligee a true copy of the policy. The obligor shall also  
22 provide to the obligee written notice of any action that will reduce the  
23 benefits or change the designation of the beneficiaries under the policy.

24       “(g) For the creation of trusts as follows:

25       “(A) For the appointment of one or more trustees to hold, control and  
26 manage for the benefit of the children of the parties, of the marriage or  
27 otherwise such of the real or personal property of either or both of the par-  
28 ties, as the court may order to be allocated or appropriated to their support  
29 and welfare, and to collect, receive, expend, manage or invest any sum of  
30 money awarded for the support and welfare of minor children of the parties.

1       “(B) For the appointment of one or more trustees to hold, manage and  
2 control such amount of money or such real or personal property of either  
3 or both of the parties, as may be set aside, allocated or appropriated for the  
4 support of a party.

5       “(C) For the establishment of the terms of the trust and provisions for the  
6 disposition or distribution of such money or property to or between the  
7 parties, their successors, heirs and assigns after the purpose of the trust has  
8 been accomplished. Upon petition of a party or a person having an interest  
9 in the trust showing a change of circumstances warranting a change in the  
10 terms of the trust, the court may make and direct reasonable modifications  
11 in its terms.

12       “(h) To change the name of either spouse to a name the spouse held before  
13 the marriage. The court shall order a change if it is requested by the affected  
14 party.

15       “(i) For a money award for any sums of money found to be then remaining  
16 unpaid upon any order or limited judgment entered under ORS 107.095. If a  
17 limited judgment was entered under ORS 107.095, the limited judgment shall  
18 continue to be enforceable for any amounts not paid under the limited  
19 judgment unless those amounts are included in the money award made by the  
20 general judgment.

21       “(j) For an award of reasonable attorney fees and costs and expenses  
22 reasonably incurred in the action in favor of a party or in favor of a party’s  
23 attorney.

24       “(2) In determining the proper amount of support and the proper division  
25 of property under subsection (1)(c), (d) and (f) of this section, the court may  
26 consider evidence of the tax consequences on the parties of its proposed  
27 judgment.

28       “(3) Upon the filing of the judgment, the property division ordered shall  
29 be deemed effective for all purposes. This transfer by judgment, which shall  
30 affect solely owned property transferred to the other spouse as well as com-

1 monly owned property in the same manner as would a declaration of a re-  
2 sulting trust in favor of the spouse to whom the property is awarded, is not

4 “(4) If an appeal is taken from a judgment of annulment or dissolution

6 attorney copies of any information that the department has filed with the

8 “(c) Information gathered by the department or by an Oregon licensed  
9 adoption agency during the preparation of the placement report may include  
10 information concerning the child’s social, medical and genetic history and  
11 the birth parent’s history as may be required by ORS 109.301, 109.302 or  
12 109.342.

13 “(d) The court shall file and retain the placement report filed under this  
14 subsection in the same location in the records, papers and files in the court’s  
15 record of the adoption case as the petition and exhibits filed under ORS

12 432.228 or 432.250, and the paternity or parentage of the person has been  
13 determined by DNA (deoxyribonucleic acid) testing or by other means, the  
14 person may apply to the Center for Health Statistics to add or change the  
15 name of a [*biological*] **genetic** parent on the original record of live birth.

16 “(2) An application under this section must include:

17 “(a) Evidence of a DNA test or other evidence that shows that the person  
18 whose name is to be entered as a [*biological*] **genetic** parent is the  
19 [*biological*] **genetic** parent of the applicant; and

20 “(b)(A) If the person whose name is to be entered as a [*biological*] **genetic**  
21 parent is living, an affidavit attesting that the person is a [*biological*] **ge-**  
22 **netic** parent of the applicant and that the name to be entered is that of the  
23 [*biological*] **genetic** parent that was omitted from the original record of live  
24 birth; or

25 “(B) If the person whose name is to be entered as a [*biological*] **genetic**  
26 parent is deceased, an affidavit from the personal representative or a relative  
27 of the person attesting that the person is a [*biological*] **genetic** parent of the  
28 applicant and that the name to be entered is that of the [*biological*] **genetic**  
29 parent that was omitted from the original record of live birth.

30 “(3) If the name of a [*biological*] **genetic** parent is entered on an original

1 record of live birth under this section:

2 “(a) A person may only obtain a noncertified copy of a record of live birth  
3 amended under this section.

4 “(b) A notation indicating that the record was amended must be shown  
5 on all copies of the record.

6 “(c) The center shall prominently display the following language on all  
7 copies of the record: ‘THIS RECORD OF LIVE BIRTH MAY NOT BE USED

19 “**SECTION 149.** ORS 432.295 is amended to read:

20 “432.295. (1) In consultation with the State Archivist, the State Registrar  
21 of the Center for Health Statistics shall develop and implement a preserva-  
22 tion management program to preserve vital record documents and informa-  
23 tion and meet generally accepted standards for permanent preservation.

24 “(2) The state registrar shall prepare typewritten, photographic, electronic  
25 or other reproductions of vital records or reports kept and maintained in the  
26 Center for Health Statistics. These reproductions, when verified and ap-  
27 proved by the state registrar, shall be accepted as the original vital record  
28 documents. The original vital record documents from which permanent re-  
29 productions have been made may be disposed of as described in ORS 192.105

11 have elapsed after the date of fetal death for fetal deaths occurring after 1964  
12 or 50 years have elapsed after the date of marriage, domestic partnership,  
13 dissolution of marriage or dissolution of domestic partnership for such events  
14 occurring after 1964. Supporting documents, including corrections and ac-  
15 knowledgments of paternity **or parentage**, may be included with historic  
16 vital records. Records under seal are not historic unless unsealed by court  
17 order.

18 “(5) Historic vital records shall be transferred to the State Archives in  
19 accordance with archival procedures for the continued safekeeping of the  
20 vital records. The State Archives may not charge the Center for Health  
21 Statistics for the transfer and maintenance of historic vital records under  
22 this subsection. The state registrar shall adopt rules to ensure that the re-  
23 lease of information contained in records of birth, death, marriage, domestic  
24 partnership and dissolution of marriage or domestic partnership, and reports  
25 of fetal death, comply with federal and state laws, regulations and rules.
