**PROPOSED AMENDMENTS TO  
HOUSE BILL 2208**

1 On page 1 of the printed bill, delete lines 5 through 29 and delete page  
2 2 and insert:

3 **“SECTION 1. ORS 414.577 is added to and made a part of ORS**  
4 **chapter 414.**

5 **“SECTION 2. ORS 414.577 is amended to read:**

6 **“414.577. (1) As used in this section:**

7 **“(a) ‘Local mental health authority’ has the meaning given that**  
8 **term in ORS 430.630.**

9 **“(b) ‘Local planning committee’ has the meaning given that term**  
10 **in ORS 430.306.**

11 **“[(1)] (2) A coordinated care organization shall collaborate with local**  
12 **public health authorities, community mental health programs, local**  
13 **planning committees and hospitals located in areas served by the coordi-**  
14 **nated care organization to conduct a community health assessment and adopt**  
15 **a community health improvement plan, shared with and endorsed by the co-**  
16 **ordinated care organization, local public health authorities, community**  
17 **mental health programs, local planning committees and hospitals, to**  
18 **serve as a strategic population health and health care services plan for the**  
19 **residents of the areas served by the coordinated care organization, local**  
20 **public health authorities, community mental health programs, local**  
21 **planning committees and hospitals. The community health improvement**

1 plan must include strategies for achieving shared priorities.

2 “(3)(a) **Local public health authorities, community mental health**  
3 **programs and coordinated care organizations shall include in the**  
4 **community health improvement plan any behavioral health plans re-**  
5 **quired by law or by the Oregon Health Authority, including:**

6 “(A) **Comprehensive local plans adopted by local mental health au-**  
7 **thorities under ORS 430.630 (9); and**

8 “(B) **Comprehensive behavioral health plans developed by coordi-**  
9 **nated care organizations.**

10 “(b) **The inclusion in the community health improvement plan of**  
11 **the behavioral health plans described in paragraph (a) of this sub-**  
12 **section does not change the party that is responsible for developing**  
13 **or implementing a behavioral health plan described in paragraph (a)**  
14 **of this subsection.**

15 “[2] (4) The coordinated care organization shall post the **community**  
16 health improvement plan to the coordinated care organization’s website.

17 “[3] (5) The [*Oregon Health*] authority [*may*] **shall** prescribe by rule re-  
18 quirements for **community** health improvement plans and provide guidance  
19 for aligning:

20 “(a) The timelines for the development of the community health assess-  
21 ments and **community** health improvement plans by coordinated care or-  
22 ganizations, local public health authorities, **community mental health**  
23 **programs, local planning committees** and hospitals; and

24 “(b) **The requirements of this section with other planning or re-**  
25 **porting requirements that coordinated care organizations are subject**  
26 **to, including planning or reporting requirements regarding:**

27 “(A) **Health inequities;**

28 “(B) **Social determinants of health;**

29 “(C) **Health technology;**

30 “(D) **Payment models;**

1       **“(E) Oral health integration;**

2       **“(F) Language access; and**

3       **“(G) Traditional health worker integration and utilization.**

4       **“SECTION 3. The amendments to ORS 414.577 by section 2 of this**  
5 **2025 Act apply to community health improvement plans adopted on or**  
6 **after the effective date of this 2025 Act.”.**
