**PROPOSED AMENDMENTS TO  
SENATE BILL 133**

1 Delete lines 4 through 8 of the printed bill and insert:

2 **“SECTION 1. (1) As used in this section:**

3 **“(a) ‘Community living support’ includes attendant care, skills**  
4 **training and relief care.**

5 **“(b) ‘Day support activities’ means attendant care delivered during**  
6 **scheduled, structured activities in a nonresidential setting that focuses**  
7 **on maintaining or enhancing the skills needed by an individual with**  
8 **an intellectual or developmental disability to engage in the individual’s**  
9 **community.**

10 **“(c) ‘Direct support professional’ means an employee of a provider**  
11 **agency who provides attendant care to individuals receiving employ-**  
12 **ment services, supported living services, day support activities, in-**  
13 **home or community living support services or services in a residential**  
14 **training facility or residential training home.**

15 **“(d) ‘Employment services’ means individualized, evidence-based**  
16 **services provided to an individual with an intellectual or develop-**  
17 **mental disability to assist the individual in choosing, securing and**  
18 **retaining work in an integrated employment setting.**

19 **“(e) ‘Provider agency’ means an entity that provides:**

20 **“(A) Services to individuals in residential training facilities or res-**  
21 **idential training homes;**

- 1       **“(B) In-home services;**
- 2       **“(C) Supported living services;**
- 3       **“(D) Employment services;**
- 4       **“(E) Day support activities; or**
- 5       **“(F) Community living support.**

6       **“(f) ‘Residential training facility’ and ‘residential training home’**  
7 **have the meanings given those terms in ORS 443.400.**

8       **“(g) ‘Supported living services’ means services that provide an in-**  
9 **dividual with an intellectual or developmental disability the ability to**  
10 **live in the community where the individual wants, with whom the in-**  
11 **dividual wants, for as long as the individual desires.**

12       **“(2) When the Department of Human Services enters into a con-**  
13 **tract with a provider agency for the provision of services to individuals**  
14 **with intellectual or developmental disabilities by direct support pro-**  
15 **fessionals, the department shall adjust the payments made under the**  
16 **contract for inflation as provided in subsection (3) of this section.**

17       **“(3) No later than April 30 of each year, the department shall cal-**  
18 **culate the adjustment of the payments described in subsection (2) of**  
19 **this section based on the percentage increase, if any, from March of**  
20 **the preceding year to March of the year in which the calculation is**  
21 **made in the U.S. City Average Consumer Price Index for All Urban**  
22 **Consumers (All Items) as published by the Bureau of Labor Statistics**  
23 **of the United States Department of Labor or its successor.**

24       **“(4) Any adjustment calculated under subsection (3) of this section**  
25 **shall take effect on July 1 of the year in which the calculation is**  
26 **made.”.**
