**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 3940**

1 On page 1 of the printed A-engrossed bill, line 2, after “wildfire;” delete
2 the rest of the line and lines 3 through 6 and insert “creating new provisions;
3 amending ORS 242.702, 291.055, 321.005, 321.011, 321.012, 321.015, 323.500,
4 323.505, 323.510, 323.515, 323.625, 477.001, 477.205, 477.230, 477.232, 477.270,
5 477.277, 477.281, 477.295, 477.440, 477.445, 477.450, 477.455, 477.460, 477.750,
6 477.755, 477.760, 477.770, 477.775, 477.777, 478.010, 478.120, 478.140, 526.122 and
7 section 20, chapter 592, Oregon Laws 2021; repealing ORS 476.310, 476.320,
8 476.330, 476.340, 477.415, 477.880, 477.960, 477.970 and 526.123; prescribing an
9 effective date; and providing for revenue raising that requires approval by
10 a three-fifths majority.”.

11 Delete lines 8 through 19 and delete pages 2 through 20 and insert:

13 **“ORAL NICOTINE PRODUCTS TAX**

14
15 **“SECTION 1. Section 2 of this 2025 Act is added to and made a part**
16 **of ORS 323.500 to 323.645.**

17 **“SECTION 2. (1) In addition to and not in lieu of any other taxes,**
18 **a tax is imposed on the distribution of oral nicotine products in this**
19 **state. The tax imposed by this section is intended to be a direct tax**
20 **on the consumer, for which payment upon distribution is required to**
21 **achieve convenience and facility in the collection and administration**

1 of the tax. The tax shall be imposed on a distributor at the time the
2 distributor distributes oral nicotine products.

3 “(2) The tax imposed under this section shall be imposed at the
4 following rates:

5 “(a) For each package containing 20 or fewer discrete consumable
6 units, 65 cents; and

7 “(b) For each package containing more than 20 discrete consumable
8 units, 3.25 cents per discrete consumable unit, rounded to the nearest
9 whole cent.

10 “SECTION 3. The balance of moneys received by the Department
11 of Revenue under the tax imposed on oral nicotine products under
12 section 2 of this 2025 Act, after payment of expenses, refunds and
13 credits under ORS 323.625, shall be distributed as follows:

14 “(1) One-third of the moneys shall be deposited in the Landscape
15 Resiliency Fund established under ORS 477.502; and

16 “(2) Two-thirds of the moneys shall be deposited in the Community
17 Risk Reduction Fund established under ORS 476.396.

18 “SECTION 4. ORS 323.500 is amended to read:

19 “323.500. As used in ORS 323.500 to 323.645, unless the context otherwise
20 requires:

21 “(1) ‘Business’ means any trade, occupation, activity or enterprise engaged
22 in for the purpose of selling or distributing tobacco products in this state.

23 “(2) ‘Cigar’ means a roll for smoking that is of any size or shape and that
24 is made wholly or in part of tobacco, irrespective of whether the tobacco is
25 pure or flavored, adulterated or mixed with any other ingredient, if the roll
26 has a wrapper made wholly or in greater part of tobacco and if 1,000 of these
27 rolls collectively weigh more than three pounds. ‘Cigar’ does not include a
28 cigarette, as defined in ORS 323.010.

29 “(3) ‘Consumer’ means any person who purchases tobacco products in this
30 state for the person’s use or consumption or for any purpose other than for

1 reselling the tobacco products to another person.

2 “(4) ‘Contraband tobacco products’ means tobacco products or packages
3 containing tobacco products:

4 “(a) That do not comply with the requirements of ORS 323.500 to 323.645;

5 “(b) That do not comply with the requirements of the tobacco products
6 tax laws of the federal government or of other states;

7 “(c) That bear trademarks that are counterfeit under ORS 647.135 or other
8 state or federal trademark laws; or

9 “(d) That have been sold, offered for sale or possessed for sale in this
10 state in violation of ORS 180.486.

11 “(5) ‘Department’ means the Department of Revenue.

12 “(6) ‘Distribute’ means:

13 “(a) Bringing, or causing to be brought, into this state from without this
14 state tobacco products for sale, storage, use or consumption;

15 “(b) Making, manufacturing or fabricating tobacco products in this state
16 for sale, storage, use or consumption in this state;

17 “(c) Shipping or transporting tobacco products to retail dealers in this
18 state, to be sold, stored, used or consumed by those retail dealers;

19 “(d) Storing untaxed tobacco products in this state that are intended to
20 be for sale, use or consumption in this state;

21 “(e) Selling untaxed tobacco products in this state; or

22 “(f) As a consumer, being in possession of untaxed tobacco products in
23 this state.

24 “(7) ‘Distributor’ means:

25 “(a) Any person engaged in the business of selling tobacco products in
26 this state who brings, or causes to be brought, into this state from without
27 the state any tobacco products for sale;

28 “(b) Any person who makes, manufactures or fabricates tobacco products
29 in this state for sale in this state;

30 “(c) Any person engaged in the business of selling tobacco products

1 without this state who ships or transports tobacco products to retail dealers
2 in this state, to be sold by those retail dealers;

3 “(d) Any person, including a retail dealer, who sells untaxed tobacco
4 products in this state; or

5 “(e) A consumer in possession of untaxed tobacco products in this state.

6 “(8)(a) ‘Inhalant delivery system’ means:

7 “(A) A device that can be used to deliver nicotine in the form of a vapor
8 or aerosol to a person inhaling from the device; or

9 “(B) A component of a device described in this paragraph or a substance
10 in any form sold for the purpose of being vaporized or aerosolized by a device
11 described in this paragraph, whether the component or substance is sold
12 separately or is not sold separately.

13 “(b) ‘Inhalant delivery system’ does not include:

14 “(A) Any product that has been approved by the United States Food and
15 Drug Administration for sale as a tobacco cessation product or for any other
16 therapeutic purpose, if the product is marketed and sold solely for the ap-
17 proved purpose;

18 “(B) If sold separately, battery chargers, straps or lanyards; or

19 “(C) Marijuana items as defined in ORS 475C.009.

20 “(9) ‘Manufacturer’ means a person who manufactures tobacco products
21 for sale.

22 “(10) ‘Moist snuff’ means:

23 “(a) Any finely cut, ground or powdered tobacco that is not intended to
24 be smoked or placed in a nasal cavity; or

25 “(b) Any other product containing tobacco that is intended or expected
26 to be consumed without being combusted.

27 “(11)(a) **‘Oral nicotine product’ means any noncombustible product**
28 **that:**

29 **“(A) Contains nicotine derived from any source, or a nicotine ana-**
30 **log; and**

1 **“(B) Is intended for human consumption via the oral cavity by any**
2 **means other than inhalation.**

3 **“(b) ‘Oral nicotine product’ does not include:**

4 **“(A) Moist snuff; or**

5 **“(B) Any product regulated as a drug or device by the United States**
6 **Food and Drug Administration under chapter V of the Federal Food,**
7 **Drug and Cosmetic Act (21 U.S.C. 351 et seq.).**

8 “[(11)] (12) ‘Place of business’ means any place where tobacco products
9 are sold or where tobacco products are manufactured, stored or kept for the
10 purpose of sale or consumption, including any vessel, vehicle, airplane, train
11 or vending machine.

12 “[(12)] (13) ‘Retail dealer’ means any person who is engaged in the busi-
13 ness of selling or otherwise dispensing tobacco products to consumers. The
14 term also includes the operators of or recipients of revenue from all places
15 such as smoke shops, cigar stores and vending machines, where tobacco
16 products are made or stored for ultimate sale to consumers.

17 “[(13)] (14) ‘Sale’ means any transfer, exchange or barter, in any manner
18 or by any means, for a consideration, and includes and means all sales made
19 by any person. It includes a gift by a person engaged in the business of
20 selling tobacco products, for advertising, as a means of evading the pro-
21 visions of ORS 323.500 to 323.645, or for any other purpose.

22 “[(14)] (15) ‘Taxpayer’ includes a distributor or other person required to
23 pay a tax imposed under ORS 323.500 to 323.645.

24 “[(15)] (16) ‘Tobacco products’ means cigars, cheroots, stogies, periques,
25 granulated, plug cut, crimp cut, ready rubbed and other smoking tobacco,
26 snuff, snuff flour, moist snuff, cavendish, plug and twist tobacco, fine-cut and
27 other chewing tobaccos, shorts, refuse scraps, clippings, cuttings and
28 sweepings of tobacco and other kinds and forms of tobacco, prepared in such
29 manner as to be suitable for chewing or smoking in a pipe or otherwise, or
30 both for chewing and smoking, **oral nicotine products** and inhalant delivery

1 systems, but does not include cigarettes as defined in ORS 323.010.

2 “[~~(16)~~] (17) ‘Untaxed tobacco products’ means tobacco products for which
3 the tax required under ORS 323.500 to 323.645 has not been paid.

4 “[~~(17)~~] (18) ‘Wholesale sales price’ means the price paid for untaxed to-
5 bacco products to or on behalf of a seller by a purchaser of the untaxed to-
6 bacco products.

7 **“SECTION 4a.** ORS 323.505 is amended to read:

8 “323.505. (1) A tax is hereby imposed upon the distribution of [~~all~~] tobacco
9 products in this state. The tax imposed by this section is intended to be a
10 direct tax on the consumer, for which payment upon distribution is required
11 to achieve convenience and facility in the collection and administration of
12 the tax. The tax shall be imposed on a distributor at the time the distributor
13 distributes tobacco products.

14 “(2) The tax imposed under this section shall be imposed at the rate of:

15 “(a) Sixty-five percent of the wholesale sales price of cigars, but not to
16 exceed one dollar per cigar;

17 “(b) One dollar and seventy-eight cents per ounce based on the net weight
18 determined by the manufacturer, in the case of moist snuff, except that the
19 minimum tax under this paragraph is \$2.14 per retail container; or

20 “(c) Sixty-five percent of the wholesale sales price of all tobacco products
21 that are not cigars [~~or~~], moist snuff **or oral nicotine products**.

22 “(3) For reporting periods beginning on or after July 1, 2022, the rates
23 of tax applicable to moist snuff under subsection (2)(b) of this section shall
24 be adjusted for each biennium according to the cost-of-living adjustment for
25 the calendar year. The Department of Revenue shall recompute the rates for
26 each biennium by adding to the rates in subsection (2)(b) of this section the
27 product obtained by multiplying the rates in subsection (2)(b) of this section
28 by a factor that is equal to 0.25 multiplied by the percentage (if any) by
29 which the monthly averaged U.S. City Average Consumer Price Index for the
30 12 consecutive months ending August 31 of the prior calendar year exceeds

1 the monthly averaged U.S. City Average Consumer Price Index for the 12
2 consecutive months ending August 31, 2020.

3 “(4) If the tax imposed under this section does not equal an amount cal-
4 culable to a whole cent, the tax shall be equal to the next higher whole cent.
5 However, the amount remitted to the Department of Revenue by the taxpayer
6 for each quarter shall be equal only to 98.5 percent of the total taxes due
7 and payable by the taxpayer for the quarter.

8 “(5) A tax under this section is not imposed on inhalant delivery systems
9 that are:

10 “(a) Marketed and sold solely for the purpose of vaporizing or
11 aerosolizing marijuana items as defined in ORS 475C.009; or

12 “(b) Purchased in a medical marijuana dispensary that is registered under
13 ORS 475C.833 by a person to whom a registry identification card has been
14 issued under ORS 475C.783.

15 “(6) No tobacco product shall be subject to the tax if the base product
16 or other intermediate form thereof has previously been taxed under this
17 section.

18 “**SECTION 4b.** ORS 323.510 is amended to read:

19 “323.510. (1) Except as otherwise provided in ORS 323.500 to 323.645, the
20 tax imposed by ORS 323.505 and 323.565 **and section 2 of this 2025 Act** shall
21 be paid by each distributor and each common carrier or authorized person
22 specified in ORS 323.565 to the Department of Revenue on or before the last
23 day of January, April, July and October of each year for the preceding cal-
24 endar quarter.

25 “(2) With each quarterly payment, the taxpayer shall submit a return to
26 the department, in such form and containing such information as the de-
27 partment shall prescribe.

28 “(3) The tax, penalties and interest imposed by ORS 323.500 to 323.645
29 shall be a personal debt, from the time liability is incurred, owed by the
30 taxpayer to the State of Oregon until paid.

1 “(4) The returns required of distributors and common carriers or author-
2 ized persons specified in ORS 323.565 under this section shall be filed by the
3 distributors, common carriers or authorized persons regardless of whether
4 any tax is owed by them.

5 “(5)(a) The department for good cause may extend the time for making
6 any return under ORS 323.500 to 323.645. The extension may be granted at
7 any time if a written request is filed with the department within or prior to
8 the period for which the extension may be granted. The department may not
9 grant an extension of more than one month.

10 “(b) When the time for filing a return is extended at the request of a
11 taxpayer, interest shall be added at the rate established under ORS 305.220
12 from the time the return was originally required to be filed to the time of
13 payment.

14 “**SECTION 4c.** ORS 323.515 is amended to read:

15 “323.515. The tax imposed by ORS 323.505 **and section 2 of this 2025 Act**
16 does not apply with respect to any tobacco products which under the Con-
17 stitution and laws of the United States may not be made the subject of tax-
18 ation by [*the*] **this** state.

19 “**SECTION 4d.** ORS 323.625 is amended to read:

20 “323.625. All moneys received by the Department of Revenue under ORS
21 323.500 to 323.645 shall be deposited in the State Treasury and credited to a
22 suspense account established under ORS 293.445. The department may pay
23 expenses for administration and enforcement of ORS 323.500 to 323.645 out
24 of moneys received from the taxes imposed under ORS 323.505 and 323.565.
25 Amounts necessary to pay administrative and enforcement expenses are
26 continuously appropriated to the department from the suspense account. Af-
27 ter the payment of administrative and enforcement expenses and refunds or
28 credits arising from erroneous overpayments, and except as provided in ORS
29 323.627 **and section 3 of this 2025 Act**, the balance of the money shall be
30 credited to the General Fund. Of the amount credited to the General Fund

1 under this section 41.54 percent shall be dedicated to funding the mainte-
2 nance and expansion of the number of persons eligible for the medical as-
3 sistance program under ORS chapter 414, or to funding the maintenance of
4 the benefits available under the program, or both, and 4.62 percent shall be
5 credited to the Tobacco Use Reduction Account established under ORS
6 431A.153.

7 **“SECTION 4e. Section 2 of this 2025 Act applies to tobacco products**
8 **tax reporting periods beginning on or after January 1, 2026.**

9

10 **“OREGON RAINY DAY FUND INTEREST**

11

12 **“SECTION 5. (1) After each calculation of General Fund interest**
13 **attributable to the Oregon Rainy Day Fund performed under ORS**
14 **293.144 (3) after the effective date of this 2025 Act and before July 31,**
15 **2027, the Oregon Department of Administrative Services, in lieu of the**
16 **transfer described in ORS 293.144 (3), shall:**

17 **“(a) Transfer 6.7 percent of the amount calculated to the Landscape**
18 **Resiliency Fund established under ORS 477.502;**

19 **“(b) Transfer 13.3 percent of the amount calculated to the Commu-**
20 **nity Risk Reduction Fund established under ORS 476.396; and**

21 **“(c) Transfer 80 percent of the amount calculated to the Oregon**
22 **Rainy Day Fund, except as provided in ORS 293.148.**

23 **“(2) For purposes of ORS 293.148, transfers to the Oregon Rainy Day**
24 **Fund under subsection (1)(c) of this section are considered to be**
25 **transfers under ORS 293.144 (3).**

26

27 **“FOREST PRODUCTS HARVEST TAX FOR**
28 **WILDFIRE MITIGATION AND SUPPRESSION**

29

30 **“SECTION 5a. ORS 321.011 is amended to read:**

1 “321.011. The prevention and suppression of, **and preparedness for**, for-
2 est fires on forestlands for the preservation of forest resources and the con-
3 tinuous growth of timber on lands suitable therefor, are declared to be the
4 public policy of the State of Oregon. The Legislative Assembly recognizes
5 that:

6 “(1) The forested areas situated within eastern Oregon predominate in
7 Ponderosa pine trees and associated species, and that the forested areas sit-
8 uated within western Oregon predominate in Douglas fir and associated
9 species;

10 “(2) Because of this difference in species, different forest fire protection
11 problems exist in eastern and western Oregon, and different logging condi-
12 tions and circumstances in each necessitate varied forest practices in the
13 disposal of forest slashings and debris; and

14 “(3) Therefore, in order to give recognition to such differences and their
15 effect on the accomplishment of the public policy stated in this section, cer-
16 tain classifications of forestlands within the State of Oregon are established
17 by ORS 321.005 to 321.185 and 321.560 to 321.600.

18 “**SECTION 5b.** ORS 321.012 is amended to read:

19 “321.012. The Legislative Assembly finds that it is in the interest of the
20 State of Oregon that the public as a whole share responsibility for protecting
21 the forests of this state, by making funds available [*from time to time*] for
22 suppression of fires [*caused by the public*].

23 “**SECTION 6.** ORS 321.015 is amended to read:

24 “321.015. (1) For the calendar years beginning January 1, 2024, and Janu-
25 ary 1, 2025, there is levied a privilege tax of 90.00 cents per thousand feet,
26 board measure, upon taxpayers for the privilege of harvesting of all
27 merchantable forest products harvested on forestlands. Subject to ORS
28 321.145, the proceeds of the tax shall be transferred as provided in ORS
29 321.152 (2) to the Forest Research and Experiment Account for use for the
30 forest resource research, experimentation and studies described in ORS

1 526.215 and for the Forest Research Laboratory established under ORS
2 526.225.

3 “(2)(a) [*Except as provided in ORS 477.760,*] In addition to the tax levied
4 by subsection (1) of this section, there is levied a forest products harvest tax
5 upon taxpayers of [*62.5 cents*] **one dollar** per thousand feet, board measure,
6 for the privilege of harvesting all merchantable forest products harvested on
7 forestlands for the payment of benefits related to fire suppression as provided
8 in ORS 321.005 to 321.185, 321.560 to 321.600 and 477.440 to 477.460.

9 “(b)(A) **The rate set under paragraph (a) of this subsection for any**
10 **calendar year shall be adjusted by the percentage, if any, by which the**
11 **monthly averaged Consumer Price Index for All Urban Consumers,**
12 **West Region (All Items) for the 12 consecutive months ending August**
13 **31 of the prior calendar year exceeds the monthly averaged index for**
14 **the 12 consecutive months ending August 31, 2024.**

15 “(B) **The adjusted rate computed under subparagraph (A) of this**
16 **paragraph shall be rounded to the nearest one-tenth of a cent.**

17 “(3) For the calendar years beginning January 1, 2024, and January 1,
18 2025, in addition to the taxes levied under subsections (1) and (2) of this
19 section, there is levied a privilege tax upon taxpayers for the privilege of
20 harvesting all merchantable forest products harvested on forestlands in the
21 amount of 253.46 cents per thousand feet, board measure, for the purpose of
22 administering the Oregon Forest Practices Act in an amount not to exceed
23 40 percent of the total expenditures approved by the Legislative Assembly for
24 this purpose, including salary adjustments approved by the Legislative As-
25 sembly for fiscal years 2024 and 2025.

26 “(4) For the calendar years beginning January 1, 2024, and January 1,
27 2025, in addition to the taxes levied by subsections (1) to (3) of this section,
28 there is levied a privilege tax of 21 cents per thousand feet, board measure,
29 upon taxpayers for the privilege of harvesting all merchantable forest pro-
30 ducts harvested on forestlands. Subject to ORS 321.145, the proceeds of the

1 tax shall be transferred as provided in ORS 321.152 (5) to the subaccount
2 established pursuant to ORS 350.520 for use by Oregon State University for
3 the purpose of making investments in professional forestry education at the
4 College of Forestry.

5 “(5) Subject to subsection (6) of this section, the taxes shall be measured
6 by and be applicable to each per thousand feet, board measure, on the total
7 quantity of forest products harvested in this state measured by use of any
8 log scale which is or may be in general use in the logging industry and
9 which is designed to measure total volume of merchantable forest products
10 in board feet. However, if the Department of Revenue finds that the scale
11 used by any taxpayer in computing the taxes due under ORS 321.005 to
12 321.185 and 321.560 to 321.600 does not accurately reflect the total quantity
13 of merchantable forest products harvested by the taxpayer, it may require the
14 taxpayer to adopt another log scale in general use in the industry which in
15 the department’s opinion will accurately reflect merchantable harvest in
16 board feet.

17 “(6) The first 25,000 feet, board measure, of forest products harvested an-
18 nually by any taxpayer during each calendar year shall be excluded from the
19 total quantity of harvested forest products that constitutes the measure of
20 the taxes under ORS 321.005 to 321.185 and 321.560 to 321.600.

21 “(7)(a) Not later than March 10 of each odd-numbered year, the Legisla-
22 tive Assembly shall begin considering the biennial forest products harvest
23 tax rates levied under subsections (1), (3) and (4) of this section.

24 “(b) Upon request of the Legislative Revenue Officer or the Legislative
25 Fiscal Officer, the State Forestry Department shall provide the respective
26 officers with relevant timber harvest data for the purposes of paragraph (a)
27 of this subsection.

28 **“SECTION 7. The amendments to ORS 321.015 by section 6 of this**
29 **2025 Act apply to calendar years beginning on or after January 1, 2026.**

30 **“SECTION 8.** ORS 321.005 is amended to read:

1 “321.005. As used in ORS 321.005 to 321.185[,] **and** 321.560 to 321.600 [*and*
2 *477.440 to 477.460*], unless the context requires otherwise:

3 “[*(1) ‘Board’ means the State Board of Forestry.*]

4 “[*(2) ‘Protected forestlands’ means those lands which are protected from the*
5 *starting or spread of fire thereon or therefrom by:*]

6 “[*(a) The State Forester, with the approval of the board;*]

7 “[*(b) The United States of America through contract with the State*
8 *Forester;*]

9 “[*(c) Any forest protective agency under contract with the State Forester or*
10 *the board pursuant to ORS 477.406; or*]

11 “[*(d) Any forest protective agency, described in paragraph (c) of this sub-*
12 *section, under an agreement with the United States of America wherein such*
13 *agency agrees to protect specific federal forestlands and, in return, the United*
14 *States of America agrees to protect specific lands of such agency.*]

15 “[*(3) ‘Department’ means the Department of Revenue.*]

16 “[*(4) ‘Committee’ means the Emergency Fire Cost Committee.*]

17 “**(1) ‘Consumer Price Index for All Urban Consumers, West Region**
18 **(All Items)’ means the Consumer Price Index for All Urban Consum-**
19 **ers, West Region (All Items), as published by the Bureau of Labor**
20 **Statistics of the United States Department of Labor.**

21 “[*(5) (2) ‘Forestland’ means any land producing forest products.*]

22 “[*(6) (3) ‘Forest products’ means products from harvested timber, but does*
23 *not include products from short rotation fiber grown under agricultural*
24 *conditions as described in ORS 321.267 (3) or 321.824 (3), western juniper or*
25 *products from harvested western juniper.*]

26 “[*(7) (4) ‘Harvest’ means the point at which timber that has been cut,*
27 *severed, or removed for purposes of sale or use is first measured in the or-*
28 *inary course of business as determined by reference to common practice in*
29 *the timber industry.*]

30 “[*(8) (5) ‘Merchantable stand of timber’ means any stand on forestlands*]

1 containing living or dead timber which is being or can be harvested.

2 “[9] *‘Taxpayer’ means the owner of timber at time of harvest.*]

3 “(6) **‘Owner of timber’ means any individual or combination of in-**
4 **dividuals, partnership, firm, corporation or association of whatever**
5 **nature holding title to harvested timber by virtue of:**

6 “(a) **An instrument of conveyance;**

7 “(b) **The harvesting of the timber; or**

8 “(c) **The harvesting of the timber and payment therefor.**

9 “[10] (7) *‘Taxes’ means the taxes provided for in ORS 321.015.*

10 “[11] *‘Owner of timber’ means any individual or combination of individ-*
11 *uals, partnership, firm, corporation or association of whatever nature holding*
12 *title to harvested timber by virtue of:]*

13 “[a] *An instrument of conveyance;*]

14 “[b] *The harvesting of the timber; or*]

15 “[c] *The harvesting of the timber and payment therefor.*]

16 “(8) **‘Taxpayer’ means the owner of timber at time of harvest.**

17 “[12] (9) *‘Timber’ means all logs which can be measured in board feet*
18 *and other forest products as determined by department rule.*

19 “**SECTION 9. ORS 477.415 is repealed.**

20

21 “REDUCTION OF WILDFIRE RISK

22

17 rangeland owners, forestland and rangeland collaboratives and other relevant
18 community organizations to identify and select landscapes for treatment and
19 develop selection criteria for projects.

21 dations regarding wildfire risk reduction on forestland and rangeland and in
22 communities, based on information obtained from the projects described in
23 [*section 18, chapter 592, Oregon Laws 2021,*] **ORS 477.503** to an interim com-
24 mittee of the Legislative Assembly related to natural resources, in the man-
25 ner provided by ORS 192.245, and to the Governor, State Wildfire Programs

8 resulting or anticipated changes in landscape conditions related to enhanced
9 resiliency or the mitigation of wildfire risk to public values;

10 “(D) The identification of existing disincentives to, and recommendation
11 for reducing barriers to, the use of prescribed fire;

12 “(E) Recommendations for creating optimal working relationships with
13 forestland or rangeland collaboratives and other relevant community organ-
14 izations regarding future wildfire risk reduction projects;

15 “(F) A description of the funding source types and amounts secured by the
16 department as matching funds to carry out projects; and

17 “(G) Recommendations for investment in future wildfire risk reduction
18 projects to be carried out in the 2023-2025 biennium.

20 ment shall work in coordination with federal land management agencies,

4 “(a) Administration of the State Forestry Department;

5 “(b) The following services, provided statewide and in areas of this
6 state by the department:

7 “(A) Fire management on forestland;

9 “(C) Other services not described in this paragraph; and

10 “(c) The procurement of supplies related to purposes described in
11 this subsection.

12 “[4] (5) ‘Department’ means the State Forestry Department.

13 “[5] (6) ‘District’ means a forest protection district organized under ORS
14 477.225.

15 “[6] (7) ‘Every reasonable effort’ means the use of the reasonably avail-
16 able personnel and equipment under the supervision and control of an owner
17 or operator, which are needed and effective to fight the fire in the judgment
18 of the forester and which can be brought to bear on the fire in a timely
19 fashion.

20 “[7] (8) ‘Fire season’ means a period designated pursuant to ORS 477.505.

21 “[8] (9) ‘Fiscal year’ means the period beginning on July 1 of any year
22 and ending on June 30 of the next year.

23 “[9] (10) ‘Forestland’ means any woodland, brushland, timberland,
24 grazing land or clearing that, during any time of the year, contains enough
25 forest growth, slashing or vegetation to constitute, in the judgment of the

17 manner that combustion air is not effectively controlled and combustion
18 products are not effectively vented through a stack or chimney.

19 “[~~(17)~~] **(18)** ‘Operation’ means any industrial activity, any development or
20 any improvement on forestland inside or within one-eighth of one mile of a
21 forest protection district, including but not limited to the harvesting of for-
22 est tree species, the clearing of land, the use of power-driven machinery and
23 the use of fire, excluding, however, the culture and harvesting of agricultural
24 crops.

25 “[~~(18)~~] **(19)** ‘Operation area’ means the area on which an operation is be-
26 ing conducted and the area on which operation activity may have resulted
27 in the ignition of a fire.

28 “[~~(19)~~] **(20)** ‘Operation in progress’ means that time when workers are on
29 an operation area for the purpose of an operation, including the period of
30 time when fire watches are required to be on the operation area pursuant

1 to ORS 477.665.

2 “[20] (21) ‘Operator’ means any person who, either personally or through
3 employees, agents, representatives or contractors, is carrying on or has car-
4 ried on any operation.

5 “[21] (22) ‘Owner’ means an individual, a combination of individuals, a
6 partnership, a corporation, the State of Oregon or a political subdivision
7 thereof, or an association of any nature that holds an ownership interest in
8 land.

9 “[22] (23) ‘Political subdivision’ includes, but is not limited to, counties,
10 cities and special districts.

11 “[23] (24) ‘Rangeland’ is defined by ORS 477.315.

12 “[24] (25) ‘Routine road maintenance’ is defined by ORS 477.625.

13 “[25] (26) ‘Side’ means any single unit of a logging operation employing
14 power-driven machinery.

15 “[26] (27) ‘Slashing’ means the forest debris or refuse on any forestland
16 resulting from the cutting, killing, pruning, severing or removal of brush,
17 trees or other forest growth.

18 “[27] (28) ‘State Forester’ means the person appointed State Forester
19 pursuant to ORS 526.031 or the person serving in the position on an interim
20 or delegated basis.

21 “[28] (29) ‘Summit of the Cascade Mountains’ is considered to be a line
22 beginning at the intersection of the northern boundary of the State of
23 Oregon and the western boundary of Wasco County; thence southerly along
24 the western boundaries of Wasco, Jefferson, Deschutes and Klamath Coun-
25 ties to the southern boundary of the State of Oregon.

2 “477.205. As used in ORS 477.205 to 477.281[, *unless the context requires*
3 *otherwise*]:

4 **“(1) ‘Budget’ means an estimate of the amount of moneys a forest**
5 **protection district needs for preparedness for, and for the prevention**
6 **and suppression of, forest fires on forestland, not including centralized**
7 **administration costs.**

16 of directors of a rural fire protection district[,] **and** the board of commis-
17 sioners of a domestic water supply corporation [*and the county court or board*
18 *of county commissioners acting under ORS 476.310 to 476.340 for the purposes*
19 *of preventing and controlling fire on zone 2 rural lands*].

20 “(9) ‘Political subdivision’ means any city, county, municipal corporation,
21 rural fire protection district[,] **or** domestic water supply corporation [*or or-*
22 *ganization authorized under ORS 476.310 to 476.340 to combat fire on zone 2*
23 *rural lands which employs four or more full-time firefighters, not including the*
24 *chief of the fire department*].

25 “(10) ‘Position’ includes any office, place or employment.
26

27 “RURAL FIRE PROTECTION DISTRICTS

28
29 “**SECTION 34.** ORS 478.010 is amended to read:

30 “478.010. (1) A rural fire protection district may be formed in the manner

1 set forth in ORS 478.010 to 478.100.

2 “(2) A district may not include:

3 “[*(a) Territory within a city unless otherwise authorized by law.*]

4 “[*(b)*] **(a)** Territory within a water supply district organized under ORS
5 chapter 264 if the district has previously been authorized by its electors to
6 exercise the fire protection powers prescribed by ORS 264.340.

7 “[*(c)*] **(b)** [*Forestlands*] **Forestland** included within a forest protection
8 district under ORS 477.205 to 477.281 unless the owner consents and notifies
9 the rural fire protection district[, *however, forestland protected pursuant to*
10 *ORS 477.205 to 477.281 and not exceeding five acres in one ownership shall*
11 *be included in the rural fire protection district without the owner’s consent if*
12 *the ownership includes any structures subject to damage by fire*], **except as**
13 **provided in subsection (3) of this section.** [*Forestland included in a rural*
14 *fire protection district under this subsection subjects the forestland to assess-*
15 *ments for fire protection by the rural fire protection district and the forest*
16 *protection district.*]

17 “[*(d)*] **(c)** Railroad rights of way or improvements thereon or rolling stock
18 moving thereover unless the owner of such property consents.

19 “[*(e)*] **(d)** Ocean shores as defined by ORS 390.605.

20 **“(3)(a) Notwithstanding subsection (2)(b) of this section, forestland**
21 **protected pursuant to ORS 477.205 to 477.281 that is within the exterior**
22 **boundaries of an existing rural fire protection district shall be included**
23 **in the rural fire protection district without the owner’s consent.**

24 **“(b) Forestland described in paragraph (a) of this subsection is**
25 **subject to limitations on assessment as described in section 36 of this**
26 **2025 Act.**

27 **“(4) Forestland protected pursuant to ORS 477.205 to 477.281 that is**
28 **included in a rural fire protection district is subject to assessments for**
29 **fire protection by the rural fire protection district and the forest pro-**
30 **tection district.**

1 **“SECTION 35. The amendments to ORS 478.010 by section 34 of this**
2 **2025 Act apply to all rural fire protection districts, whether formed**
3 **before, on or after the effective date of this 2025 Act. Forestland de-**
4 **scribed in ORS 478.010 (3)(a), as amended by section 34 of this 2025 Act,**
5 **is made part of a rural fire protection district without the district’s**
6 **taking any action to include such forestland.**

7 **“SECTION 36. (1) As used in this section, ‘qualified forestland’**
8 **means forestland that is:**

9 **“(a) Included in a rural fire protection district under ORS 478.010**
10 **(3); and**

11 **“(b) Outside the limits of a city.**

12 **“(2) If a structure exists, in whole or in part, on qualified**
13 **forestland, the property subject to taxation by a rural fire protection**
14 **district shall include the value of any structures subject to taxation**
15 **and may not exceed 10 acres in any one ownership.**

16 **“(3) If a structure does not exist on qualified forestland, the prop-**
17 **erty subject to taxation by a rural fire protection district is limited to**
18 **individual lots or parcels not exceeding 10 acres in size.**

19 **“SECTION 37. ORS 478.120 is amended to read:**

20 **“478.120. The authority to include forestland within a rural fire protection**
21 **district pursuant to ORS 478.010 [(2)(c)] (2)(b) applies to forestland within**
22 **the exterior boundaries of an existing district [*and to forestland on which***
23 ***structures subject to damage by fire have been added after July 20, 1973*].**

24 **“SECTION 38. ORS 478.140 is amended to read:**

25 **“478.140. Any owner consenting to add the forestland of the owner to the**
26 **district under ORS 478.010 [(2)(c)] (2)(b) shall do so on forms supplied by the**
27 **Department of Revenue. The owner shall file the original with the district.**
28 **The district shall forward a copy to the assessor of each county in which the**
29 **land is located, within 20 days of receipt.**

“TREASURY LOANS

4

5 **“SECTION 40. (1) As used in this section:**

6 **“(a) ‘Biennium’ means a two-year period beginning on July 1 of an**
7 **odd-numbered year.**

8 **“(b) ‘Borrowing agency’ means the State Forestry Department or**
9 **the Department of the State Fire Marshal.**

10 **“(c) ‘Borrowing fund’ has the meaning given that term in ORS**
11 **293.205.**

12 **“(d) ‘Lending fund’ has the meaning given that term in ORS 293.205.**

13 **“(e) ‘Repayment amounts’ means amounts transferred under sub-**
14 **section (2) of this section, plus any interest or borrowing costs.**

15 **“(2)(a) Notwithstanding the provisions of ORS 293.210 that limit**
16 **when the State Treasurer may transfer moneys between funds of the**
17 **State Treasury, the State Treasurer shall, at the written request of a**
18 **borrowing agency, and subject to paragraph (b) of this subsection,**
19 **transfer moneys under ORS 293.205 to 293.225 to a fund or funds under**
20 **the administration of the borrowing agency for the purpose of enabling**
21 **the agency to pay for noncapital wildfire suppression costs.**

22 **“(b) Before a transfer is made under this subsection, the State**
23 **Treasurer and the borrowing agency shall report to the Emergency**
24 **Board:**

25 **“(A) The amount requested to be transferred;**

26 **“(B) The amount of wildfire suppression costs above the borrowing**
27 **agency’s available resources; and**

28 **“(C) The balance of moneys projected to be available to repay the**
29 **amount advanced.**

30 **“(3) If the State Treasurer transfers moneys under subsection (2)**

1 of this section, the borrowing agency, no later than the second May
2 15 of the biennium in which the transfer is made, and in collaboration
3 with the Oregon Department of Administrative Services, shall certify
4 to the State Treasurer whether the balance of moneys available to the
5 borrowing agency as of the second June 15 of the same biennium will
6 be sufficient to repay the repayment amounts.

7 “(4) If the borrowing agency certifies that the balance of moneys
8 is insufficient to repay the repayment amounts:

9 “(a) The borrowing agency shall, as soon as practicable, transfer
10 all moneys available for repayment to the State Treasurer, to be
11 credited to the lending fund; and

12 “(b) There is appropriated to the borrowing agency, for the
13 biennium in which the transfer was made, out of the General Fund,
14 an amount equal to the difference between the repayment amounts
15 and the amounts transferred under paragraph (a) of this subsection,
16 for deposit in the borrowing fund for the purpose of repaying the re-
17 payment amounts.

21 “CASH FLOW REPAYMENT FUND

22

23 “SECTION 43. ORS 526.122 is amended to read:

24 “526.122. (1) The State Forestry Department Cash Flow Repayment Fund
25 is established in the State Treasury, separate and distinct from the General
26 Fund. The State Forestry Department Cash Flow Repayment Fund consists
27 of moneys deposited in the fund by the State Forestry Department pursuant
28 to subsection (2) of this section. Moneys in the fund are continuously ap-
29 propriated to the department for the purposes set forth in subsection (3) of
30 this section.

1 “(2)(a) When the State Forestry Department determines that moneys are
2 available to the department in an amount greater than necessary to satisfy
3 the current cash flow needs of the department, the department shall deposit
4 excess amounts in the State Forestry Department Cash Flow Repayment
5 Fund, except as provided in paragraph (b) of this subsection.

6 “(b) The department is not required to deposit moneys in the fund if the
7 balance of the fund is equal to or greater than the outstanding balance of
8 moneys appropriated, allocated or otherwise made available to the depart-
9 ment specifically for cash flow purposes.

10 “(c) The moneys deposited in the fund under this subsection shall not be
11 considered as a budget item on which a limitation is otherwise fixed by law,
12 but shall be in addition to any specific biennial appropriations or amounts
13 authorized to be expended from continuously appropriated moneys for any
14 biennial period.

15 “[(3) *On July 1 of each odd-numbered year, the department shall cause the*
16 *balance of the fund to be transferred to the General Fund for general govern-*
17 *mental purposes.*]

18 “**SECTION 44. ORS 526.123 is repealed.**

19

20 **“WILDFIRE PREPARED STRUCTURE PROGRAM**

21

22 “**SECTION 45. (1) In collaboration with the Department of Con-**
23 **sumer and Business Services, the Department of the State Fire Mar-**
24 **shal shall establish and implement a grant program called the Wildfire**
25 **Prepared Structure Program to facilitate the retrofitting of dwellings**
26 **existing on the effective date of this 2025 Act, as well as dwellings**
27 **constructed following wildfire damage, to be resistant and resilient to**
28 **wildfire.**

29 “(2) **To implement the program, the Department of the State Fire**
30 **Marshal shall:**

1 “(a) Publish a list of eligible retrofits and materials that reduce the
2 vulnerability of structures to wildfire and flying embers, as identified
3 in section R327 of the Oregon Residential Specialty Code or other rel-
4 evant industry best practices and standards.

5 “(b) Consider the relative cost-effectiveness of the retrofits and
6 materials.

7 “(c) Award individual grants to persons and block grants to coun-
8 ties for the counties to award as individual grants to persons.

9 “(d) Establish ranking and criteria for awarding individual grants
10 that include a preference for projects that:

11 “(A) Benefit persons who live in the wildland-urban interface, as
12 defined pursuant to ORS 477.015 and 477.027.

13 “(B) Benefit persons who implement defensible space requirements
14 described in ORS 476.392.

15 “(C) Benefit persons in socially vulnerable communities.

16 “(D) Benefit low-income persons who have demonstrated financial
17 need.

18 “(E) Benefit persons whose homes have been destroyed or signif-
19 icantly damaged by a wildfire for which authority has been exercised
20 under the Emergency Conflagration Act set out in ORS 476.510 to
21 476.610.

22 “(e) Establish formats by which persons who receive individual
23 grants and counties that receive block grants must report to the State
24 Fire Marshal.

25 “(3) A person who receives an individual grant shall:

26 “(a) Complete the grant project on a timeline approved when the
27 individual grant is awarded.

28 “(b) Report to the State Fire Marshal in a format designated pur-
29 suant to subsection (2)(e) of this section.

30 “(4) A county that receives a block grant shall report to the State

1 Fire Marshal in a format designated pursuant to subsection (2)(e) of
2 this section.

3 “(5) The department, and counties that receive block grants, shall
4 accept applications for individual grants:

5 “(a) At least once per year, for dwellings existing on the effective
6 date of this 2025 Act, on a date or dates determined by the department.

7 “(b) As needed, for dwellings constructed following wildfire damage.

8 “(6) The department may adopt rules as needed to implement this
9 section, in consultation with other agencies, local governments, non-
10 governmental organizations and the Wildfire Programs Advisory
11 Council.

12

13 “CAPTIONS

14

15 “SECTION 46. The unit captions used in this 2025 Act are provided
16 only for the convenience of the reader and do not become part of the
17 statutory law of this state or express any legislative intent in the
18 enactment of this 2025 Act.

19

20 “EFFECTIVE DATE

21

22 “SECTION 47. This 2025 Act takes effect on the 91st day after the
23 date on which the 2025 regular session of the Eighty-third Legislative
24 Assembly adjourns sine die.”
