### Timeline

March 2024	Deflection introduced using Behavioral Health Resource Network (BHRN) formula.
June 2024	Oversight and Accountability Committee (OAC) deliberated. Washington County asked OHA for delayed vote.
July 2024	OHA adopted formula on July 3. No public testimony allowed and no follow-up from OHA.
August 2024	Washington County alerted OHA to errors in the formula.
September 2024	OHA corrected errors. OAC did not revote on updated outcomes.

### SB 610 Modernize the process

### Advisory Board on Behavioral Health Resource Networks (BHRNs)

- New body to develop funding formula
- Subject to public process guidelines
- Diverse membership

### SB 610 Modernize the process

#### Clear process requirements

- Funding formula is a rule subject to the Administrative Procedures Act
- Consultation with impacted parties
- Hearings to understand challenges and opportunities; hear additional voices
- Make public comments accessible online

### SB 610 Modernize the process

Broadened OAC membership to include Community Mental Health Program Directors

Mandatory audit provision by Secretary of State's office

Help everyone access substance use disorder treatment in their community.

### OAC proposed 25-29 formula

Variable	Weight	
Medicaid population	30%	
Houselessness count	30%	
Arrests	20%	
Drug overdose deaths	10%	
Emergency room visits for drug overdoses	10%	
Established a funding floor of \$500K a year		



Funding fluctuations that make sustainable programming impossible

### OAC funding formula reality



Average annual county funding loss is **over 26**% up to **52**%



Some counties will be forced to discontinue services

### Solution: SB 610

Build a sustainable solution for funding formula adoption.

Propose a temporary funding solution for 2025-29:

- Ensure Oregonians can access substance use treatment in their community.
- 2. Minimize significant funding shifts that threaten sustainable and consistent service.
- 3. Uphold health equity as a goal.

#### Temporary funding solution: Public Health Modernization (PHM)

Established by Public Health Advisory Board in 2017



## PHM formula applied to other distributions

- February 2021: Epidemiology and Lab Capacity grant via Centers for Disease Control (CDC)
- February 2021: Coronavirus Aid, Relief, and Economic Security (CARES) Act – COVID Vaccination funding
- June 2021: Distribute \$8M in COVID Immunization funds
- July 2021: Distribute American Rescue Plan Act (ARPA) Public Health Workforce Funds
- December 2021: \$2M CDC Disease Investigation Specialists Workforce funds
- May 2022: Distribute \$10M in BM 108 Tobacco funding
- November 2022: \$140K in Fentanyl Campaign Funds to 26 counties
- July 2023: To estimate equitable distribution of communitybased organization funding across counties
- August 2023: To distribute extra \$775K ARPA funds
- September 2023: To distribute extra \$400K to Local Public Health Authority in tobacco funding
- January 2024: Immunization Program

### SB 610 funding proposal summary

Tribal set aside and OHA admin

Base funding \$500,000

Use PHM to allocate funding

Cap county gain or loss at 19.6%

Equitable distribution of any additional funds

## SB 610 funding formula impacts



Reduced funding fluctuations make sustainable programming possible



Average annual county funding loss is 12% instead of **over 26%**



## Risks of losing sustainable funding

- Delayed care
- Worsening health conditions
- Increased overdose
- Amplified stigma discouraging people from seeking help
- Increased burden on neighboring regions
- Increased costs and outcomes
- Increased health care costs for all
- Increased impact on historically marginalized communities

# Deflection cannot exist without the BHRN

Provides multiple types of services and supports

Provides rapid access to treatment

Decreases recidivism
