Dear Co-Chair McLain, Co-Chair Gorsek, Vice-Chair Boshart-Davis, Vice-Chair Starr, and members of the Joint Committee on Transportation,

I am writing to express my strong support for HB 3453, a bill that promises to transform transportation between the Portland metro area and Salem, with future expansions to Eugene. This enhanced connectivity will facilitate smoother commutes for workers, encourage collaboration between businesses, and promote a more integrated regional economy.

It's also important to recognize that approximately 30 percent of Oregonians, including seniors, young people, and individuals with disabilities, either cannot or choose not to drive. Enhanced passenger rail services will provide these residents with greater access to opportunities, services, and social connections, fostering a more inclusive and equitable transportation system.

In addition to economic and accessibility benefits, the environmental advantages of reducing single-occupancy vehicle travel cannot be overstated. The transportation

sector is a significant contributor to greenhouse gas emissions in Oregon. By shifting more travelers to rail, we can make substantial progress toward our environmental goals and promote sustainable development.

Thoughtful planning of station development and connections along the corridor is essential to maximize the benefits to the communities served. This bill presents a unique opportunity to commit to transit-oriented development, fostering healthy, livable communities that are well-connected and comfortable. Expanding WES service to Salem and Eugene will pave the way for vital investments in housing, retail, education, recreation, and job opportunities around new stations.
