Thank you, distinguished Co-Chairs (Senator Lieber, Representative Sanchez), Vice-Chairs and other Committee members. (Joint Ways & Means.)

I am Dr James A. Gaudino-- a Senior Preventive Medicine-Public Health Specialist Physician, Epidemiologist and Affiliate Professor with TWO university Schools of Public Health – the OHSU-PSU and UW Schools of Public Health.

I bring ~40 years experience

Many Oregon communities and families are SUFFERING and FEARFUL with the MANY ongoing and NEW threats to their health & wellbeing AND with slowly faltering governmental responses ...witnessing CUT backs in services in our UPSTREAM Public health system, shrinking in abilities to protect our communities

You know some of these THREATs --- I won't list them NOW

Preventable communicable and chronic diseases,

Loosing ground for having safe and healthy and thriving pregnancies, infants, adolescents and family members

AND emerging (and re-emerging) conditions

Breakout COVID-like viral illnesses

Larger-scale climate and environmental threats

Firearm and other violence

SKIP to:

We can prevent and mitigate MUCH with UPSTREAM approaches!

OUR Public health system- Local, tribal, state public health departments-- IS *separate* from healthcare WHERE clinicians LIKE ME provide interventions to individuals-one person at a time

Instead, Public health system IS a "force multiplier" with healthcare, WE track and study health threats and implement COMMUNITY-level interventions BACKED BY Science

We empower community members to BE more healthy and resilient even BEFORE they need healthcare

We SAVED many lives from horrible suffering, premature death, and disabilities when COVID-19 spread

YET WE CANNOT AGAIN afford the costly delays we had RAMPING UP for COVID to respond to these next threats!

We also can't afford MORE workforce losses

The duBeaumont Foundation summarized it this way:

Congress and state leaders would never cut budgets for force readiness of our military after a big fight (still going on),

BUT often cuts back public health's force readiness after responding to health threats! FORGETTING the ongoing PUBLIC health, safety and Readiness NEEDS of our communities

Today, for 2025-27, I respectfully ask for FULL FUNDING and support for 10 smaller budget and policy requests by Oregon's Coalition of Local Health Officers (CLHO)

CLHO is co-parallel in constitutional Public Health Authority with OHA (OHA Public Health Division)

These are common sense Public Health Modernization ACTIONS that will

- A. Deliver to effective services to our communities (7 listed here)
- --Disease prevention and curative treatments (\$25 million, HB 2025)
- --Primary Addiction Prevention (\$25 million, HB 2954)
- --Early Childhood WIC and Nurse Home Visiting (\$10.2 million)
- --Ban Flavored Tobacco products (SB 702)
- --Closing Tobacco Loopholes (HB 2528)
- --Vaccine Finance Reform with bridging investments (SB 42)
- --START Updating Point of Sales Tax on Beer, Wine, Cider) (HB 3197)

and

- B. Assure communities HAVE AN effective, locally-engaged and responsive public health workforce (3 listed here)
- --Break down silos to Assure CCOs, Medicaid and other community health boards leverage the expertise of Local Public Health (HB 2224 & HB 2317)
- --Opening up Career Pathways in Public Health (\$5 million)
- --Payment Pathways for Community Health Workers (HB 2216) and for Community Parametics (HB 2222)
