



Dear Oregon Lawmakers:

As a coalition of farms, farmers markets, small grocers, community partners, and advocates we are writing to **request your continued support of the Double Up Food Bucks program in the Oregon Department of Human Services' Self Sufficiency Budget (SB 5526)**.

Supporting Double Up Food Bucks (Double Up) means investing in families, farmers, and local economies all over our state. This vital program helps individuals using SNAP to access more fresh fruits and vegetables. For every dollar spent on SNAP-eligible foods at participating sites, shoppers receive an additional dollar to spend on Oregon-grown fruits and vegetables. There are 216 farmers markets, farm stands, CSA programs, and small, culturally specific grocers who offer Double Up in 34 of Oregon's 36 counties.

"Double Up remains a vital program for families, farmers, and local economies across Oregon." says Rachael Ward, the Executive Director of Farmers Market Fund (FMF). "FMF is thrilled to partner with ODHS to offer this program in conjunction with our CSA and grocery partners. In the coming biennium, **we will focus on expanding Double Up to every county in the state** and growing our outreach efforts to attract new shoppers, while sustaining benefits for returning customers."

For over a decade, Double Up has connected SNAP participants with Oregon grown produce, facilitating almost **\$19 million in SNAP and Double Up sales** since 2016. A recent economic impact assessment showed the power of Double Up to strengthen localized economies. Providing incentives helped families on tight budgets to free up funds for spending on other vital purchases like housing and health care. In 2024 over **\$6 million in Oregon labor income** was created due to the additional spending that Double Up made possible.

Double Up is a highly cost effective health care intervention, with participants **eating more fruits and vegetables than the average American** and reporting improvements to their physical, mental, and social health. A recent study found that Double Up dollars redeemed in 2024 alone created up to **\$8.8 million in avoided healthcare costs to the state** over a participant's lifetime.

Continued investment in Double Up from the State is essential to leveraging federal matching dollars and growing the impact of the program. As the farmers, ranchers, small businesses, and community members in your districts we urge you to fully fund the Double Up Food Bucks program within SB 5526.
