I am in full opposition to House Bill 3992, which proposes significant increases in expenditure limitations and appropriations for several state agencies, including a staggering \$204 million boost for the Oregon Department of Transportation (ODOT) alone. While the bill frames these changes as necessary adjustments for the biennium ending June 30, 2027, it ignores a troubling pattern of mismanagement of taxpayer funds and potential abuses of power under Governor Tina Kotek's administration. Approving this bill would only reward inefficiency and enable further waste at a time when Oregonians are already burdened by rising costs and declining services.

First and foremost, HB 3992 funnels massive sums to ODOT without addressing its chronic mismanagement issues. Even editorial boards have called out ODOT's mismanagement, noting multiple instances where the agency has squandered resources without accountability.

Similar concerns extend to other agencies in the bill. The Oregon Department of Administrative Services (DAS), which receives a \$500,000 General Fund appropriation for a highway cost allocation study review, has been flagged in state audits for potentially wasting millions through poorly managed contracts and avoidable costs.

Compounding these issues is Governor Kotek's own record, which raises alarms about abuse of power and misuse of public resources. Under her leadership, taxpayer funds have been allocated to provide regular state police security and new staff for First Lady Aimee Kotek Wilson, despite her holding no official elected position—a move criticized as an abuse of power that diverts resources from critical needs.
