Work Session

SB 430

Specifies disclosures that a retail seller must make to a retail buyer for a transaction in goods or services that concludes online by means of a website or other electronic method.

SB 569 **

**Subsequent Referral(s) to Ways and Means

Directs the Oregon Business Development Department to establish a program to provide grants to nonprofit and community-based organizations that assist businesses owned by minority individuals to become certified by the Certification Office for Business Inclusion and Diversity as minority-owned businesses so that the certified businesses can compete effectively for public contracts.

SB 605 **

**Subsequent Referral(s) to Health Care

Prohibits medical service providers from reporting the amount or existence of medical debt to a consumer reporting agency.

SB 904

CARRIED OVER FROM THE 03-18-2025 AGENDA: Includes school districts among the self-insured employers that may apply for exemption from the rules requiring such employers to demonstrate financial viability and provide security to the Director of the Department of Consumer and Business Services.

SB 906

CARRIED OVER FROM THE 03-18-2025 AGENDA: Requires that itemized statements provided to employees show, in plain language, the amount and purpose of each deduction.

SB 907

Requires an applicant for a license to manufacture psilocybin to submit to the Oregon Health Authority information regarding the ownership and location of the premises to be licensed.

SB 968

CARRIED OVER FROM THE 03-18-2025 AGENDA: Provides requirements for employer deductions for erroneous overpayments of wages for employees who are not subject to a collective bargaining agreement.

Requires the Director of the Oregon State University Extension Service to establish a lumber grading training program.

SB 946 **

**Subsequent Referral(s) to Ways and Means

Authorizes the payment out of the Workers' Benefit Fund of the expenses of the Commissioner of the Bureau of Labor and Industries in carrying out the commissioner's statutory duties.

SB 1044

CARRIED OVER FROM THE 03-18-2025 AGENDA: Clarifies for purposes of state wage and hour laws that "work time" does not include meal periods.

SB 1110 **

**Subsequent Referral(s) to Ways and Means

Authorizes the issuance of lottery bonds with the proceeds distributed to Williams & Russell CDC for the purpose of developing a business hub to support small businesses, professional development, workforce training and economic growth in Portland's Albina neighborhood.

SB 1166

Requires transportation network companies to pay minimum compensation rates to drivers.
